RESOLVED: That We, your Memorialists, on behalf of the people we represent, take this opportunity to respectfully request that the United States Congress take immediate steps to reach a compromise and end the partial shutdown of the Federal Government and restore financial security to the lives of citizens; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the President of the United States Senate, the Speaker of the

United States House of Representatives and each Member of the Maine Congressional Delegation.

Representative **NADEAU**: Okay, so that just made my speech a little shorter, so I thank you for that. Men and Women of the House of Representatives, thank you for the opportunity to speak to this Joint Resolution. I am proud to sponsor this resolution and am humbled by the support of the members of this body and on the other side of the hall and unanimous support from Senate leadership and House leadership.

My son James, and myself cannot thank you enough. It has meant so much that this family, as dysfunctional as we can be down here, this resolution was formed by a text I received from my son, who is here today in the gallery and who I love and am still very proud of. His words, can we not send a letter down to Washington encouraging them to end this partial federal shutdown so I can get back to work at the USGS, also known as the United States Geological Survey. I love my job and I went to school for this. He also served in the US Coast Guard, so he is a veteran. With each day that the shutdown continues, the burden on these workers and their family grows. Today marks 34 days that the shutdown has been in effect and they are heading for their third missed paycheck. What does that mean to them? Well, James took out a personal loan to cover his mortgage payment and expenses including an unexpected furnace problem. As difficult as it is for my son and his family, I know that he is one of many who are in this terrible situation, so when I say he, I really mean them.

As frustrating as it is, he is a kind young man who has not said a bad or unkind word about anyone in Washington. Again, how proud am I.

We urge members of Congress to act immediately to end this federal shutdown. Federal workers deserve better. Coasties deserve better. The people of Maine deserve better. It all started with a text from one veteran and we listened. He is proud of us. I know I am. I thank you for making this happen.

Representative **LOCKMAN**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, I cannot vote for the pending resolution because it's incomplete. WHEREAS, under the United States Constitution, Article V, the Congress of the United States, whenever two-thirds of both Houses shall deem it necessary, shall propose amendments to the United States Constitution, or, on the application of the legislatures of two-thirds of the several states, shall call a convention for proposing amendments that, in either case, shall be valid to all intents and purposes, as part of the United States Constitution, when ratified by the legislatures of three-fourths of the several states, or by conventions in three-fourths thereof, as the one or the other mode of ratification may be proposed by the Congress; and

WHEREAS, with each passing year, this nation becomes more deeply in debt as its expenditures grossly and repeatedly exceed available revenues, so that the public debt now exceeds hundreds of billions of dollars; and

WHEREAS, the annual federal budget is a continual demonstration of an unwillingness or inability of both the legislative and executive branches of the Federal Government to curtail spending to conform to available revenues; and

WHEREAS, unified budgets do not reflect actual spending because of the exclusion of special outlays that are neither included in the budget nor subject to the legal public debt limit; and

WHEREAS, knowledgeable planning, fiscal prudence and plain good sense require that the budget reflect all federal spending and be in balance; and

WHEREAS, believing that fiscal irresponsibility at the federal level, with the inflation that results from this policy, is the greatest threat that faces our nation, we firmly believe that constitutional restraint is necessary to bring about the fiscal discipline needed to restore financial responsibility; and

WHEREAS, we believe action on amendments to the United States Constitution concerning federal expenditures to be vital; now, therefore, be it

RESOLVED: That the Legislature of Maine respectfully applies to the Congress of the United States, under the provisions of Article V of the United States Constitution, for the calling of a convention of the states limited to proposing an amendment to the United States Constitution requiring that, in the absence of a national emergency, the total of all federal outlays made by the Congress of the United States for any fiscal year may not exceed the total of all estimated federal revenues for that fiscal year, together with any related and appropriate fiscal restraints; and be it further

RESOLVED: That this application is to be considered as covering the same subject matter as the presently outstanding balanced budget applications from other states, including but not limited to previously adopted applications from Alabama, Alaska, Arkansas, Colorado, Delaware, Florida, Georgia, Indiana, Iowa, Kansas, Louisiana, Maryland, Michigan, Mississippi, Missouri, Nebraska, Ohio, Nevada, New Hampshire, New Mexico, North Carolina, North Dakota, Oklahoma, Pennsylvania, South Dakota, Tennessee, Texas, Utah and West Virginia; and this application must be aggregated with same for the purpose of attaining the two-thirds of states necessary to require the calling of a convention for proposing amendments, but may not be aggregated with any applications on any other subject; and be it further

RESOLVED: That this application constitutes a continuing application in accordance with Article V of the United States Constitution until the legislatures of at least two-thirds of the several states have made applications on the same subject. It supersedes all previous applications by this Legislature on the same subject; and be it further

The SPEAKER: The Chair recognizes the Representative from Presque Isle, Representative Stewart.

Representative STEWART: Thank you very much, Madam Speaker, Ladies and Gentlemen of the House. As the Ranking Republican on the Committee of House Rules, I just wanted to speak very briefly to this motion and explain why our caucus's position is going to be not in support of the pending question.

The first is that we, quite simply, don't see a purpose for this rule and what it hopes to achieve we believe it can already be done in this chamber. The first fact is that the Senate doesn't have such a rule and they can enforce the rules of decorum without such rule and our caucus believes that we can do the same sort of enforcement in the House. Additionally, we feel that in the 21st Century we should be looking at moving forward and going towards where the people are in terms of getting the message of what's happening in this chamber, in the people's House, out to the people of Maine. And we believe that one of the better ways to do that is through better leveraging of technology. I know that there are cameras in the chamber, I'm looking at one right now, but our members, quite frankly, have had issues accessing that footage and

making it work for them in order to be able to actually present to their constituency exactly what is happening in this chamber. We feel that it is a limit on the transparency of what happens in this chamber for that reason and furthermore don't feel that it's a move that; it's almost a solution in search of a problem, so to speak, and so we feel very strongly that we shouldn't be moving forward with this rule, that we shouldn't be limiting access of our constituents to reach out to our members and I would respectfully request that our; that this chamber vote down this motion and that it would accept the Minority Report instead. Thank you very much, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Moonen.

Representative MOONEN: Thank you, Madam Speaker. Madam Speaker, Women and Men of the House, I rise in support of the pending motion. This rule change simply restricts members of this body from photographing or taking videos of each other during the deliberations in this chamber. Advancements in technology have given the people of Maine more access to the legislative process than ever before. Technology certainly has an important role to play in our work in this body. But its use in the chamber should not distract us from or interfere with that work. In recognition of this, other legislative bodies across the country and the U.S. Congress have adopted restrictions similar to the proposal before us today in their own rules.

One of the main purposes served by the House rules is to maintain decorum. Practically, that means paying the institution of the House the respect it deserves and requiring members to behave in a way that allows us to focus on the serious issues we are charged with considering. Allowing members to video or photograph each other during House deliberations does not fit the traditions of this body or reflect the gravity of our work. It is not what our constituents sent us here to do. In fact, it detracts from the work that they sent us here to do and allowing it does not serve a purpose that isn't otherwise met.

Transparency is of the utmost importance to me, Madam Speaker. The people of Maine should have access to everything we do in this chamber. Whenever we meet in this chamber, day or night, our deliberations are streamed live online and made available for viewing after we've adjourned. That's exactly as it should be and it will continue to be the case. The public and the media are virtually always present while the House is in session. This rule change does nothing to restrict or impede their rights. I know many members of the body use social media and email to communicate with their constituents. Under this change, members will still have access to their devices so that they continue that communication in real time, sharing the live video of our proceedings or other information.

Madam Speaker, I believe this change to the House rules is straightforward and appropriate. It's about respect for each other, respect for the process we have the privilege to take part in and respect for the people we serve. I hope you will join me in supporting it. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Penobscot, Representative Hutchins.

Representative HUTCHINS: Madam Speaker, thank you. I rise again this morning in a motion for openness and I think this is a good example of it. I don't think we should be running around taking pictures of people, but I don't see any reason why we shouldn't be taking pictures from our seats and I think that probably would be proper decorum, anyway. But I would

ask for a roll call vote on this when we take the vote today. Thank you.

**JOINT RESOLUTION MAKING APPLICATION TO THE CONGRESS OF THE UNITED STATES TO CALL A CONVENTION UNDER ARTICLE V OF THE UNITED STATES CONSTITUTION TO PROPOSE AN AMENDMENT TO THE UNITED STATES CONSTITUTION TO RESTORE FREE AND FAIR ELECTIONS**

WHEREAS, the framers of the United States Constitution intended that the Congress of the United States should be "dependent on the people alone"; and

WHEREAS, that dependency has evolved from a dependency on the people alone to a dependency on powerful special interests, through campaigns or 3rd-party groups, that has created a fundamental imbalance in our representative democracy; and

WHEREAS, Americans across the political spectrum agree that elections in the United States of America should be free from the disproportionate influence of special interests and fair enough that any citizen can be elected to office; and

WHEREAS, the Constitution of Maine, Article I, Section 2 states that "All power is inherent in the people; all free governments are founded in their authority and instituted for their benefit" and that the people have an unalienable and indefeasible right to reform the government; and

WHEREAS, under the United States Constitution, Article V, the Congress of the United States, whenever 2/3 of both Houses consider it necessary, shall propose amendments to the United States Constitution, or, on the application of the legislatures of 2/3 of the several states, call a convention for proposing amendments that, in either case, will be valid to all intents and purposes as part of the United States Constitution when ratified by the legislatures of 3/4 of the several states, or by conventions in 3/4 thereof, as the one or the other mode of ratification may be proposed by the Congress; now, therefore, be it

RESOLVED: That the Legislature of Maine respectfully applies to the Congress of the United States to call a convention for the specific and exclusive purpose of proposing an amendment to the United States Constitution that will permanently protect free and fair elections by addressing concerns about the removal of restrictions on amounts of independent political spending through Citizens United v. Federal Election Commission, 558 U.S. 310 (2010) and related cases and events including those occurring long before or afterward or for a substantially similar purpose, and desires that the requested convention be limited to that purpose; and be it further

RESOLVED: That this State desires that the delegations to the requested convention be composed equally of individuals currently elected to state and local office or be selected by election in each congressional district for the purpose of serving as delegates and all individuals elected or appointed to federal office, now or in the past, be prohibited from serving as delegates to the requested convention and that the State intends to retain the ability to restrict or expand the power of its delegates within the limits expressed in this paragraph; and be it further

RESOLVED: That this application by this body constitutes a continuing application in accordance with the United States Constitution, Article V together with similar applications calling for a convention passed in Vermont, California, Illinois, New Jersey and Rhode Island and all other passed, pending and future applications until at least 2/3 of the legislatures of the several states have made similar application pursuant to Article

V and the convention is convened by the Congress of the United States; and be it further

RESOLVED: That this application is void, rescinded and of no effect in the event that such a convention is not limited to such a specific and exclusive purpose; and be it further

RESOLVED: That the people of the State speaking through its Legislature, and pursuant to Article V of the United States Constitution, hereby apply to the Congress of the United States to call a convention for the exclusive purpose of proposing an amendment to the United States Constitution that will restore free and fair elections as described herein, as soon as 2/3 of the several states have applied for a convention for a similar purpose; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Secretary of the Senate and the presiding officers of the houses of the legislature of each of the several states in the nation, the President of the United States, the Speaker and the Clerk of the United States House of Representatives, the President and the Secretary of the United States Senate and each member of the Maine Congressional Delegation.
