Resolve, To Continue until August 3, 2019 Limited-period Positions Expiring in June 2019 (EMERGENCY)

(H.P. 1310) (L.D. 1840)

Sponsored by Representative MILLETT of Waterford. (GOVERNOR'S BILL)

Committee on **APPROPRIATIONS AND FINANCIAL AFFAIRS** suggested.

The **SPEAKER**: The Chair recognizes the Representative from Waterford, Representative Millett.

Representative **MILLETT**: Thank you, Madam Speaker and Ladies and Gentlemen of the House. I thought a brief message or explanation of this supplement and the bill that it relates to would be in order.

I learned earlier in the week that the end dates for employment of people who are known as limited period positions in state government will ripen for some of them tomorrow night. In other words, these are positions for which there is no head count, no budgeted authority, but departmentally-determined funding sources expiring within the period for which they have funding. Given that there will be some of the group that will be faced with immediate layoff at the close of the day tomorrow and some of them, not a lot, but some of them are included in the budget to be continued with permanent funding starting July 1. The problem, therefore, arises when people might have to be summarily laid off at the end of the day tomorrow only to be rehired three weeks down the road.

This language, as an emergency, authorizes the departments without additional funding to extend that period so that there be no unnecessary layoff involved. There's also an unintended consequence for those who will be not continued, and that is that we have already passed the 30-day notice of termination and this bill will address that issue, as well.

I apologize for the lateness, I just wanted you to know that it is a bill that does not have a budgetary impact in the next biennium and is necessary to treat those few employees appropriately given the timeframes that we're dealing with. I'm sure Representative Gattine will speak also to this at some point during the morning. If it passes here and is enacted in the Senate and the Chief Executive signs it before the day is out, we will need to exempt it from the Appropriations Table forthwith, so later in the morning or maybe by midday we may have to do that. Thank you, Madam Speaker.

So, I am so pleased to have them here and to congratulate them on their great effort and, I might add, we have a legendary basketball coach here in the chamber who's brought home a gold ball or two for Bangor High. So, congratulations and thanks for being here today.

Representative **REED**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I rise this morning to extend my congratulations to both of these Bangor High School championship teams.

I do so for two reasons. First, winning a State Championship is very hard to do. Regardless of what they seem to think in Kittery, in the great State of Maine our natural rights are protected by our State Constitution. So much so that the first section of the Maine State Constitution is, in fact --

The **SPEAKER**: The Member will defer. The Chair recognizes the Representative from Kittery and inquires as to his Point of Order.

Representative **RYKERSON**: Point of Order. We should not be defaming other Members of this body.

The **SPEAKER**: The Chair will remind the Member who is speaking, I believe he was not speaking about a Member but about a town; however, the Chair will remind Members to please be careful of their language and make sure it was not misconstrued in any way or is not presented in a way that can be misconstrued.

The Chair recognizes the Member from Paris, and he may proceed.

Representative **ANDREWS**: Thank you, Madam Speaker. In the great State of Maine, our natural rights are protected by our State Constitution, so much so that the first section of the Maine State Constitution is, in fact, a declaration of rights, with our natural rights being the first to be mentioned. They are listed in Article 1, Section 1 of the Maine State Constitution.

All people are born equally free and independent, and have certain natural, inherent and unalienable rights, among which are those of enjoying and defending life and liberty, acquiring, possessing and protecting of property, and of pursuing and obtaining safety and happiness.

This bill seeks to correct state statute to get it in line with the protections of our natural rights, mainly to defend life and obtain safety, that are listed in Article 1, Section 1. This bill is necessary to protect everyday Mainers from harm if they face dangerous situations outside of their domicile in a place they legally have the right to be. Currently, Mainers who face danger outside their homes are required to retreat from the encounter, surrender their property to someone asserting a claim to it, and comply with a demand from an aggressor they are not obliged to perform. That is not a safe or rational standard, and it is in clear violation of our State Constitution. It must be corrected. Mainers have constitutional protections to

guarantee the right to meet force with force to defend their lives or the lives of others so that they can obtain safety.

I submitted this bill for everyone in Maine because everyone has the right to defend themselves in a place that they have a legal right to be if they face danger. Whether it is a single mom walking through a desolate parking lot late at night who meets an attacker or a young Marine home on leave who engages and takes down a mass shooter in a public park, this law, LD 533, is for every law-abiding citizen in our great state to protect themselves and others without having to worry about the current statute that violates their constitutional rights. This is especially true in rural Maine where the police or county sheriffs may be a long distance from being able to help people. Mainers have always been a self-sufficient people and they need to have their constitutional right to self-defense affirmed and protected by passing this bill.

I would ask you to please vote down the Majority Report, and move the Ought to Pass Minority Report, to bring current statute in line with our State Constitution and make Maine a safer place for everyone. Thank you, Madam Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: Thank you, Madam Speaker. I rise in opposition to the pending motion.

My brother, Herman Faulkingham, is a Marine veteran and very active in the firearms training community and he has imparted on me his knowledge of violent confrontation. I would say that he is an expert on the subject. I'd like to briefly speak in favor of LD 533.

Many people have an unrealistic understanding of how fights and lethal force engagements happen. They don't understand how the brain functions when dealing with a fight or flight response or how fast decisions made when confronted by someone intending to cause you harm. These misunderstandings can not only lead a good person involved in a justified use of lethal force to be charged or prosecuted but in an even worse case having confusion in the laws about use of force, such as when you are obligated to retreat, or defining exactly what is the duty to deescalate can lead that same good person to hesitate or make a wrong choice when their life is on the line.

Stand-your-ground laws can end these problems by simplifying it into if you fear for your life you have the right to defend yourself. A person being held at knifepoint or being chased by someone with a baseball bat shouldn't have to worry about if they will be criminally charged for defending themselves with overwhelming force. Most apprehension to stand-your-ground laws come from a misunderstanding that stand your ground is license to pick fights or allows a person to shoot someone. That is not what this law is. It is simply just brings the laws surrounding justifiable self-defense back to common-law principles; if you have a reasonable fear for your life, you have a fundamental right to self-preservation. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Hallowell, Representative Warren.

Representative **WARREN**: Thank you, Madam Speaker. I just want to clear up a little, it seems, confusion. I'm not sure what other states do in this realm but Maine's law currently recognizes very clearly a person's right to self-defense, and it does not include a duty to retreat in one's own home and when one is not the initial aggressor. So, this proposal is truly not needed because we already have it in Maine.

The SPEAKER: The Chair recognizes the Representative from Dixfield, Representative Pickett.

Representative PICKETT: Thank you, Madam Speaker, Ladies and Gentlemen of the House. Not too long ago, legislation was passed in our State for a bill that was deemed to cause hysteria and cause all kinds of problems. It was called the constitutional carry. That bill was passed and we still remain today the safest state in the union.

This particular bill here, the stand-your-ground bill, I believe is a good bill. I believe it's a public safety bill. It aligns with our constitutional rights and, most importantly, we heard references to a state last evening regarding another bill and that same state today, New Hampshire, has a stand-your-ground bill. Thank you very much, Madam Speaker.
