**JOINT RESOLUTION RECOGNIZING FEBRUARY 6, 2019
AS NATIONAL GIRLS AND WOMEN IN SPORTS DAY**

WHEREAS, the National Girls and Women in Sports Day Coalition celebrates National Girls and Women in Sports Day in Washington, D.C. and encourages its celebration in communities across the nation; and

WHEREAS, this day exists to recognize the past and current sports achievements of girls and women, the positive influence of sports participation and the continuing struggle for equality and access for girls and women in sports; and

WHEREAS, National Girls and Women in Sports Day began in 1987 as a day to remember Olympic volleyball player Flo Hyman for her athletic achievements and her commitment to ensure equality for women's sports; and

WHEREAS, despite the history of impressive successes of girls and women in sports, there has been little national recognition of the significance of girls' and women's athletic achievements; and

WHEREAS, at all levels of athletics, girls and women develop self-discipline, initiative, confidence and leadership skills regardless of background; and

WHEREAS, the bonds girls and women build through athletics help to break down the social barriers of racism and prejudice, and the communication and cooperation skills learned through sports play a key role in the athletes' contributions at home, at work and to society; and

WHEREAS, a need for increased opportunities exists for girls to participate in and pursue physical activity in the community and at the scholastic level so that they may, beginning at an early age, improve their health and well-being on a daily basis and develop lifelong fitness habits; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-ninth Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize February 6, 2019 as National Girls and Women in Sports Day.

The SPEAKER: The Chair recognizes the Representative from South Portland, Representative Reckitt.

Representative **RECKITT**: Thank you, Madam Speaker. I rise to speak on behalf of this resolution today on three counts. One is most of you know that I'm in my 70s, in my 75th year, in fact. So, you probably don't picture me as a basketball/tennis/softball/field hockey, etcetera, etcetera athlete. But I was, indeed, such. And I was an athlete both

before and after I worked on the implementation and the adoption of Title 9 of the Higher Education Act which brought equality to women in sports. It was my major focus in life at that point and I'm very glad today to see this resolution.

It's very -- just one other quick thing. I had a dear friend who I share with Representative Marean who is not with us anymore but she died at the age of 97, 12 years ago. She was the first and I think only woman, to play polo in the Massachusetts Polo League. It was a very historic thing. They finally threw her out of the league because she played better than all the guys. And so I think that in her honor, I stand today to remember Marge Rowe and thank her for her activity as a basketball coach when women couldn't pass, we couldn't dribble, could only dribble once, could dribble three times, and could finally in the fourth incarnation could actually play like everybody else. She was a fascinating woman and I rise in her honor today in regards to this resolution. Thank you so much, Madam Speaker.

**JOINT RESOLUTION RECOGNIZING MARCH 2019 AS
CHILDHOOD CANCER AWARENESS MONTH**

WHEREAS, in the United States, 15,780 children under 21 years of age are diagnosed with cancer every year and approximately 1/4 of them will not survive the disease; and

WHEREAS, the causes of pediatric cancer are still largely unknown and, though new discoveries are resulting in new treatments, this disease continues to harm families and communities with wounds that may never fully heal; and

WHEREAS, due to ongoing advances in research and treatment, the 5-year survival rate for all childhood cancers has climbed from less than 50% to 80% over the past several decades; and

WHEREAS, researchers around the world continue to pioneer new therapies and explore the root causes of the disease, driving progress that could provide cures or improved outcomes for patients; and

WHEREAS, Childhood Cancer Awareness Month will put a spotlight on the survivorship issues that children and families face, the types of cancer that largely affect children, recent gains against the disease and challenges that still lie ahead and will help raise funds for research and family support; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-ninth Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to proclaim March 2019 as Childhood Cancer Awareness Month and urge citizens of the State to become informed about childhood cancer, including both the issues that are involved and the progress that is being made.
