The **SPEAKER**: The Chair recognizes the Representative from Waterford, Representative Millett.

Representative **MILLETT**: Thank you, Mr. Speaker. The purpose of the Recede motion, as many of you know, and for the newcomers, we are in that position where we need to back up from where the bill is in the other Body, namely the way we sent it yesterday morning with two amendments added to it, in order for further amendments to be considered here today. I will be speaking to one of those amendments but not offering them.

I thought I would like to take just a few minutes, I'll try to be brief and not overwhelm you with numbers, but I heard a lot of good messages yesterday. The prayer was extremely historically valuable. The Good Representative from Wells, Representative Skolfield, touched all of the bases that remind us all of how things changed when the 129th adjourned back on St. Patrick's Day of 2020.

Our two fore leaders, both Representatives Dillingham and Dunphy, used the word "we" several times during the course of the conversation yesterday. And I listened carefully and I thought it would be good to remind us that we are all in this together if we are to achieve a successful outcome today. As a reminder, since we adjourned on the 17th of March, 2020, more than 8 billion dollars of federal money, pandemic-related, has come through our borders in various ways. Not one nickel of that has been authorized and approved by legislative bodies either in the 129th or yet for this Body and the other in the 130th. Most of those dollars were intended to acknowledge that, unknown to us when we left here or the other building on St. Patrick's Day, the full extent that the pandemic would have and the upsets to every aspect of the communities that we represent. From individuals, from workers, from families, to children, to students, to communities and to our institutions, everything has been turned upside down.

A supplemental budget normally is to rebalance a year, and that was its original purpose. Yet, we have, I think, come together on a lot of what is in the bill before us today by recognizing that we need to go beyond simply rebalancing the FY-21 general fund budget, which I would remind you is at the moment only 150 million out of balance. There was a time back in the mid-summer when we thought it was going to be much larger. The August forecast projected over a 570 million shortfall in 21, rising to 1.4 billion over the three-year period. So, when we were sworn in on the second of December last year, we knew the new forecast, we had hint that we were 150 million out of balance.

A couple of things changed. In late-December, the Consolidated Appropriations Act was signed by the outgoing President and it did change some of the federal benefits that had been extended throughout the year and was not reflected in the 150 million figure we knew of in mid-December. So, the Chief Executive presented the budget on January 8th, acknowledging that we were 150 million out of sync for the balance of this fiscal year. She proposed three areas of attention that have survived intact exactly from that beginning; 100.5 million in curtailment initiatives gathered from her cabinet members and departments, 97 million of federal CARES money moves to offset salaries for those state employees engaged in health and safety activity, and 65 million from the Federal Medical Assistance Percentage increase, or FMAP, that supports our Medicaid programs, totaling 65 million.

A little simple math would say that budget produced 287 million of one-time savings, well beyond the 150 that we were out of balance and still are today. The Chief Executive proposed two things that utilized some of that additional balance. One was to add monies to two stabilization accounts, totaling 66 million, and 24 million of spending. Subtracting that 90 million offset that left us with 197 million, which is 47 million more than the need and that was to go forward to the next biennial budget.

So, with that backdrop, here we are today with the new information from that Consolidated Appropriations Act which concluded that our December forecast did not anticipate the conformity issues that arose later from the Paycheck Protection Program, which added to the revenue loss issue by 100 million-plus. Since then, we have as an Appropriations Committee, acknowledged that the Paycheck Protection Program was a sincerely intended program that helped many of our workers who continue to work only because their employers were given money to pay for their paychecks. The changes we have made in early-March as a committee include two new spending issues, 47 million, as a one-time attempt to allow those persons who were unemployed as a result of layoff pandemic related by exempting the first \$10,200 of earned unemployment benefits in 2020, from Maine income taxes. Another 9.7 million was added to address the direct support workers that we have all heard from and care for.

So, here we are today with a difference between the majority and the minority report. I cannot speak to the minority report, but it seeks to address additional conformity that has been available for the last two calendar tax years but would not be continued for the 2020 year. That will be spoken to as an amendment. What I'd like to say as a concluding message is, back to the we; we have an obligation to balance the FY-21 budget. No one will dispute that. We have an obligation to address emergencies when they occur. No one would dispute that this is a true emergency. No one would disagree that we have an obligation to everyone in our communities whose lives were turned upside down during the calendar year and the

more we can do utilizing the one-time sources that are available to us today, the better we will be able to go back home and say we tried to help. I would hope today that we cannot demonize either party's priorities or how we got to where we are today, nor try to make it appear that some of us care more about businesses, some of us care about employees, some of us care about institutions, when, in fact, I believe truly we all care for all elements of our society and our economy. So, I'm hoping that we will bear those thoughts in mind and realize that when we finish today, we have an obligation to address the unbalanced budget and the issues and challenges that lie before us today. I hope we can do so in a civil and bipartisan way and that we will result in a solution that we can all be proud of. Thank you.

The SPEAKER: The Chair recognizes the Representative from Oxford, Representative Dillingham.

Representative **DILLINGHAM**: Thank you, Mr. Speaker. I wanted to briefly explain what we hope to do with this amendment. This amendment speaks to foreign derived intangible income, which is commonly referred to as FDII. And that is a deduction that is given to U.S.-based and even Maine-based businesses that produce and manufacture items, but sell globally. And so, it provides them a deduction on the income on the items that are being sold globally to better help them compete on the global field and against maybe better tax jurisdictions that maybe could be provided elsewhere.

The other piece of this, and speaking with folks from Maine Revenue Services, there is a feeling that this isn't acting as it was intended. And we have asked; there's language in the amendment that asks for them to do a report and a study back to the committee of jurisdiction to provide the data and survey those businesses that are actually currently taking this deduction that are based in Maine to see if there is a benefit for them. That report back would be due at the end of December so that this asks for the deduction that is currently in place to remain in place for tax year '20 and the committee would then have the ability to put forth a piece of legislation if it is proven that this isn't performing as intended and they could then rescind that deduction for tax years '21 going forward.

So, I do hope everyone will consider this and consider supporting this amendment. Thank you.

The Chair recognizes the Representative from Waterford, Representative Millett.

Representative **MILLETT**: Thank you, Mr. Speaker. Speaker, Ladies and Gentlemen of the House, in my earlier two lengthy remarks, I referenced this particular amendment as one possible grounds for common ground; a compromise, if you will.

The Representative from Oxford has properly explained this is one of those few conformity issues where the particular provision was put in place in the Tax Cuts and Jobs Act of 2017, in an effort to encourage businesses having a presence in Maine and the U.S. to not look to tax havens overseas when they actually did business overseas, either through exports or other income generation. It has been conformed to routinely in tax years '18 and '19 by action of the previous Legislatures. It was offered again as a conformity item but rejected by the administration and is not currently included as a conformity item in the Majority Report.

As the Representative from Oxford indicated, she and I and members of the administration both at the Chief Executive's office and Maine Revenue Services talked about the why not. Because this will cause those businesses based in Maine and/or doing business in Maine to pay 8.6 million dollars in state income taxes than they have previously been paying.

The idea of getting more hard data to determine whether or not this is an appropriate tool in our economic development toolbox to incentivize companies to come to Maine, to stay in Maine, to continue to look at the export options as a productive way of selling their goods and services, and given that the current feeling is that it's not well-understood, why not determine how well it's understood by those who aren't speaking? The idea of the study and the conformity for one year, with a full understanding that if it isn't working, we discard it, was presented. I want to just suggest that this is the one amendment where I see an opening for some conversation rather than a straight unspoken motion to indefinitely postpone and walk away from this opportunity. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Falmouth, Representative Pierce.

Representative **PIERCE**: Thank you, Mr. Speaker. The Good Representative is correct, we have been discussing this and a study. We are in complete agreement that we agree that a study needs to be developed around this issue. Where we disagree is that the vast majority of people who receive this benefit that Maine taxpayers pay are actually not Maine businesses that reside in Maine; they're multinational companies that exist beyond our borders.

We definitely think that this should be researched and are happy to do it, but we also think that we should not continue to pay an average of \$33,000 to each of these businesses that do not reside in Maine while we look at that study, and there's our difference. I'm always hopeful that we might be able to come to some agreement, but I wanted to be clear about the majority report and the discussion around this issue.

Representative **DILLINGHAM**: Thank you, and I appreciate the comments from the Representative from Falmouth. But, I would like to clarify in our conversations that we were told that those businesses actually are protected privately, so, we weren't informed of what the businesses were, we weren't given any information about how many businesses here specifically versus how many businesses outside the State of Maine. I did ask about an industry that we have, our lobstering industry, that is produced here in Maine but they do sell globally and if what the impact would be on those folks that participate in the lobstering industry and I wasn't given an answer, I wasn't able to provide an answer because those businesses that are here in Maine hadn't been surveyed to see what would be that impact.

So, while I understand the comments and the concern, I think that that's what led us to to promoting the compromise to allow a deduction that doesn't actually create a fiscal note and can be absorbed within the majority budget, for us to be able to move forward, go through that study, and the folks at Maine Revenue Services would have the opportunity to really get all of that data, still protect the privacy of the businesses that are taking this deduction, but bring that forth to the committee of jurisdiction as well as the Appropriations Committee.

The **SPEAKER**: The Chair recognizes the Representative from York, Representative Hymanson

Representative **HYMANSON**: Thank you, Mr. Speaker and Colleagues. My husband and I moved to York 35 years ago to start our medical practices; me in Neurology, my husband in Cardiology. We moved to York as a Jewish family raising three children who each earned their bar and bat mitzvah. We were welcomed, appreciated, and we felt at home, until 20 years ago York hired a Jewish executive director of our library. Feces were smeared on the door of the library soon after. We in the town of York put together a diverse group of town people and created the York Diversity Forum, with its mission everyone who lives here feels at home. That group still does good work in the community and it has helped my family feel at home in York, Maine, for 35 years.

This resolution includes a working definition of antisemitism which I will read. Antisemitism is a certain perception of Jews which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, to our Jewish community, institutions and religious facilities.

This Joint Resolution serves as a reminder for us about antisemitism and that's what I wanted to say to you today.

The **SPEAKER**: The Chair recognizes the Representative from Portland, Representative Zager.

Representative **ZAGER**: Thank you, Mr. Speaker. There is much work to be done today, so, I will be brief and will not repeat what the sentiments of the Good Representative from York has just shared.

Ladies and Gentlemen of the House, I rise as a Jewish Representative and a veteran who joined the U.S. Military

many years before taking the Hippocratic Oath. I did so because I love our country and also to serve under the same flag that America's submarine force, the Screaming Eagles of the 101st Airborne Division, the Tuskegee Airmen and so many others carried when they sacrificed to defeat the Nazis.

I also wish to echo the countless survivors whose stories I bear witness to, the things that I saw at Auschwitz-Birkenau, Majdanek, Treblinka, and Warsaw in the 1990 March of the Living, and also the millions of civilians who were executed in the Holocaust, including many of my relatives.

I want to share two things. One is that antisemitism sometimes comes disguised. In the 1930s in Germany it was cloaked in the Reichstag's ostensibly democratic process and so it's important that legislators recommit ourselves to never forget.

The other point I'd like to make is that, of course, military, paramilitary, and police forces were complicit in perpetrating the Holocaust and Christopher Browning's book, *Ordinary Men*, describes well how this happened in one battalion of Einsatzgruppen.

I had many non-Jewish commanding officers emphasize the importance that those wielding power must remember. At one such commemoration aboard our ship in 2001, an elderly U.S. Army veteran spoke to our crew about the horrors he beheld while liberating a Nazi death camp. With these thoughts in mind, I ask the Honorable Members of this Body to support this resolution, and I thank you, Mr. Speaker.

**JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES AND THE UNITED STATES CONGRESS TO ESTABLISH A NATIONAL INFRASTRUCTURE BANK**

WE, your Memorialists, the Members of the One Hundred and Thirtieth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the President of the United States and the members of the Congress of the United States as follows:

WHEREAS, the American Society of Civil Engineers states in its 2017 Report Card that the United States received a grade of D+ regarding the current state of infrastructure and that more than \$4.5 trillion would be needed to restore the nation's infrastructure to a state of good repair, over \$2 trillion in new infrastructure projects is currently not funded by the Federal Government and the remainder of infrastructure projects is inadequately funded; and

WHEREAS, the Maine Section of the American Society of Civil Engineers gave the State a grade of C- in 2020, including dams, D+; hazardous waste, D+; roads, D; transit, D+; and wastewater, D+; and

WHEREAS, the state highway system projects a drastic funding shortfall due to the pandemic related to coronavirus disease 2019 and preexisting financial deficits; drivers in the State spend over \$1 billion per year in vehicle operating costs, congestion and crashes, and the State has the highest highway fatality rate in New England; and the State has 1,073 dams with an average age of over 100 years, and a minimum of \$269 million is needed to maintain dam infrastructure; and

WHEREAS, a new National Infrastructure Bank could directly help finance all of these projects, and the United States Congress introduced H.R. 6422, "National Infrastructure Bank Act of 2020," which would create a \$4 trillion bank that could help finance the infrastructure needs and hire millions who have lost their jobs during the pandemic, putting them into higher-paying infrastructure and related jobs; and

WHEREAS, the new National Infrastructure Bank is modeled on previous successful, similar institutions that built much of the nation's infrastructure, and under United States Presidents George Washington, James Madison, Abraham Lincoln and Franklin D. Roosevelt similar institutions financed the infrastructure projects that made us the envy of the world and helped bring us out of the Great Depression and win World War II; and

WHEREAS, the new National Infrastructure Bank will be capitalized by using secure, existing United States Treasury debt, such as treasury bills typically held in large quantities by major investment institutions, requiring no new federal spending and no new taxes, and will be authorized to spend \$4 trillion in urgently needed infrastructure projects; and

WHEREAS, the new National Infrastructure Bank will create approximately 25 million new jobs, ensure the payment of fair wages, mandate project labor agreements, ensure "buy American" policies, direct spending into disadvantaged business enterprises and ensure minority hiring opportunities, and it is expected to increase the size of the economy by 4% to 5% each year; and

WHEREAS, the new National Infrastructure Bank is supported by many organizations: Seventeen state legislatures have introduced or passed resolutions, city and county councils have introduced or passed resolutions and the National Congress of Black Women, National Association of Counties, the United States High Speed Rail Association, the National Federation of Federal Employees, the American

Sustainable Business Council, the National Association of Minority Contractors, the National Latino Farmers and Ranchers Trade Association and many other government, labor and civic bodies have endorsed the National Infrastructure Bank legislation; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge and request that the Congress of the United States pass, and the President of the United States sign, H.R. 6422 to create a National Infrastructure Bank to finance urgently needed infrastructure projects; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Joseph R. Biden, Jr., President of the United States, the President of the United States Senate, the Speaker of the United States House of Representatives and each Member of the Maine Congressional Delegation.

WHEREAS, the Supplemental Nutrition Assistance Program, or SNAP, is a federally governed and funded program under the United States Department of Agriculture, Food and Nutrition Service with shared state administration; and

WHEREAS, SNAP currently provides nutrition benefits to supplement the food budget of qualifying recipients so they can purchase healthy food but fails to account for nonfood essentials, including toilet paper, soap, deodorant, toothpaste and menstrual products; and

WHEREAS, toilet paper, soap, deodorant, toothpaste and menstrual products are essential products needed for human dignity and health; and

WHEREAS, if a person struggles with access to food, that person likely also struggles with access to nonfood essentials; and

WHEREAS, a person who does not have access to nonfood essentials, especially menstrual products and toilet paper, may be forced to use inappropriate and unsafe alternatives, thereby putting that person's health and the health of the person's reproductive system at risk; and

WHEREAS, a person without access to nonfood essentials cannot equitably participate in work, the search for employment or many other activities due to the risk of embarrassment such as from odors or bleeding through clothing; and

WHEREAS, a person who lives in an abusive situation has an increased likelihood of having difficulty accessing menstrual products and other nonfood essentials; and

WHEREAS, it is a matter of human justice and dignity for recipients of SNAP benefits to be granted the authority to determine what essentials they most need; and

WHEREAS, the residents of this State who qualify for SNAP benefits have essential needs beyond food and should therefore be granted the dignity to select how to expend their SNAP benefits based upon their essential needs; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge and request that the United States Department of Agriculture, Food and Nutrition Service enter into rulemaking to amend the stated goal of SNAP to "raising the level of nutrition and essential-need stability among low-income households and maintaining adequate levels of nutrition and nonfood-essentials supplies by increasing the food and nonfood-essentials purchasing power of low-income families"; and be it further

RESOLVED: That We, your Memorialists, respectfully urge and request that the United States Department of Agriculture, Food and Nutrition Service enter into rulemaking to expand the scope of SNAP benefits to include the following nonfood essentials for recipient purchase: toilet paper, soap, deodorant, toothpaste and menstrual products, including but not limited to tampons, pads, liners and reusable cups, underwear and shields; and be it further



RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Joseph R. Biden, President of the United States, for consideration in the federal budgeting process; to the Secretary of the United States Department of Agriculture, Food and Nutrition Service; to the Nutrition Service Administrator, United States Department of Agriculture, Food and Nutrition Service; to the Food and Nutrition Service Associate Administrator of the Supplemental Nutrition Assistance Program, United States Department of Agriculture, Food and Nutrition Service; to the Northeast Regional Office of the United States Department of Agriculture, Food and Nutrition Service; to the President of the United States Senate; to the Speaker of the House of Representatives of the United States; to each Member of the Maine Congressional Delegation; and to the Maine Department of Health and Human Services.

### JOINT RESOLUTION RECOGNIZING FEBRUARY 2021 AS BLACK HISTORY MONTH

WHEREAS, Maine's Black history and the story of Maine's role in the Atlantic world slave economy have been largely effaced from our narratives and from our collective consciousness; and

WHEREAS, from the earliest arrivals of people from Europe and Africa in the Americas, Africans and African Americans have been part of the story of this land, and researchers have identified over 1,600 people of color who lived in what is now called the state of Maine prior to the year 1800; and

WHEREAS, Africans who were brought involuntarily to these shores suffered generations of enslavement and their descendants faced the injustices of lynch mobs, segregation and the denial of basic, fundamental rights; and

WHEREAS, Maine merchants were deeply entangled in the Atlantic world slave economy, as were the banks that handled their accounts and the insurance firms that secured their investments, and at a time when Havana, Cuba was the

hub of the illicit slave trade, Portland was that city's number one trading partner; and

WHEREAS, it was not only Maine's coastal towns that were complicit in the global economy of enslavement through shipbuilding and merchant trading activities, but its inland regions as well: crops and livestock were routinely shipped in the "coastwise" trade to provision the sugar plantations of the West Indies, along with salted fish and even ice from this region; and

WHEREAS, great quantities of Maine timber were processed into barrel staves and shipped throughout the 18th and 19th centuries to the West Indies, where enslaved Africans were forced to fashion them into barrels; they then filled these barrels with the sugar and molasses that were shipped back to Portland and distilled into rum, which was used as currency in purchasing more captive Africans; and

WHEREAS, African Americans in all walks of life have shown resilience despite suffering under slavery and injustice and have made significant contributions throughout the history of the State and across the United States; and

WHEREAS, from the Revolutionary War through the abolitionist movement, to marches from Selma to Montgomery and across America today, and in this State, African Americans have remained devoted to the proposition that all of us are created equal, even when their own rights were denied; and

WHEREAS, the month of February is officially celebrated as Black History Month, which dates back to 1926 when Dr. Carter G. Woodson set aside a special period of time in February to recognize the heritage and achievements of African Americans; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirtieth Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize the significance of Black History Month as an important time to honor the contributions of African Americans in the nation's history and encourage all people in the State to learn more about the past and to better understand the experiences that have shaped the State and the nation.

The **SPEAKER**: The Chair recognizes the Representative from Bowdoinham, Representative Berry.

Representative **BERRY**: Thank you, Mr. Speaker. Mr. Speaker and Men and Women of the House, the measure before us would continue the green power electricity offer that the State of Maine has had in place for many years, for at least as long as I have served in this Body. It's a bill that came to us from the Public Utilities Commission because they support the program and believe that it should continue. The Majority Report would allow us to continue the program.

If we fail to accept the Majority Report and to enact this bill as an emergency, then the program will expire on April 1st. At that time, 4,500 Maine residents and businesses will lose the ability to pay an extra two cents per kilowatt hour for green electricity supply. And I want to say that again; these 4,500 Maine residents and businesses are choosing to pay more, two cents per kilowatt hour more, in order to know that their electricity supply is one hundred percent renewable. It bears repeating that our current electricity supply does not come from the utilities but from a competitive market and, in this case, the procurement is done by the PUC with a lot of checks and balances to make sure that all of the trading and renewable energy credits is above board and that no costs are shifted to other residents of the State of Maine.

So, again, the Public Utilities Commission is where this bill originates. I'm the sponsor, but it is a PUC bill, and they are hoping to continue with the program, which will expire on April 1st if we do not act together with the other body today.

Mr. Speaker, all testimony, with the exception of one written document submitted by an individual, was in support of the bill. That includes the utilities themselves. And there is one other option which I will note for those who are interested in green energy and I think this is important for all of us to be aware of so we can advise our constituents. If, by some happenstance today, we are unable to pass this bill as emergency, you might want to know what to tell your constituents. You can tell them if this happens that the green power is no longer available for them at this time, it may come back, but, MEgreenpower.com is where you can learn more about that program that would otherwise end.

Another place you can send them, however, is the Office of the Public Advocates website, where they can learn more about community solar. And there is a very robust market now, as I'm sure you may have read in the paper or perhaps you've received mailers offering community solar options, I'm sure your constituents have too. And the Public Advocate has

information about this community solar options that your constituents, if they are thrown off this program by our lack of action, will still have available to them. So, I would direct your constituents to [Maine.gov/meopa](http://Maine.gov/meopa) that stands for Maine Office of the Public Advocate forward slash M-E-O-P-A and just look up community solar. There's an excellent video there advising folks about how they can save money and also subscribe to a community solar farm. It would be nice if our constituents have all the options, including the ability to pay more for renewables, but that will depend on us here today.

For my part, and with bipartisan majority of my committee, we request that we together here today vote in favor of the pending motion and continue the green power option for our constituents.

Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Hiram, Representative Wadsworth.

Representative **WADSWORTH**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I rise in opposition to the pending motion. This is an idea that should sunset as scheduled to in April. The main power offered doesn't change the electrons that are flowing into the home that you use, those are dictated by the grid. However, this program creates extra administration costs of purchasing renewable energy credits. With the work that this body did in the last Legislature, the percentage of renewables in our grid is increasing. Also, a lot more homes are net measuring their power from rooftop solar and this bill doesn't really do anything to decrease our electric costs. Please follow my light as it's time to let this program sunset.

The SPEAKER: The Chair recognizes the Representative from Dexter, Representative Foster.

Representative **FOSTER**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I, too, rise in opposition to this motion. The green energy offer does allow those who wish to pay more on their electric bill and those monies go to buy renewable energy credits. They do not, however, go to reduce your bill or my bill, which may be higher because we have higher cost renewable energy projects that are being paid by the ratepayers. I also would say that because these monies go to purchase RECs, there are plenty of other ways that RECs are being purchased, it is not as necessary as it was when this was first developed to do so and, as I believe the Good Representative mentioned, there are other alternatives to those who wish if they do not have this.

Representative **BRADSTREET**: Thank you, Mr. Speaker. Members of the House, I rise in opposition to the pending motion.

I wish to point out that the fiscal note on this bill is 83 million dollars and any unfunded actuarial liability which the bill entails must be paid for up front per the Maine Constitution. It will also add an estimated 1.6 million dollars per year going forward to local school systems. But, beyond that, this has been presented as removing a penalty when in actuality it merely reflects a choice being made by the retiree. A person with 35 years teaching can conceivably retire at around age 57 rather than what is considered to be a normal retirement age starting at 60 years old. Upon retirement, there has been a certain amount of money set aside for retirement benefits for that particular person. Of course, when that money is spread out over many years, over more years that will mean less money per month paid out in benefits. The retiree can choose more money per month for a lesser amount of time or start drawing at normal retirement age for more money per month. The choice is his or hers, it is not a penalty.

Many of us, myself included, have chosen to receive our Social Security benefits at a younger age than what is considered normal retirement age. We, all of us, receive a smaller amount of benefits than we otherwise would have had we deferred benefits to a later time. It was our choice. This is the same scenario.

Additionally, at one of our committee meetings last week, at our work sessions, we were trying to discuss an act or two about other similar retirement bills, when one member of the majority caucus wisely brought up the fact that we have a lot of retirement bills due to be fielded by the committee and that there seemed to be quite a number of retirement plans floating around, covering a wide variety of constituencies. Then wouldn't it be wise to step back and ask the Maine Public Employee Retirement System provide us with a comprehensive picture of the entire system? Then we can have a clearer view of where we are with our retirement plans. The entire committee deemed this a good idea and we subsequently unanimously tabled these two bills.

This is a bill that falls under the same category as those others. In that light, why would we wish to proceed with passing this bill? The only logical action would be to vote no on this motion.

Thank you, Mr. Speaker. Oh, and I do request a Roll Call.

The bills that we were discussing the other day were special plan bills which have to do with the retirement of police officers, firemen, those sorts of folks who are first-line



responders. And the bills we were talking about were, in fact, about hypertension or about PTSD, so, those sorts of things that create a need to retire early. This is a special bill particular to educators. It's very simple. If you come into the workforce at 21, you could put in 35 years and still have multiple years until your retirement. If you retire at 35 years, you would have a penalty every year. And, yes, that is a choice, but it seems to me that it's a choice that we could make in order to honor the work that our teachers do in the State of Maine and it's very unclear how many folks this would affect and so, the maximum fiscal note got put on it, which I respect, but it seems like it's the sort of bill that we should put onto the appropriations table and see if that is the priority of that committee. Thank you.

The SPEAKER: The Chair recognizes the Representative from Guilford, Representative Stearns.

Representative STEARNS: Thank you, Mr. Speaker. Even though I'm a co-sponsor on the bill, with the current fiscal note, I certainly will not be able to vote yes on it and support it. However, it brings up two important things and one is that folks need to remember that when a person is in the education portion of the Maine State Retirement System, as the Good Representative from Portland just alluded to, they do not have transportability. In other words, like in Social Security, you might work ten years as a contractor, 14 years at a restaurant, and 11 more years doing something else, whereas an educator is dedicated and has to work in education and in the State of Maine to do that.

My second point would be I think this is a call to really revive the work of a; it was either a commission or a taskforce that was put together in the 126th and they did some great work at perhaps establishing a new retirement system that would build in that portability so that, in my opinion, would entice more people to go into education and stay in education. Thank you.

In March of 2020, with only 137 of 151 members of the House present, only 90 members were needed in order to push out constitutional amendments to the voters. If all members were present, the required number would've been 101. At the time; just in full disclosure, at the time we only had 150 members elected and that number would've been dropped to 100. In fact, we have several votes that require two-thirds of elected members already in statute. Emergency measures, as we are likely encountering later, that will be coming back as emergency bills and as we saw an emergency enactor being stripped from a bill just moments ago, when they return from the other Body to ours, we're going to need 101 votes to pass those emergency measures. These are just changing statute, not our constitution.

For example, the items that do require the 101 are use of the mining excise tax trust fund, mandates, changes in use of park land, which is often land sales. Those are the only four times that we are requiring two-thirds of our elected membership. While there are other items that fall in the same category as constitutional amendments currently, I have concerns that more need to be looked at for the same reasons but that will have to be an issue for another day and another bill. Ironically, I am aware that if we were to adopt this resolution, it would only take two-thirds present and voting to require future resolutions to end up requiring two-thirds of the elected membership in each Body, which in this Body would be 101, the other Body would be 24.

Amending our constitution should never be taken lightly and with the current climate in our nation and our State, I hope that we can look at this as a way to encourage more bipartisan views in our Legislature. We're watching our statutes become amended today, sadly, in a partisan manner. And while I wish we could compromise and work together more on these bills, there are many factors that are contributing to this today. Statutes are much easier to amend with good reason; they require only a simple majority, can be passed with or without bipartisan support. But my hope today is to encourage more bipartisan negotiations when it comes to changing our sacred constitution. Thank you.

The **SPEAKER:** The Chair recognizes the Representative from East Machias, Representative Tuell.

Representative **TUELL**: Thank you, Mr. Speaker. I would concur with the Representative from Knox. I think she's done a very good job explaining the motivations behind this bill. I know last year when we were in the State House Proper and we had folks that didn't feel comfortable participating in the session that day and were excused because of the newly-emerging COVID-19 at the time, numbers were getting lower and I just believe, as the Representative from Knox does, that constitutional amendments ought to be one of the hardest things that we can get through this Body. Now, yes, they do have to go out to the voters, that is a check and balance, but it should be extremely difficult to get any constitutional amendment through this Body. We have any number of them this year and that's fantastic, but at some point they do have to reach a near-universal threshold, at least a two-thirds threshold, I should say, of the membership of the Body. So, with that, I will be opposing the pending motion. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Scarborough, Representative Caiazzo.

Representative **CAIAZZO**: Thank you, Mr. Speaker. LD 107 is a proposal to amend the Constitution of Maine to specify

that only a person who is a citizen of the United States may vote in a state, county or municipal or other local elections.

The committee agrees with the bill's sponsor, the Good Representative from Winter Harbor, that citizenship is a necessary qualification to participate in any of the above-mentioned elections. In fact, in regards to state office elections, the Maine Constitution, Article 2, Subsection 1, dictates that a person to participate must be a citizen of the United States. For state ballot questions, the Maine Constitution Article 4, Subsection 20 covers that type of election. For county office, Title 21-A MRSA Subsection 11, line 1, covers the citizenship requirement. For local municipal elections, it's Title 30-A MRSA Section 2501, line 2. And for local ballot questions, it's both previous statutes as mentioned.

In his testimony to the committee, Attorney General Frey noted that the requirement of citizenship is already found in the statutes mentioned previously and that, I quote, this means that municipalities are not currently able to adopt ordinances to allow noncitizens to vote in municipal elections as these ordinances would violate the statutes cited above, close-quote. This bill also had a preliminary fiscal impact of 172,000 for potential ballot printing costs.

The committee concluded that the concerns of the sponsor are already being addressed, both constitutionally and through statute, and therefore I would urge you to support the committee recommendation of Ought Not to Pass.

The SPEAKER: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: Thank you, Mr. Speaker. Mr. Speaker and Ladies and Gentlemen of the House, LD 107 simply states that only a citizen of the United States may vote in any state, county, municipal or local election. This bill adds one sentence to the Constitution of Maine; only a citizen of the United States may vote in a state, county or municipal or other election. The issue at hand here is that some would have noncitizens voting in our elections. If we don't enact the constitutional amendment to prevent it, it's only a matter of time before we see municipalities enact noncitizens voting. A constitutional amendment is necessary to ensure that noncitizens never vote in our elections and there is no reasonable reason to vote against this resolution.

I believe, as do most Mainers, that voting is a sacred right reserved for only citizens. We must protect citizens voting or we cheapen the very meaning of citizenship. A poll conducted by Remington Research Group of Maine citizens found that 81% supported a constitutional amendment to bar noncitizens from voting in any election. If voting is allowed for noncitizens, then what value does citizenship hold? If noncitizens are permitted to vote, what prevents foreign interference in our elections by hordes of foreign nationals, be they green card holders or illegal immigrants here under false pretenses? If noncitizens are permitted to vote, what prevents them from voting by absentee from other states or other countries? I find it hard to imagine a voter identification law being passed for this purpose.

If noncitizens are permitted to vote, what prevents them from becoming a majority block in our cities and passing anti-American ordinances that are contrary to the American way and burdensome to state and federal budgets? The answer is nothing. The idea of noncitizens voting is insanity, so my position is clear; only United States citizens should vote in any election. It's that simple.

Perhaps one last thing to consider is that this bill has overwhelming support from the legal immigrant community; I repeat, the legal immigrant community. Here is what Susan Dench, a legal immigrant said speaking in favor of this bill; as an immigrant who came here legally and went through a lot to obtain a treasured U.S. citizenship, I am asking the Legislature to vote for a resolution proposing an amendment to the Constitution of Maine to specify the qualification of electors. Frankly, it both horrifies and terrifies me that we are even having such a discussion in this State. We are not allowed to vote in countries we aren't citizens of, citizens of other nations did not fight to keep us free, nor should they reap the privileges of U.S. citizenship. Voting is a civil right for U.S. citizens only.

Now, the lines have been drawn. There is no gray here, only black and white. Do you support noncitizens voting or will you stand to protect citizens only voting for future generations?

Thank you, Mr. Speaker.

Representative KINNEY of Knox **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought Not to Pass** Report.

We want to make sure only citizens can vote and we have a lot of support for that.

Statutes, as we all know, can be easily amended, and there lies another problem. This statute that has a loophole can be easily amended and we need to make the Constitution changed for citizens. Thank you.

The SPEAKER: The Chair recognizes the Representative from Scarborough, Representative Caiazzo.

Representative **CAIAZZO**: Thank you, Mr. Speaker. LD 109 would allow a candidate to request that the candidate's nickname appear on the ballot by making a written, quote, declaration that the nickname is the name by which the candidate is known to others, close-quote.

Under current law, the candidate's name listed on a ballot must be the one approved by the probate court pursuant to Title 18-C, Subsection 1-701 or, in the absence of an applicable court order, the name consistently used by the candidate during the past two years in filings with governmental agencies and in the transaction of public business included without limitations transactions relating to voter registration, motor vehicle registration, driver's license, a passport, professional license, local, state, or federal permits of any kind, public benefit programs, and veterans' benefits and Social Security. If requested by the Secretary of State when there is a question concerning which name should be listed on the ballot, it is the obligation of the candidate to provide documentation to demonstrate consistent use of a particular name.

The Maine Secretary of State's Office expressed concerns on this bill regarding experience reported in other

states which have adopted similar proposals. The Maine Town and City Clerks Association as well as the Maine Municipal Association raised concerns with the challenge of identifying what could be considered as offensive language and the difficulties associated with regulation of said language.

For these reasons, I hope you join me in supporting the committee recommendation of Ought Not to Pass.

Representative FAULKINGHAM of Winter Harbor **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought Not to Pass** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: Thank you, Mr. Speaker. LD 109 allows a candidate to request that their nickname appear on the ballot following their legal first name for an election in the State. The candidate must declare to the Secretary of State that the nickname is actually the name by which the candidate is known to others. This bill provides the voter with a clearer and more complete representation of the candidate and will help prevent confusion at the ballot box.

This bill is about transparency. This bill is about letting the voter know who they are voting for and letting the candidate campaign honestly by using the name they are commonly known as. This bill does not create a space issue on the ballot. For example, W.R. Billy Bob Faulkingham is shorter than William Robert Faulkingham. Even if it did, some names are long, some names are short, that's just a matter of fact that we deal with already. This bill received bipartisan support in the 129th Legislature, in the Committee of Veterans and Legal Affairs, as well as the other Body, and passed unanimously in this Body twice.

The only opposition to this bill seems to be that a candidate could use electioneering techniques by calling themselves something like the greatest. First of all, if someone did something like that, I think it would guarantee that they would lose. I also don't foresee anyone going through the work of getting signatures to get on the ballot and all that entails and then proceed to lie to the Secretary of State on a sworn affidavit about the name they are commonly known as. But if that is what they seek, a simple probate court change could do that for them and the Secretary of State would have no recourse. So, if a probate court can change your name in a matter of minutes, then what is the need for this bill? Well, for me, I don't want to legally change my name. I am proud of the name that my parents gave me. My first name is William, it is after my great-grandfather, a two-war veteran, Spanish-American War and World War I. He was named after his father, who was a mason in the city of Alexandria. He set the last stone in the Washington Monument and I am proud of that name. My middle name is Robert. I am named Robert after my grandfather, Bob, a World War II veteran who received a Purple Heart in the Pacific Islands. He was hit by a mortar shell fighting the Japanese. I am very proud of that name. I would never legally change it. I feel that the suggestion of changing my name is insulting to my parents and myself.

Now, I'd like to tell you a short story, and some of you have heard this before but I'm going to repeat it again. A couple months after being elected, I was having a load of lobster traps delivered to my house. About midway through unloading the traps, we started discussing politics. At that point, the man that was unloading the traps said the only one

he voted for that won was that Faulkingham. I said oh, yeah, who? And he said that William Faulkingham. You must know him. And I laughed and said you know you're talking to him? We both laughed, but that right there is an honest example of why we need to pass this law. This law is about transparency and people should know who they are voting for. I've been called Billy Bob my whole entire life but the one name I have never been referred to is William Robert.

The Representative from Madison, John Ducharme, is Jack Ducharme. The Senator from Aroostook, Harold Stewart III, is Trey Stuart. U.S. Senator Willard Romney is Mitt Romney. Representative Rochelle Pingree is Chellie Pingree. The list goes on and on. Twenty-two states allow common known names on the ballot, which is exactly what this bill does. There are reasons more complex than these examples. Some citizens have names that are not common in America. These are mostly immigrant names or names from minority religions like Islam. There are many Muslim names that are very long and difficult for some Mainers to pronounce. I'll give you an example; I have a good friend who is Iranian. His family came to the United States when they fled Iran in '79. His name is Sharon. But because it wasn't a common name here and most people had trouble with it, the name he told people to call him was Shawn. This is the name everyone has called him since childhood and everyone knows him as. If he wanted to run for office, he should be able to run as Shawn. It would be a name he is commonly known as, the name he goes by, it would also be a way he could avoid implicit bias on the ballot. To not allow this shows inherent racism in our election laws.

I would like to give you another example why this law is very important for future ramifications. It came to my awareness when I was watching television and a credit card commercial came on. There was a young man working on a project building something. The commercial goes along, the young man is sitting on the couch with his mom reading through a book of names. He then declares to his mother that he's decided on a name. The mother is proud and supports the son. The moral of the story being told in this commercial is that the young man is transgender and was given a female name at birth. So, then at the end, the credit card company says we will honor your chosen name and print it on your credit card. It was at this point that I realized that a credit card company is more progressive than Maine's election laws. Can you imagine taking a young man like this and forcing them to run on the ballot with a female name? Our current laws are transphobic and we need to correct that.

There are also reasons why a person might need to use this law to get their true known-by name on the ballot before they can go through the probate court process. This bill was supported by the League of Women Voters and the Maine Transgender Network. There are many more examples like these, there will be many more in the years to come. This bill is about letting people know who they are voting for. This bill is about letting people run honest campaigns. This bill is the most nonpartisan bill in the Legislature. Join me in passing LD 109 now to improve future elections.

The SPEAKER: The Chair recognizes the Representative from Knox, Representative Kinney.

Representative **KINNEY**: Thank you, Mr. Speaker. Ladies and Gentlemen of the House, I stand in opposition of the pending motion. As was stated by the Representative from Winter Harbor, this bill was supported by the League of Women Voters, Anna Keller, Bob Howe; I think that might've been a nickname, and also Quinn Gormley from the

transgender organization, in addition to several of our legislators, including additional representatives that the Representative from Winter Harbor did not mention, the Representative from Greenbush, and the Representative from Skowhegan as well as the Representative from Carmel, all of whom, I believe, go by nicknames when you refer to them by their first name.

Additionally, the fiscal note that has been placed on this bill is \$266,000. And normally, as we heard in the previous bill that we heard, the fiscal note normally for additional language on a ballot is \$172,000. The Secretary of State's office said that because there are going to be too many people that are going to require additional names added to their name on the ballot that it will possibly require a higher fiscal note, whereas the Representative from Winter Harbor mentioned, his name would be shorter. And that is the case for the most part with nicknames. These are the familiar names that these people do go by and I urge you to vote in opposition to the pending motion so that we can have this pass as it was done in the 129th with unanimous support. Thank you.

The SPEAKER: The Chair recognizes the Representative from Milton Township, Representative Dolloff.

Representative **DOLLOFF**: Thank you, Mr. Chair, Ladies and Gentlemen of the House. Representative Faulkingham presented this bill in the 129th with unanimous support and for what he told us all here, we should reject the Ought Not to Pass.

This bill will help the voters because I don't know how many of you that even put your campaign signs out with your nickname or short name, people know you as by, but it's going to be different when they see the ballot. So, I believe it's going to make our voters know and understand what candidate they're actually voting for. Yes, this has a high fiscal note, but that is only because in case of it takes two pages for the ballot, so there might not be any. Because if you consider that William Robert, that has 14 letters in it, versus Billy Bob that has nine, or Christopher that has 11 or Chris that has five, actually, it's probably going to shorten up our ballots. Thank you.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Oxford, Representative Dillingham.

Representative **DILLINGHAM**: Thank you, Mr. Speaker and Ladies and Gentlemen of the House. I rise today disappointed that we were unable to find agreement on the supplemental budget that is before us.

As the Representative from Falmouth said, we found agreement on 99% of this budget and I do appreciate their efforts. From the beginning, I believed that the hard work of the Appropriations Committee would get us to a final budget proposal that the Members of this Body could agree on and result in the necessary two-thirds support for emergency passage. I'm not ready to give up hope.

In looking to the Majority Report, we are in agreement but the proposal eliminates a tax exemption currently in law which will result in increased taxes for those employers. Also, the provision reasserting the Legislature's role in appropriating funds that come to the State to aid in our COVID recovery is of vital importance, but so is ensuring that that is done so in a manner that is fully representative of all and should be done with two-thirds support of this Body.

Finally, Appropriations Committee members were pleased to be able to support an income tax reduction for those Mainers who found themselves unemployed as a result of government-forced shutdowns. As was stated during committee by the minority members of Appropriations, it is important that we offer help but that help shouldn't be limited to just those who lost their jobs, but also those who performed their duties to ensure essential services were provided for the rest of us, such as staffing our grocery stores, teaching our children and working the front lines in our hospitals. These Mainers also deserve the advantages a reduction in their income tax provides and I hope we can have that discussion moving forward.

We have all suffered over the last year and that suffering should not be compounded by the State looking to mitigate

their own losses on the backs of suffering Maine residents. Without the ability to reach an agreement, I will be supporting my caucus and our members of Appropriations and will be voting against the budget before us as it is presented.

Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Perry

Representative **PERRY**: Thank you, Mr. Speaker. Fellow Members of the House, I rise today to speak in favor of the motion before us. Almost a thousand businesses in Bangor received PPP loans that supported 15,241 jobs. I don't know a single restaurant in Bangor; in the whole Bangor area that would have survived this past year without the Paycheck Protection Program. From Governors to the Ground Round, small business owners relied on that support from the government in order to keep their staffs and operations running. In total, over 28,000 businesses in Maine relied on these loans to make ends meet and keep hundreds of thousands of Mainers employed.

These are not multinational corporations we're talking about here, who have taken their jobs overseas. These are businesses rooted in Maine and are the bedrock of our economy. Maine businesses needed the support then and they need it now. With the corporate filing deadline of March 15th, they desperately need our support again. I've heard from dozens of small businesses who need clarity and cannot afford to be left hanging. These people need to file their tax returns by Monday and they don't know how to file, they don't know what we're going to do here. And I promised the accountants who contacted me, they would have clarity by the end of tonight.

As a small business owner myself, I get it. If we do not pass the supplemental budget, we'll be letting these businesses down that have spent the past year working incredibly hard to make ends meet. For the sake of every business in my district and every business that received PPP funds, I urge you, Mr. Speaker and my colleagues in the House, to support the supplemental budget tonight. Thank you.

The SPEAKER: The Chair recognizes the Representative from Biddeford, Representative Sheehan.

Representative **SHEEHAN**: Thank you, Mr. Speaker. Mr. Speaker, Fellow Members of the House, I rise today to speak in favor of the pending motion.

In my community, businesses of all sizes benefitted from the Paycheck Protection Program. The largest Biddeford businesses to receive PPP money employ nearly 90 people, while the smallest mom and pop operations, including my own business, employ just a few. All together, the Paycheck Protection Program supported more than 3600 jobs at Biddeford-based businesses. Businesses in our community received more than 32.5 million in badly-needed PPP funds, and they all have these things in common. They were built from the ground up by local people who put their heart and souls into turning their dreams into a reality. The people who make up these businesses live and work in our communities, they're not big corporations based in far-off places, and they will all be hurt badly if we leave here today without passing this supplemental budget.

My husband and I own a small business in Biddeford and consider ourselves very, very lucky to be supported by a community of hardworking entrepreneurs dedicated to their employees and to our community. As they or any other entrepreneur can tell you, it's not always easy even in the best



of times, and this year has been anything but the best. Maine's small businesses are doing all they can with the bad hand that they've been dealt. Their scrappiness, ingenuity, and dedications have allowed them to keep their lights on all this time and it is heartbreaking to me to think that their businesses might not make it through this final stretch. We need to have their backs today.

Mr. Speaker, I know that everyone in this chamber cares deeply about the small businesses that form the bedrock of all of our communities. Over the course of this pandemic, many of us have spoken passionately on behalf of these businesses. Today, I ask my colleagues to act on behalf of these businesses. I ask you, Mr. Speaker, and our fellow Members of the House, to join me in supporting the pending motion. Thank you.

The SPEAKER: The Chair recognizes the Representative from Gorham, Representative Terry.

Representative **TERRY**: Mr. Speaker and Colleagues of the House. Mr. Speaker, I rise in support of the pending motion. As chair of the Taxation Committee, I would like to speak about the supplemental budget proposal that addresses funds that businesses received through the Paycheck Protection Program.

First, it took a lot of hard work and consensus building to arrive at the position where we are today and I want to thank my fellow Taxation Committee members and the members of Appropriations for their contribution to this process.

The motion before you provides complete income tax relief and double exemptions for one hundred percent of Maine businesses that received PPP loans. Double benefits are not something that anyone in the Legislature likes to give lightly but, as we know, this is an unusual time. This tax relief will provide a boost of dollars that Maine businesses can use to either help keep paying their staff or start the tourist season with enough cash to make sure they have a fully-stocked store for people to buy from or enough bait to set traps with or enough burger meat to sell at dockside lunches. It gives certainty to all Maine businesses who received the loans when it comes to their taxes but, more importantly, it also brings that much-needed bump to the businesses who have struggled most during this pandemic and to those who employ so many of our Maine citizens.

I run a small business myself, so do the majority of my friends in the restaurant business and hospitality business. We are a small business state. And we know that to start a business is to take a chance on a dream. So, when we talk about what we as a Legislature can do to make sure those dreams don't die, this is personal to me. I totally get it. When the pandemic hit Maine and federal relief funds became available, business owners used PPP and whatever resources they had at their disposal to innovate and try to hang on there through all the rest of this pandemic. I'm happy that this supplemental budget proposed before us will make that goal even a little bit easier to achieve.

With tax filing already underway, we know we need to act quickly. Businesses need certainty and taxpayers need certainty. If we don't pass this supplemental budget, Maine will find ways to make our shortfalls work. What we will not do, though, is send that extra lifeline to our small, medium and large Maine businesses that so desperately need our help. We will fall short of the public-private partnership that's so important to all of us. This motion does right by Maine businesses, Maine workers, and all those families that have to

struggle because of this pandemic and I respectfully urge this Body to vote yes.

Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Raymond, Representative Fay.

Representative **FAY**: Thank you, Mr. Speaker. Mr. Speaker, I rise in support of the pending motion.

This supplemental budget proposal includes 47 million dollars to exempt unemployment benefits from state income taxes. This would provide critical relief to over 160,000 Mainers whose jobs were impacted by COVID-19 and received unemployment insurance in order to make ends meet. This tax relief extends to workers who received unemployment benefits including self-employed business owners and people who saw their hours cut.

When the pandemic hit Maine last year, I started to hear from constituents in every corner of my district, asking for help navigating the unemployment system. People in my district are hardworking and resilient and most who reached out to me had never accessed unemployment before. Job loss in my district impacted people across sectors. I heard from people who worked at campgrounds, municipal libraries and in local retail shops. Because of the sheer overload of unemployment cases being processed by the Maine Department of Labor, many of my constituents, like in all of our districts, found themselves in really tough situations. People lost their source of income and were now spending hours on hold each day trying to address issues with their unemployment claims, all while fearing that if they didn't get their benefits in time, they might not be able to meet their basic needs.

I'm proud that my colleagues on the Appropriations Committee and I have included tax relief to Mainers who have experienced so much financial hardship from the pandemic. Without this measure, people who received unemployment benefits will be on the hook for state income taxes. At a time when so many Mainers are struggling to get by, we can lessen the tax burden on those most affected by the economic impacts of the pandemic by passing this supplemental budget.

Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Eliot, Representative Meyer.

Representative **MEYER**: Thank you, Mr. Speaker. Mr. Speaker, Women and Men of the House, I rise in support of the pending motion.

Like so many frontline health care workers, Maine's direct care service providers and nonprofit providers have faced enormous challenges over the past year. Our organizations that provide direct care services to Maine's most vulnerable have struggled to meet their clients' needs, protect their workers and, frankly, just to keep the doors open. Unlike other organizations, however, these critical service providers have not received the federal assistance that has kept so many businesses afloat during these difficult times. Left out of the Paycheck Protection Program as well as other grants and relief monies, these organizations and the people they serve have been, in many ways, left out of the response to the pandemic.

The Majority Report recognizes both the necessity of these services and the needs of our direct care providers. This proposal allocates 30 million dollars to direct care providers that did not receive PPP funds, state grants, or any other relief and without such support have struggled to meet the needs of Maine people. This investment represents a two to one match of federal dollars to help keep these organizations running and to provide needed services to those whom they serve. The

proposal before us will benefit our constituents, providing desperately needed short-term relief to help programs and services for Maine's most vulnerable citizens - valued and important members of my own community, Mr. Speaker, and I believe of each and every community represented in this chamber today. That we may fail them is unconscionable. I urge our honorable colleagues to join me in supporting the pending motion, and I thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Canaan, Representative Stetkis.

Representative STETKIS: Thank you, Mr. Speaker. Oh, I guess I don't have to be that close. I wasn't going to speak to this motion but after hearing the comments, I had to thank and congratulate my democrat colleagues for changing their minds and realizing how important the republicans' call for not taxing those who received PPP loans that was originally proposed is to our struggling businesses.

Unfortunately, our call for no tax increases on all job providers has not been heard. For this reason, I cannot support this budget.

The SPEAKER: A roll call has been ordered. The pending question before the House is Passage to be Enacted All those in favor will vote yes, those opposed will vote no.

**JOINT RESOLUTION MEMORIALIZING THE FEDERAL GOVERNMENT TO ELIMINATE THE WINDFALL ELIMINATION PROVISION THAT PENALIZES MAINE STATE RETIREES**

WE, your Memorialists, the Members of the One Hundred and Thirtieth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the President of the United States and the Congress of the United States, as follows:

WHEREAS, under current federal law, individuals who receive a Social Security benefit and a public retirement benefit derived from employment not covered under Social Security are subject to a reduction in the Social Security benefits; and

WHEREAS, these laws, contained in the federal Social Security Act, 42 United States Code, Chapter 7, Subchapter II, Federal Old-Age, Survivors, and Disability Insurance Benefits, and known as the Government Pension Offset and the Windfall Elimination Provision, greatly affect public employees, particularly women; and

WHEREAS, the Windfall Elimination Provision reduces by a formula the Social Security benefit of a person who is also receiving a pension from a public employer that does not participate in Social Security; and

WHEREAS, the Government Pension Offset and the Windfall Elimination Provision are particularly burdensome on the finances of low-income and moderate-income public service workers, such as school teachers, clerical workers and school cafeteria employees, whose wages are low to start; and

WHEREAS, the Government Pension Offset and the Windfall Elimination Provision both unfairly reduce benefits for those public employees and their spouses whose careers cross the line between the private and public sectors; and

WHEREAS, since many lower-paying public service jobs are held by women, both the Government Pension Offset and the Windfall Elimination Provision have a disproportionately adverse effect on women; and

WHEREAS, in some cases, additional support in the form of income, housing, heating and prescription drug and other safety net assistance from state and local governments is needed to make up for the reductions imposed at the federal level; and

WHEREAS, other participants in Social Security do not have their benefits reduced in this manner; and

WHEREAS, to participate or not to participate in Social Security in public sector employment is a decision of employers, even though both the Government Pension Offset and the Windfall Elimination Provision directly punish employees and their spouses; and

WHEREAS, although the Government Pension Offset was enacted in 1977 and the Windfall Elimination Provision was enacted in 1983, many of the benefits in dispute were paid into Social Security prior to that time; now, therefore, be it

**RESOLVED:** That We, your Memorialists, respectfully urge and request that the President of the United States and the Congress of the United States work together to support reform proposals that include the following protections for low-income and moderate-income government retirees:

1. Protections permitting retention of a combined public pension and Social Security benefit with no applied reductions;
2. Protections permanently ensuring that level of benefit by indexing it to inflation; and
3. Protections ensuring that no current recipient's benefit is reduced by the reform legislation; and be it further

**RESOLVED:** That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Joseph R. Biden, Jr., President of the United States; the President of the United States Senate; the Speaker of the United States House of Representatives; and each Member of the Maine Congressional Delegation.

Very briefly, I would like to express my personal thanks and my strong and heartfelt appreciation to everyone in this room who has come together, helped to not only respond to a 150-million-dollar budget shortfall, which we could've done much sooner, much easier, probably, but we all realized that once we had the flesh around the bones, there needed to be a lot more meat to address the hardships that have been caused by the pandemic. And we came together in 228 and with the help of the good chair from Falmouth, Representative Pierce, the support of the two corner leaders, I want to respectfully acknowledge that the Representative from Old Town, having been a member of the

Appropriations Committee, knows what goes on. The Representative from Oxford, Representative Dillingham, has been a stalwart for us. My entire Republican Caucus has come together in a way that I think bodes well for the future.

Because we have met the challenge, the message we are sending to the people who are watching us and those that said it couldn't be done, is that we can, when we work together, solve huge problems. I want to thank all of you. I think, around the room; I've been studying that picture of all of us, I counted 40 people that I haven't had a conversation with yet. You must be so confused and wondering what goes on in the making of a budget. Now you've learned, you can be extremely helpful going forward. So, thank you, all of you, and let's get this done and let's continue the good work.

The SPEAKER: The Chair recognizes the Representative from Old Town, Representative Dunphy.

Representative **DUNPHY**: Thank you, Mr. Speaker and esteemed colleagues of the House. The compromise we've reached tonight is the result of weeks of hard work from my caucus and the caucus across the aisle. Thank you to every member of the Tax Committee and the Appropriation and Financial Affairs Committee for their dedication to delivering much-needed relief to Maine people and Maine businesses.

The final compromise put 8 million dollars into our budget stabilization fund and creates a study on foreign derived intangible income deductions. The supplemental budget we have before us will provide critical relief for 160,000 Mainers who lost their job due to the pandemic, provide support for Maine businesses, it provides targeted relief to direct care service providers and nonprofit providers, support for early college aspirations program for working-class Mainers, investments in a new comprehensive child welfare information system, steps to address contamination from forever chemicals, and provides incentives to construction for affordable housing in Maine.

This is a win for Maine and a victory for bipartisanship, and I thank you, Mr. Speaker, and I request a Roll Call.
