The SPEAKER: The Chair recognizes the Representative from Warren, Representative Pluecker, who wishes to address the House on the record.

Representative **PLUECKER**: Thank you, Mr. Speaker. I appreciate the opportunity to address the assembly here.

Earlier this year, the Chief Executive announced that 2025 will be celebrated as Maine's Year of Youth in Agriculture, an initiative launched during the Maine Agricultural Trade Show to recognize and support the next generation of agricultural leaders. For the first time ever, today is also Youth in Agriculture Policy Day at the State House alongside Maine Agricultural Day. A key opportunity to integrate this important initiative is to connect Maine students directly with policymakers, industry leaders and hands-on experience. This morning, 10 students from across the State of Maine join us in the Gallery. They've been selected as Policy Day participants from the DACF and DOE and will attend the ACF Committee this afternoon. They are learning about the legislative process, how to submit a bill, attend a work session and testify at a public hearing. There are also students throughout the day today from the Maine Academy of Natural Sciences and Easton schools. These are the next generation of students engaged in agriculture policy within our State.

Maine agriculture contributes over \$3.2 billion annually to the State's economy, provides 10s of thousands of jobs and strengthens food security across the State. The students here today are interested in animal health, rural prosperity, environment, food security and farm viability, to name a few issues. Please welcome them to the State House today when you see them.

Representative **SARGENT**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I am pleased and honored to rise to salute Ted Hutch for his truly legendary leadership of 35 years coaching the boys and girls in the York High School Track and Field and Cross-Country teams.

In addition to coaching, Hutch was also an ed tech working with special ed students, and apparently, he became legendary as well with most York students because he did the announcements every morning and the Pledge of Allegiance. Every Friday, he announced the end of the week and with it, he would say, "it's Friday, the day we buy our souls back from the pawnbroker of the weekday grind." So, perhaps we can use that a bit, Mr. Speaker, if we need it.

As a Representative of the town of York, I extend my gratitude and thanks to Hutch. I'm proud to say that the town of York will be naming its new athletic fields in his honor.

Currently, my grandson is a fourth-generation in the Windham school system. Extremely proud of these kids and what they've done. Huge congratulations from all of us. Thank you.

Representative **OLSEN**: Thank you, Mr. Speaker. I, too, want to congratulate the Windham Boys Basketball Team, but winning the Championship is not everything. Winning the Championship is part of it; what's almost more important is the respect that they've learned out on the court, the respect they've learned with their competitors, the respect that they've learned from the community. **READ.**

The SPEAKER: The Chair recognizes the Representative from Fairfield, Representative Rudnicki.

Representative **RUDNICKI**: Thank you, Mr. Speaker. It is with great pride that I stand before you today and recognize this organization.

I've been a member of this organization for several years now, but before I get into why I'm so proud of this organization, I want to give this Body a little bit of a history on what the Grange is, because it's my guess there's quite a few people in here that do not know what a Grange is and what they do. So, this was actually written by the historian of the Maine State Grange, Stan Howe.

The origins of the Grange in Maine extend back to the Farmer's Clubs, which were organized in the 1850s. Each club debated agricultural and household issues while both men and women had their separate gatherings. The clubs began to decline after the Civil War and were soon merged into another movement that would attract many of Maine's rural population. The Grange, officially known as the Patrons of Husbandry, was organized in Washington, D.C. in 1867. It grew slowly during its early years, but arrived in Maine in 1873. The following year, the Maine State Grange was organized in Lewiston. By the end of 1874, there were 64 Granges and approximately 2,000 members. From the beginning, there was a great interest in cooperative activities, including offering insurance, advocating railroad and banking regulations, promoting group purchasing. In 1876, the Order had grown to over 228 Granges, with about 12,000 members. At first, the hard times of the 1870s served as a stimulus to the membership growth, but the numbers began to decline as the decade passed. Prosperity returned and good leadership, such as that provided by the State Master, later Chief Executive, Frederick Robie of Gorham came into being. The Grange began to take strong positions on legislative issues and educational reforms. Libraries and readings were encouraged in Grange halls, as well as debates on multitude of topics of interest to members. In many ways, the Grange served as an adult education resource for many Mainers.

The Maine State Grange began to confer the Sixth Degree in the 1880s. Also, during this period, Pomona Granges, which is the county level, came into being. While Edward Wiggins was State Master, the Grange raised funds for Grange Cottage at Good Will Farm in Hinckley. The connection continues to present, with members donating thousands of pennies to Good Will Hinckley while supporting the Grange Cottage.

A dramatic period of growth was witnessed during the years under State Master Obadiah Gardner. The number of Granges grew from 243 to 419. Membership increased from 21,500 to 55,212. By 1907, Maine's per capita Grange membership was larger than any other state. Legislatively, the Grange supported prohibition and Rural Free Delivery. The Grange also advocated for strong local schools and increased funding for the University of Maine. The Grange worked with the State governmental agencies to promote reform in Maine agricultural practices, to protect the quality of fertilizer. In the Progressive era, the Grange supported the direct primary, recall and referendum, voting rights for women and curbs on monopolies. By 1914, with the passage of the Smith-Lever Act, the Grange worked closely with the extension services to assist in familiarizing farmers and their wives with new and improved scientific methods of farming and household management. The Grange also developed a close association with the Farm Bureau, which, along with the Extension Service and the 4-H clubs, used Grange halls for meetings and activities throughout the 20th century.

For many rural and farm women, the Grange became a social refuge which allowed them to meet other women and escape, however briefly, the onerous work of the household. From the earliest days, and long before the ratification of the 19th Amendment to the U.S. Constitution in 1920, the Grange granted women equal voting rights within the Order. During World War II, the Grange supported men and women in combat by paying their dues and sending packages of clothing and food. Grangers were also encouraged to buy war bonds, support rationing procedures and collect strategic materials. Following the war, the Grange growth continued. In 1945, the Maine State Grange purchased a state headquarters at 146 State Street in Augusta; it is still here. Faced with a major outbreak of forest fires in 1947, the headquarters became the center for distribution of food, clothing and supplies to those who lost their homes during this disastrous time. In the 1960s, the Grange took an active role in supporting the Maine Conservation Camp at Bryant Pond, building Rogers Hall from funds raised at bean suppers.

Changes in insurance law and growing popularity of television, the decline of farming and other demographics and cultural changes began to affect the membership levels of the Grange after 1960. While the Order is still a factor in many towns through its community service roles, and its halls are one of the icons of the State landscape, the number of Granges have dropped to about 180; membership now is approximately 8,000. Many efforts are being made to revive the interest in the Grange and encourage membership development with enhanced programming and membership benefits as incentives.

Now, let me tell you why I'm proud of the Grange that I belong to. Victor Grange in Fairfield is less than a quarter of a mile from my house and, you know, the first 15 years I lived there; it's been 30 years now; I barely set foot in that building. But I will tell you; and a lot of that is we're living our lives, but I will tell you, since I've become involved; and what got me involved was the first time I went to one of their dinner theaters. They had dinner theaters down the road from my house, there's flashing lights, the police cars are flashing, the lights are all there. What it was is they were slowing traffic down, because we live on a corner of a main road, but people recognized it and knew there was something going on at the Grange. They've stopped doing dinner theaters, but I will tell you the Grange has taken on so many roles in the town of Fairfield. Our role in the Grange now is more of a community center. We are the community in Fairfield; as far as we're concerned, we are, anyway. But let me tell you some of the great events.

First of all, Victor Grange in Fairfield celebrated 150 years last fall. That's an accomplishment. And I will tell you, if you've never been into one of these Grange halls, you should go check them out. The history in there. Our Grange, specifically; the history in there, the metal ceilings in the building is incredible. We actually have a curtain that's on the stage upstairs that has advertising on it still from the 1940s and '50s. We're actually looking to raise some money to eventually get that restored. So, we're working on that. But when I started and got really involved in the Grange, that was because of the window dresser program. The Grange partnered with a group called the Window Dressers, and what they did is made inserts for homes for the windows in the homes, seniors that would sit by the window and the draft coming through; they worked with window dressers. We got a lot in our community were able to get these inserts for little or no cost and they just had to volunteer. I had some for my windows. It was a fantastic program and got involved.

We do monthly bean suppers. If you've never been to a bean supper, you've got to come check us out, we have a great

time. We do monthly cooking classes; by the way, we're making whoopie pies tonight; we do senior luncheons where we educate, socialize and help our seniors on many issues and even with their taxes. We've done two benefit suppers just in the last month for fire victims in our community. We were fortunate enough, with the help of the town of Fairfield, to actually get a generator for our Grange, so that we are now our warming center in our community. And during the flooding back in '23, in December '23, we were the first open and we were the only one open for two days and we supported community members that came to the Grange for their food, and we provided three meals a day for the first two days during all the flooding. Again, you can tell I'm very proud of the organization that I belong to with this.

So, other things that we've done, just to give you a heads up; we've done some canning and freezing of fruits and vegetables that we give to our seniors and the one thing that we've started doing this year which we are extremely proud of is the Support our Senior program. What this program does is we give back to our seniors, who have a lot of pride and don't like to ask for help. And so, we hear from members of the community in saying this person needs help, we provide blankets, we provide clothing, we provide caring boxes that have puzzle books, Depends, pet food, medical equipment. If you know anybody that's got wheelchairs and shower chairs and that, we collect those to give them to community members that need them.

So, we've done a lot for our community, and I'm so proud of that. You should check us out on our Facebook page for Victor Grange in Fairfield. And I thank you very much for your indulging me, Mr. Speaker, but I'm very proud of this organization.

The SPEAKER: The Chair recognizes the Representative from Carmel, Representative Thorne, who wishes to address the House on the record.

Representative **THORNE**: Thank you, Mr. Speaker. I don't know what happened there; it might've been the old aircraft engine hissing in my ears, I didn't hear you; but I couldn't go without mentioning our Carmel Golden Harvest Grange in Carmel, #33 among the Grange Halls.

As a lifetime member of the Carmel Historical Society, I know a lot about the Grange Hall. It serves as our American Legion Post 107 meeting place and Auxiliary on the third Thursday of every month at 7:00. It serves as bingo from May through October every Sunday at 6:30. We conduct our special town meetings at our Grange Hall. We do fundraising suppers at our Grange Hall. It's not a fancy building; it's an old building. It serves as our polling place. For the last three cycles, I've had the pleasure of having a captive audience, as not too many politicians will stand out front of the Carmel Grange Hall, but the constituents that come through, I think are happy to see me, for the most part, and say hello to them. And we also have rummage sales there. Rummage sales that help raise funds for families that need them, for families that are in need on traumatic occasions, such as the unexpected passing of a loved one, the community comes together and raises funds and the Grange Hall comes up.

I just couldn't go without mentioning that our Grange Hall is special to us in Carmel. Thank you, Mr. Speaker.

**READ.**

The SPEAKER: The Chair recognizes the Representative from South Paris, Representative Lance.

Representative **LANCE**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Today, we gather to mourn the tragic loss of a hero who served our community and State with unparalleled loyalty, dedication and bravery; Maine State Police K-9 Officer Preacher.

Preacher, alongside his partner, Sergeant Jonathan Russell, worked tirelessly to protect the people of this great State, making significant contributions to public safety and the well-being of those he was sworn to serve. His untimely death while performing his duties reminds us of the dangers that those who serve and protect us face every single day. On February 3rd in Portage Lake, K-9 Officer Preacher was tragically killed in the line of duty during a domestic dispute that led to an armed standoff. The suspect barricaded himself inside a home before attempting to escape. Preacher was sent after the suspect, at which time he was shot in the abdomen by the suspect. Despite urgent attempts to saving Preacher's life, he succumbed to his injuries at a veterinary clinic in Presque Isle.

We often think of law enforcement officers as those who wear badges and carry firearms, but today, we remember that the K-9s who serve alongside them are no less heroic. Preacher was more than just a working dog; he was a partner, a protector and a friend to his handler and the community. So, let us be clear; while Preacher may have been a dog, his loyalty, courage and sacrifice are qualities that define the very essence of heroism. We owe it to him and to every K-9 who serves us to ensure that they receive the recognition and respect they deserve. May Preacher's memory inspire us to continue our work to make our community safer, and may his sacrifice be a constant reminder of the bravery and dedication of all those who serve in the line of duty.

The SPEAKER: The Chair recognizes the Representative from Westbrook, Representative Salisbury.

Representative **SALISBURY**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I rise today to offer my condolences to Sergeant Russell, his family and the colleagues of K-9 Preacher.

When my husband's K-9 partner came home, Tyson; when he came to live with us; initially we had a bit of a getting-to-know-you period that included a language barrier. We didn't realize that he only understood Dutch, so, that took us a little bit of time, but he quickly became a very important member of our family. And he was very important, once I realized and fully understood what his job was, and part of that was to keep my husband safe at work, and he did that job very, very well. And he was smart enough to know when my husband was going to work with him at the Windham Correctional Facility or when he was going to the fire department, even though both uniforms were blue. When it was time to go the fire department, he just got on the couch, whatever.

But the impact that Tyson had on our lives and our family can't be overstated, so, my heartfelt condolences go out to Sergeant Russell and his family for losing that partner, but also that sense of security that I know that Preacher probably provided, and the time and the commitment that went into training him and making him an important part of his unit. So, again, thank you for letting me express that.

He also taught as an adjunct college professor. After moving to Wiscasset, he served on Wiscasset's Economic Development Committee and championed fundraising efforts at St. Philip's Episcopal Church. He was also a member of the Lincoln Theater in Damariscotta. Mr. Malaby will be long remembered and sadly missed by his family, friends and community;

And I know that; where Rich is at now, and I can't wait to have a reunion with him and catch up when I see him then. So, my condolences go out to all the friends and loved ones of Rich, and I'll see you again someday, Rich.

Rich was a kind man. I love that he served on HHS, because that's where my heart lies. So, I want to thank the Good Representative from Winter Harbor for putting this Memoriam in. He was a very special man, and he will be very much missed.

WHEREAS, amateur radio, also known as ham radio, provides a bridge between people, societies and countries by creating friendships and sharing ideas; and

WHEREAS, April 18, 2025 marks the 100th anniversary of the founding of the International Amateur Radio Union, the entity that promotes the international cooperation and communication that are the hallmarks of amateur radio; and

WHEREAS, there are nearly 780,000 federally licensed amateur radio operators in the United States and approximately 4,500 in the State of Maine; and

WHEREAS, amateur radio is a valuable resource and, during emergencies or natural disasters, such as the ice storm of 1998, Hurricane Katrina, the Boston Marathon bombing and countless other emergency situations, is often the only dependable way to communicate locally or internationally; and

WHEREAS, many Maine amateur radio operators serve their local and county emergency management agencies by training and holding exercises to prepare for when their skills are needed during times of emergency; and

WHEREAS, Maine amateur radio operators routinely volunteer their equipment and time to provide public service communications for such events as the Dempsey Challenge, the Trek Across Maine, the TD Beach to Beacon 10K Road Race, the New England Forest Rally, the Kenduskeag Stream Canoe Race, the Can Am Crown International Sled Dog Race, the Loon Echo Bike Trek, the Mount Desert Island Marathon, Autism Awareness walks and races and the Northwoods Gravel Grind; and

Representative **GERE**: Thank you, Mr. Speaker. Mr. Speaker, I don't know whether you know any ham radio operators, but I've had the good fortune to know several.

Back in the good old days before the internet that some of us in the room remember, I was a Peace Corps volunteer in a small village in Liberia in West Africa with no electricity or communications infrastructure. And I learned through an airmail letter from my family that my grandpa was very ill. At the time, the only way that I could reach home was to ride 20 miles over dirt roads on my motorbike to a ham radio station that was operated by an Episcopal mission school in another small village in my area. And when I got there; I still remember the call sign, Echo-Lima-5-Sugar. And through that ham radio operator, who was able to reach someone in New York, who then reached an operator in Pittsburgh, who then called my parents, I was able to get information about what was happening. And without that ham radio operator, that contact would never have been made.

In addition, a friend and constituent whose family members were in the 2004 tsunami in Indonesia and for over three weeks, they could not be found through any normal communications channels, and I did not know whether they had survived that horrific event. My friend met a ham radio operator at the local library, and he was able to locate the family from the other side of the world through his ham radio colleagues in less than an hour.

Ham radio operators are a special type of person. The acronym for our group in the Kennebunks is, they call themselves N-E-R-D-S, or NERDS. They are fascinated by the technology and that's often how they get involved, and they spend their free time training on how to communicate around the world in disasters and other extreme events. And despite the fact that they are nerds, in fact, many of them, they then go on to build relationships one on one with people all around the world.

Two weeks ago, my community lost a member of our community who was the founder of that group, Mr. John Nowacki. He was one of those folks who spent his time training and working with new people who were interested in this very valuable technology, and his loss was very sudden and unexpected and he will be sorely missed. Thank you.
