Amend the bill by inserting after section 1 the following:

‘**Sec. 2. 17-A MRSA §1203, sub-§1-A, ¶A**, as enacted by PL 1999, c. 788, §4, is amended to read:

A. If the period of probation commences upon release of the person from the initial unsuspended portion of the term of imprisonment or during service of a sentence for which suspension of execution was vacated upon revocation, the court may revoke probation for any criminal conduct committed during that initial period of imprisonment.’

Amend the bill in section 4 in paragraph B in the first line (page 1, line 28 in L.D.) by inserting after the following: "imprisonment" the following: 'or during service of a sentence for which suspension of execution was vacated upon revocation'

Amend the bill in section 5 in paragraph C in the first line (page 1, line 31 in L.D.) by inserting after the following: "imprisonment" the following: 'or during service of a sentence for which suspension of execution was vacated upon revocation'

Amend the bill in section 6 in paragraph D in the first line (page 1, line 35 in L.D.) by inserting after the following: "imprisonment" the following: 'or during service of a sentence for which suspension of execution was vacated upon revocation'

Amend the bill by inserting after section 6 the following:

‘**Sec. 7. Appropriations and allocations.** The following appropriations and allocations are made.

SUMMARY

This amendment specifies that probation and supervised release may be revoked for misconduct occurring during a term of imprisonment served pursuant to any partial revocation of probation or supervised release. The bill authorizes revocation of probation and supervised release only for misconduct occurring during the initial term of imprisonment.
