Fiscal Detail and Notes

The bill lowers the estate tax exemption from \$5,000,000 to \$1,000,000 for deaths occurring on or after January 1, 2018 and reduces General Fund revenue by \$24,400,000 in fiscal year 2018-19. The bill includes General Fund appropriations of \$167,855 in fiscal year 2017-18 and \$297,675 in fiscal year 2018-19 to the Department of Administrative and Financial Services for 3 Senior Revenue Agent positions and related costs to audit and process estate tax returns.
