An Act to Establish the Winter Energy Relief Payment Program to Aid Residents with High Heating Costs and to Finalize the COVID Pandemic Relief Payment Program

Presented by Speaker TALBOT ROSS of Portland. Cosponsored by President JACKSON of Aroostook. 1 **Emergency preamble. Whereas,** acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, on March 13, 2020, the President of the United States declared a nationwide emergency pursuant to Section 501(b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act and, on April 4, 2020, the President of the United States approved a major disaster declaration for the State of Maine for periods beginning on January 20, 2020 and continuing; and

8 Whereas, on March 13, 2020, the President of the United States declared a national 9 emergency concerning the coronavirus disease 2019 (COVID-19) pandemic pursuant to 10 Sections 201 and 301 of the National Emergencies Act and, on February 18, 2022, the 11 President of the United States continued the national emergency pursuant to Section 202(d) 12 of the National Emergencies Act; and

Whereas, on January 31, 2020, the United States Secretary of Health and Human
 Services determined that a public health emergency exists and has existed since January
 27, 2020 nationwide and, on October 13, 2022, the United States Secretary of Health and
 Human Services renewed that determination; and

Whereas, Maine consumers are experiencing increased energy prices across all fuel
 types and experiencing volatility; and

Whereas, with nearly 60% of homes reliant on heating oil, Maine is the most heating oil dependent state in the country. Also, the New England electric grid, which supplies power to a majority of Maine, is over-reliant on natural gas to generate electricity. This makes Maine distinctly vulnerable to price increases; and

Whereas, residential energy prices have increased significantly throughout the pandemic and high winter energy prices will exacerbate the ongoing effects of the pandemic and pose a threat to Maine's recovery from the pandemic; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

PART A

- 30 Be it enacted by the People of the State of Maine as follows:
- 31

32 Sec. A-1. Transfer from General Fund unappropriated surplus; Housing Authority - State; supplement federal funding. Notwithstanding any provision of 33 law to the contrary, on or before June 30, 2023, the State Controller shall transfer 34 35 \$40,000,000 from the unappropriated surplus of the General Fund to the Maine State Housing Authority, Housing Authority - State, Other Special Revenue Funds account to 36 supplement federal Low Income Home Energy Assistance Program, or LIHEAP, funding. 37 38 Before October 31, 2023, any unobligated amounts remaining from this transfer must be 39 transferred to the unappropriated surplus of the General Fund.

40 Sec. A-2. Transfer from General Fund unappropriated surplus; Housing
 41 Authority - State; additional. Notwithstanding any provision of law to the contrary,
 42 on or before June 30, 2023, the State Controller shall transfer \$10,000,000 from the

unappropriated surplus of the General Fund to the Maine State Housing Authority, Housing 1 2 Authority - State, Other Special Revenue Funds account for assistance for households that are not eligible for federal Low Income Home Energy Assistance Program, or LIHEAP, 3 benefits or households eligible for LIHEAP benefits that have already exhausted their 4 energy assistance benefit and Maine State Housing Authority Energy Crisis Intervention 5 Program amount. Households may be eligible for up to \$800 in emergency funds to avert 6 an energy crisis. Before October 31, 2023, any unobligated amounts remaining from this 7 transfer must be transferred to the unappropriated surplus of the General Fund. 8

9 Transfer from General Fund unappropriated surplus; Sec. A-3. Emergency Housing Relief Fund. Notwithstanding any provision of law to the 10 contrary, on or before June 30, 2023, the State Controller shall transfer \$21,000,000 from 11 the unappropriated surplus of the General Fund to the Maine State Housing Authority, 12 Emergency Housing Relief Fund Program, Other Special Revenue Funds account to 13 14 provide funds for short-term emergency housing. The Maine State Housing Authority shall prioritize these funds for use in addressing emergency housing needs occurring between 15 December 1, 2022 and April 30, 2023, for those households that were experiencing 16 17 homelessness or housing instability in the State prior to December 1, 2022. At the close of 18 fiscal year 2022-23, unobligated amounts remaining from this transfer must be transferred 19 to the unappropriated surplus of the General Fund.

Sec. B-1. Winter Energy Relief Payment Program Fund Other Special Revenue Funds account established. The State Controller shall establish within the Department of Administrative and Financial Services the nonlapsing Winter Energy Relief Payment Program Fund Other Special Revenue Funds account, which is funded through a transfer from the available balance of the unappropriated surplus of the General Fund pursuant to section 2.

29 Sec. B-2. Transfer from General Fund unappropriated surplus; Winter 30 **Energy Relief Payment Program Fund.** Notwithstanding any provision of law to the contrary, on or before December 31, 2022, the State Controller shall transfer \$398,000,000 31 from the unappropriated surplus of the General Fund to the Department of Administrative 32 and Financial Services, Winter Energy Relief Payment Program Fund Other Special 33 34 Revenue Funds account for the purpose of providing payments to help eligible recipients of the State pay for high winter energy costs and recover from the economic effects of the 35 pandemic related to coronavirus disease 2019, referred to in this Part as "the COVID-19 36 pandemic." At the close of fiscal year 2023-24, amounts remaining in the Winter Energy 37 Relief Payment Program Fund Other Special Revenue Funds account must be transferred 38 to the unappropriated surplus of the General Fund. 39

40 **Sec. B-3. Winter Energy Relief Payment Program established.** Because the 41 State has determined that residents of the State face high winter energy costs and the effects 42 of the ongoing COVID-19 pandemic and this warrants assistance from the State, the Winter 43 Energy Relief Payment Program is established within the Department of Administrative 44 and Financial Services to promote the general welfare by providing a relief payment to

Sec. B-4. State income tax subtraction modification. For tax years beginning on or after January 1, 2023 but not later than December 31, 2023, in determining the taxable income of an individual, within the meaning of the Maine Revised Statutes, Title 36, section 5122, federal adjusted gross income must be reduced by an amount equal to the relief payment received by the taxpayer pursuant to this Part, to the extent the payment is included in federal adjusted gross income for the taxable year.

9 Sec. B-5. Designation as unclaimed property. For purposes of the Winter 10 Energy Relief Payment Program, relief payment checks that remain undeposited on March 11 31, 2024 are to be treated as unclaimed property, not subject to the notice and receipt 12 provisions established in the Maine Revised Statutes, Title 33, section 2101 and the one-13 year dormancy period specified in Title 33, section 2061, as applied to such checks. The 14 Treasurer of State shall use unclaimed property systems and networks to find the proper 15 recipients of such checks as quickly as possible.

Sec. B-6. Transfer between Winter Energy Relief Payment Program Fund 16 **Other Special Revenue Funds account and COVID Pandemic Relief Payment** 17 18 Program Fund Other Special Revenue Funds account. Notwithstanding any provision of law to the contrary, on or before June 30, 2024, the State Controller may 19 transfer the available balance within the Department of Administrative and Financial 20 21 Services, COVID Pandemic Relief Payment Program Fund Other Special Revenue Funds account to the Department of Administrative and Financial Services, Winter Energy Relief 22 23 Payment Program Fund Other Special Revenue Funds account. Amounts transferred may be expended based on allotment established by financial order recommended by the State 24 Budget Officer and approved by the Governor. 25

3 Part B establishes the Winter Energy Relief Payment Program and transfers funds on 4 a one-time basis totaling \$398,000,000 from the unappropriated surplus of the General 5 Fund to the newly created Winter Energy Relief Payment Program Fund Other Special Revenue Funds account no later than December 31, 2022 to fund the program. The 6 7 program provides relief payments of \$450 to individuals who filed a Maine income tax 8 return as of October 31, 2022 and who had income less than: \$200,000, if filing as an 9 individual filing a married joint return or a surviving spouse permitted to file a joint return; \$150,000, if filing as a head of household; or \$100,000, if filing as a single individual or as 10 a married individual filing a separate return. 11

12 The State Tax Assessor is required to identify eligible recipients and make relief 13 payments to those individuals no later than March 15, 2023. A process is specified to allow 14 individuals who are eligible but who have not received a relief payment to document 15 eligibility to the State Tax Assessor. The relief payment is not considered income for 16 Maine income tax purposes.

17 Part C transfers \$4,433,437 from the unappropriated surplus of the General Fund to the 18 COVID Pandemic Relief Payment Program no later than June 30, 2023. Part C also transfers \$385,754 from the COVID Disaster Relief Payment Fund Other Special Revenue 19 20 Funds account and \$6,674,993 from the Homestead Property Tax Exemption 21 Reimbursement, Other Special Revenue Funds account to the COVID Pandemic Relief 22 Payment Program. Part C provides the COVID Pandemic Relief Payment Program with an 23 Other Special Revenue Funds allocation of \$11,494,184 in fiscal year 2022-23 to complete 24 the \$850 pandemic relief payment to each eligible resident of the State as authorized in 25 Public Law 2021, chapter 635, Part L.

26 Part D includes General Fund deappropriations to the Department of Health and 27 Human Services of \$156,752,586 in fiscal year 2022-23 to adjust funding for the 6.2% 28 increase in the Federal Medical Assistance Percentage based on the extension of the 29 national public health emergency related to the COVID-19 pandemic for the first, 2nd and 30 3rd quarter of fiscal year 2022-23. This adjustment also deallocates \$4,154,555 from the Fund for a Healthy Maine in fiscal year 2022-23. The offsets for these deappropriations 31 32 and deallocations are Federal Expenditures Fund allocations of \$158,965,759 and Federal 33 Block Grant Fund allocations of \$1,941,382 in fiscal year 2022-23.

Part E allows the Commissioner of Environmental Protection to suspend the sulfur content requirements for liquid and solid fossil fuels if the commissioner finds that the expected availability of fuel that complies with those requirements is inadequate to meet the needs of residential, commercial or industrial users in this State and that such expected unavailability constitutes an immediate threat to public health, safety or the general welfare. The commissioner is required to specify in writing the period during which the suspension is in effect.

Part F requires the temporary suspension of the provision of law that requires certain
 General Fund revenue and resources that exceed the General Fund appropriation limit to
 be transferred to the Maine Budget Stabilization Fund.
