5 **Nursing Facilities 0148**

6 Initiative: Appropriates and allocates funding to reimburse nursing homes for the losses  
7 of coinsurance and deductibles for nondual Qualified Medicare Beneficiary program  
8 members in skilled nursing beds. This funding was removed under rules adopted by the  
9 Department of Health and Human Services as required in Public Law 2013, chapter 368.
