1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 24-A MRSA §2762, sub-§2**, as amended by PL 2015, c. 494, Pt. A, §28,
3 is further amended to read:

6 the purchase of a hearing aid for each hearing-impaired ear for an individual covered
7 under the policy or contract in accordance with the following requirements.

8 A. The hearing loss must be documented by a physician or audiologist licensed
9 pursuant to Title 32, chapter 137.

10 B. The hearing aid must be purchased from an audiologist or hearing aid dealer
11 licensed pursuant to Title 32, chapter 137.

12 C. The policy or contract may limit coverage to ~~\$1,400~~ \$3,000 per hearing aid for

9 **SUMMARY**

10 This bill requires insurance plans to provide coverage for hearing aids at a minimum
11 of \$3,000 per hearing aid to all individuals with documented hearing loss.
