1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 29-A MRSA §523, sub-§1**, as enacted by PL 1993, c. 683, Pt. A, §2 and
3 affected by Pt. B, §5, is amended to read:

4 **1. Amputee or blind veterans.** On application to the Secretary of State for
5 registration of any motor vehicle of any amputee or blind veteran who has received an
6 automobile from the United States Government under authority of 38 United States Code,
7 Sections 3901, et seq. or any amputee or blind veteran receiving compensation from the
8 Veterans Administration or any branch of the United States Armed Forces for service-
9 connected disability who has a specially designed motor vehicle, that veteran is entitled to
10 have that automobile duly registered and a registration certificate delivered to the veteran
11 without the requirement of the payment of any fee.

12 Any veteran who has lost both legs or the use of both legs and who has registered a motor
13 vehicle without the payment of a fee as provided in this section upon certification by the
14 Veterans Administration or appropriate branch of the United States Armed Forces must
15 be issued special designating plates for each vehicle owned by the veteran. Those
16 designating plates must be issued by the Secretary of State and must bear the words
17 "Disabled Veteran."

18 **Sec. 2. 29-A MRSA §523, sub-§2**, as amended by PL 2007, c. 383, §14, is
19 further amended to read:

20 **2. Disabled veterans; special free license plates.** The Secretary of State, on
21 application and upon evidence of payment of the excise tax required by Title 36, section
22 1482, shall issue to any 100% disabled veteran a registration certificate and set of special
23 designating plates to be used in lieu of regular registration plates for a each vehicle with a
24 registered gross weight of not more than 10,000 pounds ~~to any 100% disabled veteran~~
25 owned by the veteran when that application is accompanied by certification from the
26 United States Veterans Administration or any branch of the United States Armed Forces
27 as to the veteran's permanent disability and receipt of 100% service-connected benefits.
28 A disability placard is issued in addition to the disabled veteran registration plate at no
29 fee.

30 These special designating plates must bear the words "Disabled Veteran," which indicate
31 that the vehicle is owned by a disabled veteran.

32 **Sec. 3. 29-A MRSA §523, sub-§2-A**, as enacted by PL 1999, c. 734, §2, is
33 amended to read:

34 **2-A. Disabled veterans motorcycle license plates.** The Secretary of State shall
35 issue to any 100% disabled veteran a registration certificate and special designating plate
36 for a each motorcycle owned by the veteran to be used in lieu of a registration plate
37 issued in subsection 2 ~~to any 100% disabled veteran~~ if an applicant submits the following
38 together with an application:

39 A. Evidence of payment of the excise tax required by Title 36, section 1482; and
