1 Initiative: Provides funding for the approved arbitration decision that awarded retroactive
 2 range changes for 4 Forensic Chemist I positions and 2 Forensic Scientist positions from
 3 range 23 to range 25, the reclassification of one State Police Forensic Specialist position
 4 to a State Police Computer Forensic Examiner position and the reclassification of one
 5 State Police Sergeant position to a State Police Lieutenant position. The retroactive
 6 portion of the range changes will be covered by salary savings.
