1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 36 MRSA §4641, sub-§4 is enacted to read:
3 4	4. Primary residence. "Primary residence" has the same meaning as the term "homestead" as defined in section 681, subsection 2.

The rate of the tax is \$2.20 for each \$500 or fractional part of \$500 of the value of the property transferred, except that for transfers occurring on or after January 1, 2022 the rate of tax is \$1.50 for each \$500 or fractional part of \$500 of the first \$150,000 of value for a primary residence and \$2.50 for each \$500 or fractional part of \$500 of the value of a primary residence that exceeds \$150,000 of the value of a primary residence and for all other property.

The rate of the tax is \$2.20 for each \$500 or fractional part of \$500 of the value of the real property owned by the entity and located in this State, except that for transfers occurring on or after January 1, 2022, the rate of tax is \$1.50 for each \$500 or fractional part of \$500 of the first \$150,000 of value for property owned by the entity that is a primary residence and \$2.50 for each \$500 or fractional part of \$500 of the value of property owned by the entity that is a primary residence that exceeds \$150,000 of the value for a primary residence and for all other property owned by the entity.

23 24 25 26	This bill decreases the rate of the real estate transfer tax on the first \$150,000 of value of a primary residence to \$1.50 for each \$500 or fractional part of \$500 of the value and increases the tax rate on the value of a primary residence exceeding \$150,000 and on all other property to \$2.50 for each \$500 or fractional part of \$500 of the value.
