The appropriation must be distributed to the area agencies, based on priorities identified by local advisory councils to meet regional need through the intrastate funding formula to develop programs and deliver services necessar for the general well-being of older adults, including, but not limited to, in-home service case management services, meals programs, wellness services, respite for caregiver public education and outreach, volunteer services and information and referral services.
