1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 22 MRSA §2142, sub-§3**, as amended by PL 1993, c. 331, §1, is further
3 amended to read:

4 **3. Home health care provider.** "Home health care provider" means any business
5 entity or subdivision thereof, whether public or private, proprietary or not for profit, that is
6 engaged in providing acute, restorative, rehabilitative, maintenance, preventive or health
7 promotion services through professional nursing or another therapeutic service, such as
8 physical therapy, home health aides, nurse assistants, medical social work, nutritionist
9 services or personal care services, either directly or through contractual agreement, in a
10 client's place of residence. This term does not apply to any sole practitioner providing
11 private duty nursing services or other restorative, rehabilitative, maintenance, preventive
12 or health promotion services in a client's place of residence or to municipal entities
13 providing health promotion services in a client's place of residence. This term does not
14 apply to a federally qualified health center or a rural health clinic as defined in 42 United
15 States Code, Section 1395x, subsection (aa) (1993) that is delivering case management
16 services or health education in a client's place of residence. Beginning October 1, 1991,
17 "home health care provider" includes any business entity or subdivision thereof, whether
18 public or private, proprietary or nonprofit, that is engaged in providing speech pathology
19 services. "Home health care provider" does not include an emergency medical services
20 provider licensed under Title 32, chapter 2-B providing community paramedicine services
21 approved under Title 32, section 84, subsection 4.

22 **Sec. 2. 22 MRSA §2143**, as enacted by PL 1983, c. 570, is amended to read:

23 **§2143. License required**

24 Effective July 1, 1984, ~~no~~ a home health care provider may not provide home health
25 services without having, subject to this chapter and to the rules ~~promulgated~~ adopted by the
26 department under this chapter, a written license ~~therefor~~ to provide the services from the
27 department. This section does not apply to a provider providing community paramedicine
28 services approved under Title 32, section 84, subsection 4.

29 **SUMMARY**

30 This bill excepts from the definition of "home health care provider" a licensed
31 emergency medical services provider providing community paramedicine services
32 approved by the Emergency Medical Services' Board and exempts from Department of
33 Health and Human Services home health services licensing requirements a provider
34 providing approved community paramedicine services.
