Resolve, To Establish the Commission To Research the Economic Disparities of Racial and Ethnic Populations

9 Whereas, this legislation establishes the Commission To Research the Economic Disparities of Racial and Ethnic Populations; and 10 Whereas, the study must be initiated before the 90-day period expires in order that 11 the study may be completed and a report submitted in time for submission to the next 12 legislative session; and 13 Whereas, in the judgment of the Legislature, these facts create an emergency within 14 the meaning of the Constitution of Maine and require the following legislation as 15 immediately necessary for the preservation of the public peace, health and safety; now, 16 therefore, be it 17 18 Sec. 1. Commission established. Resolved: That the Commission To Research the Economic Disparities of Racial and Ethnic Populations in the State, referred 19 to in this resolve as "the commission," is established. 20 21 Sec. 2. Commission membership. Resolved: That, notwithstanding Joint Rule 353, the commission consists of the following 13 members: 22 1. Two members of the Senate appointed by the President of the Senate, including 23 members from each of the 2 parties holding the largest number of seats in the Legislature; 24 2. Four members of the House of Representatives appointed by the Speaker of the 25 House, including members from each of the 2 parties holding the largest number of seats 26 in the Legislature; 27 28 3. A representative of a community development organization appointed by the President of the Senate; 29 30 4. A representative of an economic policy organization appointed by the Speaker of the House; 31 5. The administrator of the Maine District Office of the federal Small Business 32 Administration, or the administrator's designee; 33 6. Two members of the public engaged in working with communities of color in 34 business development, one of whom is appointed by the President of the Senate and one 35

Whereas, Maine needs to perform research to determine which policy interventions

in the nation cannot be combated at the individual or household level, and that public

7. The president of the Maine State Chamber of Commerce, or the president's designee; and

- 8. The commission shall invite the participation, as a voting member, of a representative of the Native American community.
- **Sec. 3. Chairs. Resolved:** That the first-named Senate member is the Senate chair and the first-named House of Representatives member is the House chair of the commission.
- **Sec. 4. Appointments; convening of commission. Resolved:** That all appointments must be made no later than 30 days following the effective date of this resolve. The appointing authorities shall notify the Executive Director of the Legislative Council once all appointments have been completed. After appointment of all members, the chairs shall call and convene the first meeting of the commission. If 30 days or more after the effective date of this resolve a majority of but not all appointments have been made, the chairs may request authority and the Legislative Council may grant authority for the commission to meet and conduct its business.
- **Sec. 5. Duties. Resolved:** That the commission shall research income levels of and opportunities available to historically disadvantaged racial and ethnic populations in the State and shall examine quantitative and qualitative data associated with those populations regarding business ownership, household assets, debts and income, housing, employment and access to inherited wealth, capital and benefits. The commission shall consider proposals to diversify business ownership to include those populations and bridge the gaps in wealth acquisition, including, but not limited to, proposals to:
- 1. Develop a program to provide to aspiring and new business owners technical assistance workshops and training on topics such as the creation of business plans, accessing capital and funding and securing job training;
- 2. Provide assistance to vendors to become state-certified and to create a register and clearinghouse to serve as a resource for state-certified vendors seeking government contracts; and
- 3. Establish an office to coordinate the educational and technical assistance needs of emerging small businesses and to provide information to small businesses seeking to open, operate and expand their businesses.
- **Sec. 6. Staff assistance. Resolved:** That, notwithstanding Joint Rule 353, the Legislative Council shall provide necessary staffing services to the commission, except that Legislative Council staff support is not authorized when the Legislature is in regular or special session.
- **Sec. 7. Report. Resolved:** That, no later than December 4, 2019, the commission shall submit a report that includes its findings and recommendations, including suggested legislation, for presentation to the Second Regular Session of the 129th Legislature.

1 2	<b>Emergency clause.</b> In view of the emergency cited in the preamble, this legislation takes effect when approved.
