| 1 | Be it enacted by the People of the State of Maine as follows: |

| 2 | Sec. 1. 29-A MRSA §2401, sub-§12-A is enacted to read: |
| 3 | 12-A. Pet. "Pet" has the same meaning as in Title 7, section 3907, subsection 22-B. |
| 4 | Sec. 2. 29-A MRSA §2411-A is enacted to read: |
| 5 | §2411-A. Aggravated OUI resulting in death of pet |
| 6 7 8 | 1. Aggravated OUI resulting in death of pet. A person commits aggravated OUI resulting in the death of a pet if the person commits an offense under section 2411 subsection 1-A, paragraph A and, as a result of the offense, the person kills a pet. |
| 9 10 | 2. Penalties. Notwithstanding section 2411, subsection 5, a person who violates subsection 1 commits a Class C crime for which the following penalties apply: |
| 11 | A. A fine of not less than \$2,100 and not more than \$7,000; |
| 12 | B. A period of incarceration of not less than 6 months and not more than 2 years; |
| 13 | C. A court-ordered suspension of a driver's license for a period of 3 years; and |
| 14 | D. Mandatory community service related to animal welfare as determined by the court |
| 15 16 17 | 3. Restitution. In addition to any other penalty, the court shall order the defendant to provide restitution to the owner of the pet killed as a result of an offense under this section for: |
| 18 | A. Veterinary costs incurred as a result of the incident; |
| 19 | B. The market value of the pet; and |
| 20 21 | C. Emotional distress suffered by the owner of the pet in an amount not to exceed \$3,000. |

| 23 24 25 26 27 | This bill creates the offense of aggravated operating under the influence resulting in the death of a pet and provides that it is a Class C crime with a mandatory fine, a period of incarceration, a court-ordered suspension of a driver's license and mandatory community service related to animal welfare. The bill also requires the offender to provide restitution to the owner of the pet, including veterinary costs, the market value of the pet and a sum |
