**Resolve, To Study Motor Fuel and Fuel Additives and To Explore
Alternatives to Ethanol Motor Fuel**

1 **Sec. 1. Convene stakeholder group. Resolved:** That the Commissioner of
2 Environmental Protection, referred to in this resolve as "the commissioner," shall convene
3 a stakeholder group to conduct a study regarding motor fuel and fuel additives, including
4 but not limited to acetaldehyde in ethanol motor fuel. The commissioner, the
5 Commissioner of Transportation, the Commissioner of Economic and Community
6 Development and the chair of the Public Utilities Commission, or their designees, shall
7 serve as members of the stakeholder group, and the commissioner shall invite the
8 participation of interested persons and groups, including but not limited to consumer
9 protection groups, small businesses, motor vehicle dealers and owners of motor fuel
10 refueling stations; and be it further

11 **Sec. 2. Stakeholder group. Resolved:** That, in conducting the study under
12 section 1, the stakeholder group shall specifically:

13 1. Review the extent to which the State is in compliance with the federal Clean Air
14 Act Amendments of 1990 with respect to the emissions of acetaldehyde produced by the
15 combustion of ethanol motor fuel;

16 2. Examine whether an increase from 10% ethanol to 15% ethanol in gasoline blends
17 will increase the level of acetaldehyde emissions and decrease the State's ability to
18 comply with the federal Clean Air Act Amendments of 1990;

19 3. Conduct a comprehensive review of the statewide costs associated with
20 acetaldehyde in ethanol motor fuel, including but not limited to the corrosive effects of
21 acetaldehyde on small engines, the effects of acetaldehyde on marine resources in the
22 State and the negative impact such effects have on business in the State;

23 4. Examine the impact of federal subsidies for corn used to produce ethanol on the
24 cost of food locally and globally;

25 5. Compare the net energy value of corn-derived ethanol to that of ethanol derived
26 from other products, such as other grains or algae;

27 6. Explore alternatives to ethanol motor fuel, including but not limited to biofuels
28 developed from wood pulp; and

29 7. Develop a plan to reduce the supply of ethanol motor fuel in the State; and be it
30 further

31 **Sec. 3. Reporting date established; legislation. Resolved:** That the
32 commissioner shall report the stakeholder group's findings and recommendations,
33 including proposed implementing legislation, regarding the study required by section 1 to
34 the Joint Standing Committee on Environment and Natural Resources by December 1,
35 2011. The committee may report out a bill relating to those recommendations to the
36 Second Regular Session of the 125th Legislature.

SUMMARY

2 This resolve requires the Commissioner of Environmental Protection to convene a
3 stakeholder group to conduct a study regarding motor fuel and fuel additives, including
4 but not limited to acetaldehyde in ethanol motor fuel. The stakeholder group is directed
5 to study the State's compliance with the federal Clean Air Act Amendments of 1990 with
6 respect to emissions of acetaldehyde produced by the combustion of ethanol gasoline, and
7 conduct a comprehensive review of the statewide costs associated with the acetaldehyde
8 in ethanol motor fuel, including the corrosive effects of acetaldehyde on small engines,
9 the effects of acetaldehyde on marine resources in the State and the negative impact such
10 effects have on business in the State. The commissioner shall report the stakeholder
11 group's findings to the Joint Standing Committee on Environment and Natural Resources
12 by December 1, 2011. The committee may report out a bill to the Second Regular
13 Session of the 125th Legislature.
