1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 22 MRSA §8302-A, sub-§1, ¶I**, as amended by PL 2015, c. 497, §2, is
3 further amended to read:

4 I. Licensing procedures; ~~and~~

5 **Sec. 2. 22 MRSA §8302-A, sub-§1, ¶J**, as enacted by PL 2015, c. 497, §2, is
6 amended to read:

7 J. Requiring a criminal background check for:

8 (1) Each child care staff member whose activities involve the care or supervision
9 of children; and

10 (2) Each adult who has unsupervised access to children who are cared for or
11 supervised by a child care facility.

12 The criminal background check must meet the requirements of 42 United States
13 Code, Section 9858f(b);

14 **Sec. 3. 22 MRSA §8302-A, sub-§1, ¶¶K and L** are enacted to read:

15 K. The provision of nutritious foods that contribute to the wellness, healthy growth
16 and development of young children. Rules adopted under this paragraph must meet
17 standards established under the United States Department of Agriculture, Food and
18 Nutrition Service, Child and Adult Care Food Program; and

19 L. Physical activity and recreational screen time. Rules adopted under this paragraph
20 must establish standards for evidence-based and age-appropriate physical activity and
21 recreational screen time. For the purpose of this paragraph, "screen time" means
22 sedentary activities done in front of a screen, such as watching television, working on
23 a computer and playing video games.

24 **Sec. 4. 22 MRSA §8302-A, sub-§2**, as amended by PL 2015, c. 497, §3, is
25 further amended to read:

26 **2. Rules for family child care providers.** Rules for family child care providers
27 must include, and are limited to, rules pertaining to the following:

28 A. Cardiopulmonary resuscitation;

29 B. Water for drinking and cooking;

30 C. Wastewater;

31 D. Rabies vaccinations for pets;

32 E. Recording the times, reasons and numbers of children involved when more than
33 12 children are cared for;

34 F. Ongoing training for providers on health and safety issues, including training on
35 communicable diseases. This training must be offered at times that are convenient to
36 the providers;

- 1 G. Child to staff ratios;
- 2 H. Health and safety of the children and staff;
- 3 I. Procedures for waivers of rules and for suspension and revocation of certification;
- 4 J. The age, criminal record and personal history of the family child care provider,
- 5 staff and members of the household; ~~and~~
- 6 K. Requiring a criminal background check for:
 - 7 (1) The family child care provider;
 - 8 (2) Each child care staff member whose activities involve the care or supervision
 - 9 of children; and
 - 10 (3) Each adult who has unsupervised access to children who are cared for or
 - 11 supervised by the family child care provider.

23 Rules adopted pursuant to paragraphs A to F and L and M are routine technical rules
24 pursuant to Title 5, chapter 375, subchapter 2-A and rules adopted pursuant to paragraphs
25 G to K are major substantive rules pursuant to Title 5, chapter 375, subchapter 2-A.

26 **SUMMARY**

27 This bill provides that rules adopted by the Department of Health and Human
28 Services for child care facilities and family child care providers must include rules
29 pertaining to physical activity and recreational screen time and the provision of nutritious
30 foods that contribute to the wellness, healthy growth and development of young children.
