An Act to Require Remittance Fees for Money Transmissions

2	Sec. 1. 32 MRSA §6100-L, sub-§3 is enacted to read:
3 4 5	3. Fee for money transmission. A licensee or authorized delegate shall collect a fee of \$5 for each money transmission up to \$500 and an additional fee in an amount equal to 3% of any amount in excess of \$500.
6 7 8	A. The licensee or authorized delegate shall remit all fees collected under this subsection on a form prescribed by the administrator to the administrator quarterly no later than the 15th day of the month following the end of each calendar quarter.
9 10 11 12	B. If the licensee or authorized delegate performs the duties under paragraph A on or before the remittance date under paragraph A, the licensee or authorized delegate is entitled to a discount in the amount equal to 0.75% of the fees collected for that calendar quarter under this subsection.
13 14	C. Notwithstanding section 6100-JJ, the administrator shall remit all fees collected under this subsection to the Treasurer of State to be deposited in the General Fund.

The sender of a money transmission is entitled to a state income tax credit equal to the amount of the fee paid by the sender for the money transmission upon filing a state individual income tax return with either a valid social security number or a valid tax identification number. The licensee or authorized delegate shall post the provisions of this paragraph in a publicly visible notice on the licensee's or authorized delegate's premises or on the licensee's or authorized delegate's publicly accessible website.

If a licensee or authorized delegate violates this subsection, the administrator may suspend or revoke the license of the licensee pursuant to section 6100-X and may suspend or revoke the designation of an authorized delegate pursuant to section 6100-Y until the licensee and the authorized delegate have filed all required forms and remitted to the administrator all fees collected under this subsection.

12 13 14 15	This bill requires a sender of a money transmission to pay a remittance fee to be deposited into the General Fund. The sender is entitled to a state income tax credit in the amount of the fee if the sender files a state individual income tax return with either a valid social security number or a valid tax identification number.
