An Act to Allow Sunday Hunting with a Bow and Arrow or Crossbow

Be it enacted by the People of the State of Maine as follows:

- **Sec. 1. 12 MRSA §10206, sub-§12** is enacted to read:
- 12. Sunday hunting permit revenues. One-third of all revenues derived from the sale of Sunday hunting permits under section 11164, subsection 3 must be deposited into a special nonlapsing account within the department, and that account must be used to fund youth hunter education and experiential programs.
- **Sec. 2. 12 MRSA §10501, sub-§9,** as amended by PL 2003, c. 511, §1 and affected by §3 and c. 614, §§9 and 10, is further amended to read:
- **9. Possession of hunting equipment on Sunday.** Possession of hunting equipment in the fields or forests or on the waters or ice in the State on Sunday is prima facie evidence of a violation of section 11205, unless:
 - A. The hunting equipment is carried, securely wrapped, in a complete cover;
 - B. The hunting equipment is fastened in a case; or
 - C. The hunting equipment is carried in at least 2 separate pieces in such a manner that it ean not cannot be fired, unless the separate pieces are joined together. For the purpose of this subsection, a clip, magazine or cylinder of a firearm may not be considered a piece of the hunting equipment. Bows and arrows must be kept in a case or cover if broadheads or field points are kept attached to the arrows-; or
- D. The hunting equipment is a hand-held bow and arrow or crossbow and the person in possession is hunting pursuant to section 11164.

Sec. 3. 12 MRSA §11164 is enacted to read:

§11164. Sunday hunting permit; penalty

- 1. Permit required. Except as otherwise authorized pursuant to this Part, a person may not hunt on a Sunday without a valid permit under this section. Each day that a person violates this subsection, that person commits a Class E crime for which a minimum fine of \$50 and an amount equal to twice the applicable license fee must be imposed.
- 2. Eligibility; archery license required. A person who possesses a valid archery hunting license may obtain from the commissioner or an authorized agent a permit to hunt with a hand-held bow and arrow or, if the person holds a valid crossbow permit, a crossbow on a Sunday.
- 3. Issuance; permit fee. The commissioner, through the commissioner's authorized agent, shall issue a Sunday hunting permit to an eligible person. The annual fee for each permit issued is \$31, \$10 of which must be deposited into the Land for Maine's Future Fund, \$10 of which must be provided to the department for the benefit of the Bureau of Warden Service, \$10 of which must be provided to the department for the benefit of youth hunter education and experiential programs as provided in section 10206, subsection 12 and \$1 of which must be retained by the commissioner's authorized agent.
- 4. Rules. The commissioner may adopt rules necessary for the proper administration, enforcement and implementation of this section. Rules adopted pursuant to this subsection are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.

9	This bill allows a person who has an archery license to purchase a Sunday hunting

This bill allows a person who has an archery license to purchase a Sunday hunting permit for \$31 to hunt with a bow and arrow or, if the person has a valid crossbow permit, a crossbow. This bill distributes the revenue from the sale of the Sunday hunting permit to benefit the Land for Maine's Future Fund and the Department of Inland Fisheries and Wildlife, Bureau of Warden Service and for the support of youth hunter education and experiential programs. The bill also amends the laws to allow a person to be in possession of a bow and arrow or crossbow on a Sunday if that person possesses a valid Sunday hunting permit.
