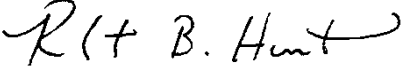

### An Act To Establish a Comprehensive Hunting License

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 12 MRSA §10260**, as enacted by PL 2007, c. 168, §1 and affected by §8,  
3 is amended to read:

4 **§10260. Black Bear Research Fund**

5 The Black Bear Research Fund, referred to in this section as "the fund," is established  
6 within the department as a nonlapsing fund to be used by the commissioner to fund or  
7 assist in funding studies related to the management of black bears. Revenue from the  
8 ~~nonresident late season bear hunting permit under section 11151-A and the bear trapping~~  
9 permit under section 12260-A must be deposited in the fund. The commissioner may  
10 accept and deposit into the fund monetary gifts, donations or other contributions from  
11 public or private sources for the purposes specified in this section. The fund must be held  
12 separate and apart from all other money, funds and accounts.

13 **Sec. 2. 12 MRSA §10851**, as corrected by RR 2013, c. 2, §20, is amended to read:

14 **§10851. Lifetime licenses**

15 **1. Infants, youth and seniors.** The following lifetime licenses may be purchased:

16 A. For a person who is less than 6 years of age:

17 (1) An infant lifetime fishing license. The fee for an infant lifetime fishing  
18 license is \$150 for a resident and \$450 for a nonresident, except that, from  
19 December 1, 2011 until March 1, 2015, the fee for a nonresident is \$200;

20 (2) An infant lifetime hunting license. The fee for an infant lifetime hunting  
21 license is \$150 for a resident and \$450 for a nonresident, except that, from  
22 December 1, 2011 until March 1, 2015, the fee for a nonresident is \$200;

23 (3) An infant lifetime archery hunting license. The fee for an infant lifetime  
24 archery hunting license is \$150 for a resident and \$450 for a nonresident, except  
25 that, from December 1, 2011 until March 1, 2015, the fee for a nonresident is  
26 \$200. Beginning January 1, 2016, the department may not issue an infant lifetime  
27 archery hunting license. An infant lifetime archery hunting license issued prior  
28 to January 1, 2016 is valid and provides the same hunting privileges as a lifetime  
29 infant hunting license;

30 (3-A) An infant lifetime trapping license. The fee for an infant lifetime trapping  
31 license is \$150 for a resident and \$450 for a nonresident, except that, from  
32 December 1, 2011 until March 1, 2015, the fee for a nonresident is \$200;

33 (4) An infant combination of any 2 lifetime licenses. The fee for an infant  
34 combination of any 2 lifetime licenses is \$250 for a resident and \$750 for a  
35 nonresident, except that, from December 1, 2011 until March 1, 2015, the fee for  
36 a nonresident is \$425; and

37 (5) An infant combination of ~~any~~ 3 lifetime licenses. The fee for an infant  
38 combination of ~~any~~ 3 lifetime licenses is \$400 for a resident and \$1,200 for a

1 nonresident, except that, from December 1, 2011 until March 1, 2015, the fee for  
2 a nonresident is \$660;

3 B. For a person from 6 to 15 years of age:

4 (1) A junior lifetime fishing license. The fee for a junior lifetime fishing license  
5 is \$300 for a resident and \$900 for a nonresident;

6 (2) A junior lifetime hunting license. The fee for a junior lifetime hunting  
7 license is \$300 for a resident and \$900 for a nonresident;

8 (3) A junior lifetime archery hunting license. The fee for a junior lifetime  
9 archery hunting license is \$300 for a resident and \$900 for a nonresident.  
10 Beginning January 1, 2016, the department may not issue a junior lifetime  
11 archery hunting license. A junior lifetime archery hunting license issued prior to  
12 January 1, 2016 is valid and provides the same hunting privileges as a lifetime  
13 junior hunting license;

14 (3-A) A junior lifetime trapping license. The fee for a junior lifetime trapping  
15 license is \$300 for a resident and \$900 for a nonresident;

16 (4) A junior combination of any 2 lifetime licenses. The fee for a junior  
17 combination of any 2 lifetime licenses is \$500 for a resident and \$1,500 for a  
18 nonresident; and

19 (5) A junior combination of ~~any~~ 3 lifetime licenses. The fee for a junior  
20 combination of ~~any~~ 3 lifetime licenses is \$800 for a resident and \$2,400 for a  
21 nonresident;

22 C. For a resident from 65 to 69 years of age:

23 (1) A senior resident lifetime fishing license. The fee for a senior resident  
24 lifetime fishing license is \$50 for a person who purchases the license in the year  
25 in which that person turns 65 years of age, \$40 for a person who purchases the  
26 license in the year in which that person turns 66 years of age, \$30 for a person  
27 who purchases the license in the year in which that person turns 67 years of age,  
28 \$20 for a person who purchases the license in the year in which that person turns  
29 68 years of age and \$10 for a person who purchases the license in the year in  
30 which that person turns 69 years of age;

31 (2) A senior resident lifetime hunting license. The fee for a senior resident  
32 lifetime hunting license is \$50 for a person who purchases the license in the year  
33 in which that person turns 65 years of age, \$40 for a person who purchases the  
34 license in the year in which that person turns 66 years of age, \$30 for a person  
35 who purchases the license in the year in which that person turns 67 years of age,  
36 \$20 for a person who purchases the license in the year in which that person turns  
37 68 years of age and \$10 for a person who purchases the license in the year in  
38 which that person turns 69 years of age;

39 (3) A senior resident lifetime archery hunting license. The fee for a senior  
40 resident lifetime archery hunting license is \$50 for a person who purchases the  
41 license in the year in which that person turns 65 years of age, \$40 for a person  
42 who purchases the license in the year in which that person turns 66 years of age,

1 \$30 for a person who purchases the license in the year in which that person turns  
2 67 years of age, \$20 for a person who purchases the license in the year in which  
3 that person turns 68 years of age and \$10 for a person who purchases the license  
4 in the year in which that person turns 69 years of age. Beginning January 1,  
5 2016, the department may not issue a senior resident lifetime archery hunting  
6 license. A senior resident lifetime archery hunting license issued prior to January  
7 1, 2016 is valid and provides the same hunting privileges as a lifetime senior  
8 resident hunting license;

9 (3-A) A senior resident lifetime trapping license. The fee for a senior resident  
10 lifetime trapping license is \$50 for a person who purchases the license in the year  
11 in which that person turns 65 years of age, \$40 for a person who purchases the  
12 license in the year in which that person turns 66 years of age, \$30 for a person  
13 who purchases the license in the year in which that person turns 67 years of age,  
14 \$20 for a person who purchases the license in the year in which that person turns  
15 68 years of age and \$10 for a person who purchases the license in the year in  
16 which that person turns 69 years of age;

17 (4) A senior resident combination of any 2 lifetime licenses. The fee for a senior  
18 resident combination of any 2 lifetime licenses is \$80 for a person who purchases  
19 the license in the year in which that person turns 65 years of age, \$64 for a person  
20 who purchases the license in the year in which that person turns 66 years of age,  
21 \$48 for a person who purchases the license in the year in which that person turns  
22 67 years of age, \$32 for a person who purchases the license in the year in which  
23 that person turns 68 years of age and \$16 for a person who purchases the license  
24 in the year in which that person turns 69 years of age; and

25 (5) A senior resident combination of ~~any~~ 3 lifetime licenses. The fee for a senior  
26 resident combination of ~~any~~ 3 lifetime licenses is \$110 for a person who  
27 purchases the license in the year in which that person turns 65 years of age, \$94  
28 for a person who purchases the license in the year in which that person turns 66  
29 years of age, \$78 for a person who purchases the license in the year in which that  
30 person turns 67 years of age, \$52 for a person who purchases the license in the  
31 year in which that person turns 68 years of age and \$26 for a person who  
32 purchases the license in the year in which that person turns 69 years of age; and

33 D. For a resident 70 years of age or older. For a person who holds a valid senior  
34 lifetime license under this section at any time during the calendar year that person  
35 turns 70 years of age, that lifetime license includes all hunting permits and licenses  
36 authorized in this Part and may renew at no cost a guide license under section 12853.  
37 A person who is 70 years of age or older may purchase a senior lifetime license that  
38 entitles the holder to all the privileges described in this paragraph for a one-time \$8  
39 fee.

40 A person must be a resident to purchase a senior resident lifetime license under  
41 subsection 1, paragraphs C and D. Once purchased, a lifetime license is valid for the life  
42 of the holder without regard to subsequent changes in the legal residence of the holder.  
43 The license entitles the holder to all fishing or hunting privileges extended to residents or  
44 nonresidents as applicable of that same age who hold the equivalent annual license and  
45 subjects the holder to all limitations and prerequisites on those fishing or hunting

1 privileges that apply to residents or nonresidents of that same age who hold the equivalent  
2 annual license.

3 **Sec. 3. 12 MRSA §10853, sub-§1**, as enacted by PL 2003, c. 414, Pt. A, §2 and  
4 affected by c. 614, §9, is amended to read:

5 **1. Residents over 70 years of age.** A complimentary license to hunt, trap or fish,  
6 including ~~an archery license under section 11109, subsection 7,~~ a pheasant hunting permit  
7 under section 11156, ~~a muzzle loading hunting license under section 11109, subsection 4,~~  
8 and a migratory waterfowl permit under section 11157 ~~and a bear hunting permit under~~  
9 ~~section 11154,~~ must be issued to a resident who is 70 years of age or older upon  
10 application to the commissioner.

11 A. A resident who applies for a complimentary license under this section at any  
12 time during the calendar year of that resident's 70th birthday must be issued a license  
13 upon application, regardless of the actual date during that calendar year in which that  
14 resident attains 70 years of age. A guide license may be renewed without charge for  
15 a resident who is 70 years of age or older upon application to the commissioner. The  
16 application must be accompanied by a birth certificate or other certified evidence of  
17 the applicant's date of birth and residency.

18 B. Beginning January 1, 2006, the department may not issue a complimentary  
19 license to a resident over 70 years of age. A complimentary license issued to a  
20 resident over 70 years of age prior to January 1, 2006 is valid as long as the license  
21 holder satisfies the residency requirements set out in section 10001, subsection 53.

22 C. A complimentary license issued under this subsection remains valid for the  
23 remainder of the life of the license holder, as long as the license holder continues to  
24 satisfy the residency requirements set out in section 10001, subsection 53 and the  
25 license is not revoked or suspended.

26 **Sec. 4. 12 MRSA §10853, sub-§8**, as amended by PL 2013, c. 136, §1, is further  
27 amended to read:

28 **8. Members of federally recognized nation, band or tribe.** The commissioner  
29 shall issue a hunting, trapping and fishing license, including ~~an archery hunting license~~  
30 ~~under this chapter, and including~~ permits, stamps and other permission needed to hunt,  
31 trap and fish, to a person, 10 years of age or older, who is an enrolled member of the  
32 Passamaquoddy Tribe, the Penobscot Nation, the Houlton Band of Maliseet Indians or the  
33 Aroostook Band of Micmacs that is valid for the life of that person without any charge or  
34 fee pursuant to section 11109, if the person presents certification from the respective  
35 reservation governor or the Aroostook Micmac Council stating that the person described  
36 is an enrolled member of a federally recognized nation, band or tribe listed in this  
37 subsection. Holders of these licenses are subject to this Part, including, but not limited to,  
38 a lottery or drawing system for issuing a particular license or permit. Members of a  
39 federally recognized nation, band or tribe listed in this subsection are exempt from the  
40 trapper evaluation program required for a license under section 12201 and the archery  
41 hunter education course under section 11106.

1           **Sec. 5. 12 MRSA §10902, sub-§7**, as affected by PL 2003, c. 614, §9 and  
2 amended by PL 2003, c. 655, Pt. B, §100 and affected by §422, is further amended to  
3 read:

4           **7. Mandatory hunting license revocation; coyote hunting violation.** A hunting  
5 license of a person convicted of hunting coyote in violation of section ~~11160~~ or 12001  
6 must be revoked and that person is ineligible to obtain any hunting license for a period of  
7 one year from the date of conviction.

8           **Sec. 6. 12 MRSA §11106**, as amended by PL 2013, c. 588, Pt. A, §12, is further  
9 amended to read:

10           **§11106. Archery hunting; requirements**

11           **1. Age requirement.** A person is eligible to ~~obtain an archery hunting license~~ hunt  
12 with bow and arrow as provided in this section.

13           A. A resident or nonresident 16 years of age or older who has satisfied the  
14 requirements of subsection 2 or holds ~~an~~ a valid apprenticeship hunter license, or who  
15 is exempt under subsection 3, may ~~obtain an archery hunting license to~~ hunt with bow  
16 and arrow ~~from the commissioner or the commissioner's authorized agent.~~

17           B. A resident or nonresident 10 years of age or older and under 16 years of age may  
18 hunt with bow and arrow if that person holds a valid junior hunting license.

19           **2. Archery hunter education requirements.** Except as provided in paragraph A  
20 and subsection 3, a person who applies for ~~an archery~~ a hunting license other than a  
21 junior hunting license or ~~an~~ a valid apprenticeship hunter license and wishes to hunt with  
22 bow and arrow must submit proof of having successfully completed an archery hunter  
23 education course as described in section 10108 or an equivalent archery hunter education  
24 course or satisfactory evidence of having previously held a valid adult ~~archery~~ hunting  
25 license ~~issued specifically for the purpose of hunting that specified the holder was~~  
26 authorized to hunt with bow and arrow in this State or any other state, province or

28           When proof or evidence cannot be otherwise provided, the applicant may substitute a  
29 signed affidavit that the applicant has previously held the required adult ~~archery~~ hunting  
30 license that specified the holder was authorized to hunt with bow and arrow or has  
31 successfully completed the required archery hunter education course.

32           A. A person who is an enrolled member of the Passamaquoddy Tribe, the Penobscot  
33 Nation, the Houlton Band of Maliseet Indians or the Aroostook Band of Micmacs  
34 who presents certification from the respective reservation governor or the Aroostook  
35 Micmac Council stating that the person is an enrolled member of a federally  
36 recognized nation, band or tribe listed in this paragraph is exempt from the  
37 requirements of this subsection.

38           **3. Archery hunter education course exemption for members of armed forces**  
39 **domiciled in State.** A member of the Armed Forces of the United States on active duty  
40 who is permanently stationed outside of the United States and home on leave is exempt  
41 from archery hunter education course requirements under subsection 2 if that member

1 shows proof at the time of application for the hunting license that that member's home  
2 state of record, as recorded in that person's military service records, is Maine. A person  
3 who no longer meets the conditions for an exemption under this subsection must satisfy  
4 the requirements of subsection 2.

5 **Sec. 7. 12 MRSA §11106-A**, as amended by PL 2013, c. 588, Pt. A, §13, is  
6 further amended to read:

7 **§11106-A. Crossbow hunting; requirements**

8 **1. Hunting license.** A resident or nonresident 16 years of age or older who has  
9 satisfied the requirements of subsection 3 or who is exempt under subsection 4 and who  
10 holds a valid ~~big game~~ hunting license or an apprenticeship hunter license may ~~obtain a~~  
11 ~~crossbow license to hunt with a crossbow from the commissioner or the commissioner's~~  
12 ~~authorized agent.~~

13 **2. Junior license.** A resident or nonresident 10 years of age or older and under 16  
14 years of age may hunt with a crossbow if that person holds a valid junior hunting license.

15 **3. Crossbow hunter education requirements.** Except as provided in paragraph A,  
16 a person who applies for a ~~crossbow~~ hunting license other than a junior hunting license or  
17 an apprenticeship hunter license who wishes to hunt with a crossbow must submit proof  
18 of having successfully completed an archery hunting education course and a crossbow  
19 hunting course as described in section 10108 or equivalent crossbow and archery hunting  
20 education courses or satisfactory evidence of having previously held ~~valid adult archery~~

24 When proof or evidence cannot be otherwise provided, the applicant may substitute a  
25 signed affidavit that the applicant has previously held the required adult ~~crossbow and~~  
26 ~~archery~~ hunting license or licenses that specified the holder was authorized to hunt with  
27 bow and arrow and crossbow or has successfully completed the required crossbow and  
28 archery hunting education courses.

29 A. A person who is an enrolled member of the Passamaquoddy Tribe, the Penobscot  
30 Nation, the Houlton Band of Maliseet Indians or the Aroostook Band of Micmacs  
31 who presents certification from the respective reservation governor or the Aroostook  
32 Micmac Council stating that the person is an enrolled member of a federally

3           **§11107. Muzzle-loader hunting; requirements**

4           A person who holds a valid hunting license, a valid junior hunting license or a valid  
5 apprentice hunting license may hunt with a muzzle-loader.

6           **Sec. 9. 12 MRSA §11108, sub-§1**, as amended by PL 2005, c. 419, §4 and  
7 affected by §12, is further amended to read:

8           **1. On certain land.** Notwithstanding section 11109, subsection 1 as it applies to this  
9 subchapter, a resident over 10 years of age and a member of the resident's immediate  
10 family over 10 years of age, as long as the hunter's license to hunt is not under suspension  
11 or revocation, may hunt without a license, ~~including, but not limited to, an archery~~  
12 ~~hunting license, a crossbow hunting license and a muzzle-loading license,~~ on a single plot  
13 of land:

- 14           A. To which they are legally entitled to possession;
- 15           B. On which they are actually domiciled;
- 16           C. That is used exclusively for agricultural purposes; and
- 17           D. That is in excess of 10 acres.

20           **§11109. Licenses and fees**

21           **1. License required.** Except as otherwise authorized pursuant to this Part, a person  
22 may not engage in an activity for which a license may be issued under this section unless  
23 that person has a valid license issued under this section. Each day a person violates this  
24 subsection that person commits a Class E crime for which a minimum fine of \$50 and an  
25 amount equal to twice the applicable license fee must be imposed.

26           **2. Hunting licenses; agent's fee.** Clerks or other agents appointed by the  
27 commissioner to issue licenses and permits shall charge a fee of \$2 for each hunting  
28 license issued. The commissioner shall charge a fee of \$1 for each hunting license issued  
29 by department employees.

30           **3. Hunting licenses; combination licenses; fees.** Hunting licenses, combination  
31 licenses and fees are as follows.

- 32           A. A resident junior hunting license, for a person 10 years of age or older and under

20 ~~9. Crossbow licenses and fees.~~ Crossbow hunting licenses and fees are as follows:

## 21 SUMMARY

22 This bill expands the current resident hunting license and nonresident hunting license  
23 to encompass and replace all other hunting licenses and hunting permits except the:

- 24 1. Junior hunting license;
- 25 2. Resident and nonresident apprentice hunting licenses;
- 26 3. Antlerless deer and special deer season permits;
- 27 4. Moose permit;
- 28 5. Pheasant permit;
- 29 6. Waterfowl permit;
- 30 7. Falconry permit; and
- 31 8. Migratory bird permit.

32 It increases the fee for a resident and a nonresident hunting license from \$25 to \$38  
33 and from \$114 to \$143, respectively. This bill also increases the fee on resident and

1 nonresident hunting and fishing combination licenses from \$42 to \$55 and from \$149 to  
2 \$178, respectively, to reflect the increase in the hunting license fee.

3 This bill also provides that infant, junior and senior resident archery lifetime hunting  
4 licenses purchased prior to January 1, 2016 remain valid and provide the same hunting  
5 opportunities as the expanded infant, junior and senior resident lifetime hunting licenses.

6 It maintains the current firearm, bow and arrow and crossbow hunter education  
7 requirements.
