- 1 **Emergency preamble.** Whereas, acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and 3 Whereas, this legislation allows a municipality to authorize the use of a siren in a 4 motor vehicle operated by a harbor master or deputy harbor master when responding to an 5 emergency call; and 6 Whereas, it is imperative that this legislation take effect before the start of the boating 7 season; and 8 Whereas, in the judgment of the Legislature, these facts create an emergency within 9 the meaning of the Constitution of Maine and require the following legislation as 10 immediately necessary for the preservation of the public peace, health and safety; now, 11 therefore, 12 Be it enacted by the People of the State of Maine as follows: 13 Sec. 1. 29-A MRSA §2054, sub-§2, ¶F, as amended by PL 2023, c. 131, §1, is further amended by amending subparagraph (5) to read: 14 15 (5) A municipality may authorize a harbor master or deputy harbor master appointed under Title 38, section 1 or 2, respectively, to use one red or combination 16 red and white flashing auxiliary light mounted in the windshield or on the 17 dashboard at the front of a vehicle or 2 flashing red or combination red and white 18 auxiliary lights mounted on the front of the vehicle above the front bumper and 19 below the hood and one red auxiliary light mounted in the rear window area. The 20 21 light or lights may be displayed but may be used only while the harbor master or 22 deputy harbor master is responding to a watercraft emergency. A light mounted on the dashboard or in the windshield must be shielded so that the emitted light 23 24 does not interfere with the operator's vision. Notwithstanding subsection 3, a 25 municipality may also authorize the use of a siren in a motor vehicle operated by the harbor master or deputy harbor master when responding to a watercraft 26 27 emergency. The authorization for the use of lights or a siren may be revoked at any 28 time by the municipality. 29 **Emergency clause.** In view of the emergency cited in the preamble, this legislation takes effect when approved. 30 **SUMMARY** 31 32 This bill allows a municipality to authorize the use of a siren in a motor vehicle 33 operated by a harbor master or deputy harbor master when responding to an emergency call.
