1	Be it enacted by the People of the State of Maine as follows:

3	§2015. Undetectable firearms prohibited
4 5 6	<u>1.</u> Undetectable firearm defined. As used in this section, "undetectable firearm" means a firearm that can operate while in a form that is not detectable as a security exemplar, as defined in 18 United States Code, Section 922(p)(2)(C).
7 8 9 10	2. Penalty for manufacture, import, sale or transfer of undetectable firearm. A person that manufactures or causes to be manufactured within this State, that imports into this State or that offers, exposes for sale, sells or transfers an undetectable firearm commits a Class C crime.
11 12	3. Penalty for possession of undetectable firearm. A person who knowingly possesses an undetectable firearm commits a Class D crime.
13 14 15 16	<u>4. Penalty for possession of undetectable firearm in courthouse.</u> A person who knowingly possesses an undetectable firearm in a courthouse or who possesses an undetectable firearm with the intent to bring that firearm into a courthouse commits a Class C crime.
17	§2016. Untraceable firearms prohibited
18 19	<u>1. Definitions.</u> As used in this section, unless the context otherwise indicates, the following terms have the following meanings.
20 21 22	A. "Additive manufacturing" means a manufacturing process in which material is added in order to produce a product, including, but not limited to, 3-dimensional printing, in which layers of material are laid down in succession.
23 24	B. "Downloadable gun" means a firearm manufactured or produced using additive manufacturing.

"Downloadable gun code" means digital instructions in the form of computer- aided design files or other code or instructions stored and displayed in electronic format as a digital model that may be used to manufacture or produce a firearm, firearm receiver, magazine or firearm component using additive manufacturing.

"Serialization" means placing a serial number on a firearm frame or receiver in accordance with the procedures for the serialization of a firearm in 18 United States Code, Section 923(i) and all regulations issued pursuant to that section, including, but not limited to, 27 Code of Federal Regulations, Section 478.92.
33	E. "Serial number" means a unique identifying number.

"Unfinished frame or receiver" means a frame or lower receiver blank, casting or machined body that requires further machining or molding to be used as part of a functional firearm and is designed and intended to be used in the assembly of a functional firearm. "Unfinished frame or receiver" does not include a piece of

1 2	material that has had its size or external shape altered solely to facilitate transportation or storage or has had only its chemical composition altered.
3 4 5	<u>G.</u> "Untraceable firearm" means a downloadable gun without a serial number or a firearm manufactured, assembled or produced without serialization using an unfinished frame or receiver.

This bill regulates the manufacture, distribution and possession of so-called ghost guns and so-called 3-D printed guns or 3-D guns, which are fully functioning firearms that can be made at home by unlicensed firearm manufacturers, sellers and distributors either by purchasing the necessary parts separately, or as part of mail order gun kits, and then assembling them at home or by downloading a computer code from the Internet that allows the user to manufacture the gun using a 3-D printer. This bill provides definitions of "undetectable firearm" and "untraceable firearm" and prohibits the manufacture,

- import, sale, transfer and possession of such firearms with certain exceptions. This bill also prohibits, with certain exceptions, the dissemination of downloadable gun code from 1

- which untraceable firearms can be manufactured. 3
