1 **Emergency preamble. Whereas**, acts and resolves of the Legislature do not  
 2 become effective until 90 days after adjournment unless enacted as emergencies; and

3 **Whereas**, the 90-day period may not terminate until after the beginning of the next  
 4 fiscal year; and

5 **Whereas**, certain obligations and expenses incident to the operation of state  
 6 departments and institutions will become due and payable immediately; and

7 **Whereas**, in the judgment of the Legislature, these facts create an emergency within  
 8 the meaning of the Constitution of Maine and require the following legislation as  
 9 immediately necessary for the preservation of the public peace, health and safety; now,  
 10 therefore,

11 **Be it enacted by the People of the State of Maine as follows:**

12 **PART A**

13 **Sec. A-1. Appropriations and allocations.** The following appropriations and  
 14 allocations are made.

18 performed state-mandated activities, shall establish the State-local Intergovernmental

**Sec. V-1. 36 MRSA §4641-B, sub-§4-B, ¶D,** as amended by PL 2013, c. 368, Pt. U, §1, is further amended to read:

D. In fiscal year 2014-15, the Treasurer of State shall credit the revenues derived from the tax imposed pursuant to section 4641-A, subsection 1 in accordance with this paragraph.

(1) At the beginning of the fiscal year, the Maine State Housing Authority shall certify to the Treasurer of State the amount that is necessary and sufficient to meet the authority's obligations relating to bonds issued or planned to be issued by the authority under Title 30-A, section 4864.

(3) On a monthly basis the Treasurer of State shall apply 50% of the revenues in accordance with this subparagraph. The Treasurer of State shall first credit ~~\$4,038,104~~ \$5,038,104 of the revenues available under this subparagraph to the General Fund, after which the Treasurer of State shall pay any remaining revenues available under this subparagraph to the Maine State Housing Authority, which shall deposit the funds in the Housing Opportunities for Maine Fund created in Title 30-A, section 4853.

**PART W**

**Sec. W-1. MaineCare program integrity.** The Department of Health and Human Services shall evaluate and improve its MaineCare program integrity processes to increase MaineCare recoveries and reduce MaineCare costs. In implementing this Part, the department shall establish specific goals and performance measures for its existing staff and vendors to achieve additional MaineCare recoveries and savings. For the purpose of this Part, program integrity processes include but are not limited to provider audits, including hospital diagnosis-related group audits; fraud referrals; 3rd-party liability activities; credit balance audits; and corrections to deficiencies in computer systems maintained by the department and its vendors.

**Sec. W-2. MaineCare program integrity resources.** In evaluating its MaineCare program integrity processes under section 1 of this Part, the department shall assess the need for additional MaineCare resources to meet the goals and performance measures for recoveries and savings identified in section 4 of this Part. If the department determines that additional resources are needed, the department is authorized to use the additional funding provided in section 4 of this Part to contract with additional vendors,

33 **Sec. Z-1. Vacancy review and lapsed savings.** The Department of

 36 Services line category equal to \$599,533 in fiscal year 2014-15. The Commissioner of  
 37 Administrative and Financial Services shall submit a report to the Joint Standing  
 38 Committee on Appropriations and Financial Affairs by July 1, 2014 with  
 39 recommendations for the vacant General Fund positions that must be administratively

## 16 SUMMARY

### 17 PART A

18 This Part includes appropriations and allocations in response to the recommendations  
19 of the Governor's Office of Policy and Management pursuant to Public Law 2013, chapter  
20 368, Part F.

### 21 PART B

22 This Part makes supplemental appropriations and allocations.

### 23 PART C

24 This Part establishes the total cost of public education from kindergarten to grade 12  
25 for fiscal year 2014-15, the local and state contributions and the annual target state share  
26 percentage.

### 27 PART D

28 This Part transfers \$1,877,000 in fiscal year 2014-15 from the Dirigo Health Fund to  
29 the unappropriated surplus of the General Fund.

### 30 PART E

31 This Part removes certain dates relating to the grant application and award process  
32 that were not met by the Oral Health Advisory Committee and applies these changes  
33 retroactively to the effective date of the law that established the dates. It also makes a

7 **PART G**

8 This Part authorizes the adjustment of salary schedules in order to implement wage  
9 parity as authorized in Public Law 2013, chapter 425. This Part also adjusts the salaries  
10 of District Attorney positions, Assistant District Attorney positions and Assistant  
11 Attorney General positions upward by 4%. It also authorizes transfers from the Salary  
12 Plan program for these purposes and limits the amount available for transfer to the  
13 Department of the Attorney General to \$423,424 in fiscal year 2014-15.

14 **PART H**

15 This Part authorizes the Maine Health Data Organization to transfer up to \$265,450  
16 in available Personal Services balances to All Other in the Maine Health Data  
17 Organization, Other Special Revenue Funds account during the 2014-2015 biennium.

18 **PART I**

19 This Part changes the use of the transfer from the Carrying Balances - Inland  
20 Fisheries and Wildlife, General Fund account in the biennial budget, Public Law 2013,  
21 chapter 368, Part YY, from funding security improvements and renovations at the Gray  
22 headquarters facility to funding permitting and development costs associated with the  
23 construction of a new headquarters facility in Gray.

24 **PART J**

25 This Part clarifies that the information provided by the Department of Health and  
26 Human Services to the Department of Administrative and Financial Services, Bureau of  
27 Revenue Services under the Maine Medical Use of Marijuana Act may be used by the  
28 bureau only for the administration and enforcement of taxes imposed under the Maine  
29 Revised Statutes, Title 36. It also provides a one-time special reporting date for the  
30 Department of Health and Human Services to provide the required information to the  
31 State Tax Assessor.

32 **PART K**

33 Public Law 2013, chapter 502, Part K reduced the income tax credit for qualified  
34 Pine Tree Development Zone businesses by 50%. This Part restores the income tax credit  
35 to the percentages in effect prior to the changes made by Public Law 2013, chapter 502,  
36 Part K.

37 **PART L**

1 This Part sets aside any profit sharing payments from the wholesale liquor  
2 distribution contract that ends June 30, 2014 in excess of budgeted amounts for the final  
3 profit sharing payment into an Other Special Revenue Funds account in the Department  
4 of Administrative and Financial Services, Bureau of Alcoholic Beverages and Lottery  
5 Operations for the purpose of funding additional liquor enforcement positions.

6 **PART M**

7 This Part provides that revenue generated from fees for admission to the Maine State  
8 Museum and miscellaneous services be deposited into a dedicated Other Special Revenue  
9 Funds account instead of to the General Fund, beginning in fiscal year 2014-15, to  
10 support the operations of the Maine State Museum.

11 **PART N**

12 This Part reduces the amount of funds that must be transferred from available  
13 balances in the Other Special Revenue Funds accounts within the Department of  
14 Professional and Financial Regulation to the unappropriated surplus of the General Fund  
15 by \$1,000,000 in fiscal year 2014-15.

16 **PART O**

17 This Part amends Public Law 2013, chapter 368, Part PPPP to increase the amount of  
18 the transfer to the General Fund unappropriated surplus from the Revenue Services -  
19 Bureau of program, Other Special Revenue Funds account from \$500,000 to \$1,000,000  
20 in fiscal year 2013-14. It also requires the State Controller to lapse to the General Fund  
21 unappropriated surplus from the Maine Revenue Services, General Fund account  
22 \$250,000 no later than June 30, 2015.

23 **PART P**

24 This Part increases the cap from \$2,786,700 to \$5,500,000 in any fiscal year of  
25 incentive payment revenue that may be expended for the purpose of covering the costs of  
26 making child support collections.

27 **PART Q**

28 This Part requires the Department of Health and Human Services to modify the  
29 timing of MaineCare payments to achieve one-time savings.

30 **PART R**

31 This Part requires the judicial branch, the University of Maine System, the Maine  
32 Community College System, the Maine Maritime Academy and each quasi-independent  
33 state entity each to prepare a list of reports that each is required to submit to the  
34 Legislature, a statement of the amount of staff time required to prepare each report and  
35 proposed legislation to repeal each reporting requirement 5 years after the effective date  
36 of this legislation and submit the information to the joint standing committee of the  
37 Legislature with subject matter jurisdiction over that entity by January 9, 2015.

1 This Part also requires each joint standing committee of the Legislature having  
2 subject matter jurisdiction over an entity providing a report to review the information  
3 provided and determine the need to either continue or repeal the reporting requirement.  
4 Each joint standing committee is authorized to report out legislation to implement its  
5 recommendations related to the report to the First Regular Session of the 127th  
6 Legislature.

7 **PART S**

8 This Part prohibits the Department of Health and Human Services from eliminating  
9 reimbursement for the medical add-on in the MaineCare Benefits Manual, Chapter III,  
10 Section 21 and Section 29 until the report required by Public Law 2013, chapter 368, Part  
11 NN has been submitted by the department to the joint standing committees of the  
12 Legislature pursuant to that Part and new rules adopted.

13 **PART T**

14 This Part removes from the cap on total itemized deductions medical and dental  
15 expenses included in an individual's itemized deductions from federal adjusted gross  
16 income for tax years beginning on or after January 1, 2014. It also provides allocations to  
17 the Department of Administrative and Financial Services, Bureau of Revenue Services to  
18 increase contingent-fee funding for contracted tax collection services to hire 8 additional  
19 collectors and improve automated collection functions.

20 **PART U**

21 This Part makes changes to laws relating to mandates imposed on municipalities by  
22 the State.

23 It amends the law governing dog licensing and animal control ordinances to clarify  
24 that a municipality may impose fees necessary and appropriate to finance the cost of  
25 animal control services. It repeals the law requiring the local appointment of an inspector  
26 of weights and measures. It also amends the law governing the exempting of certain  
27 owners of boilers from the laws governing boilers and pressure vessels generally,  
28 including from certain state fees, to exempt also municipalities and schools.

29 It repeals laws requiring municipalities to administer licensing programs for a range  
30 of recreational business activities, such as bowling, billiards and roller skating. Instead, it  
31 authorizes the municipal licensing of these activities pursuant to ordinances adopted  
32 under municipal home rule authority. It also amends the statute governing the licensing  
33 of going-out-of-business sales to establish those licensing requirements only in  
34 municipalities that choose to adopt such a licensing ordinance.

35 It creates the State-local Intergovernmental Working Group for the purpose of  
36 establishing a 2-way communication system between the state agencies responsible for  
37 the oversight of municipally performed state-mandated activities and the municipalities  
38 that perform the mandated activities with the goal of establishing more efficient, effective  
39 and cost-effective approaches to the implementation and administration of the mandated  
40 activities. The working group is required to meet periodically and report to the joint

1 standing committees of the Legislature having jurisdiction over appropriations and  
2 financial affairs and state and local government matters in 2016 and 2018.

3 It authorizes the joint standing committee of the Legislature having jurisdiction over  
4 state and local government matters to report out legislation relating to the final report of  
5 the mandate working group to the First Regular Session of the 127th Legislature.

6 **PART V**

7 This Part increases the General Fund share of the real estate transfer tax by  
8 \$1,000,000 in fiscal year 2014-15 the result of which is a like decrease in the amount  
9 transferred to the Housing Opportunities for Maine Fund.

10 **PART W**

11 This Part directs the Department of Health and Human Services to evaluate and  
12 improve its MaineCare program integrity processes to achieve additional MaineCare  
13 recoveries and savings.

14 **PART X**

15 This Part amends the fiscal year 2013-14 year-end distribution of the unappropriated  
16 surplus of the General Fund to replace the existing 4th priority transfer, which is no  
17 longer necessary, with a new 4th priority transfer of an amount up to \$20,000,000 to a  
18 General Fund reserve account established for future funding needs. Funds from the  
19 reserve account for future funding needs may be transferred only by the Legislature, and  
20 any balance not transferred and remaining in the account at the close of the fiscal year  
21 ending June 30, 2015 must be transferred by the State Controller to the Maine Budget  
22 Stabilization Fund.

23 **PART Y**

24 This Part clarifies the use of funding being provided to the Department of Health and  
25 Human Services for the Maine Medical Use of Marijuana Act.

26 **PART Z**

27 This Part requires the Department of Administrative and Financial Services, Bureau  
28 of the Budget to conduct a review of vacant General Fund positions for the purpose of  
29 identifying total savings in the Personal Services line category equal to \$599,533 in fiscal  
30 year 2014-15. The Commissioner of Administrative and Financial Services must provide  
31 to the Joint Standing Committee on Appropriations and Financial Affairs a report of the  
32 positions that must be administratively held vacant during fiscal year 2014-15 to achieve  
33 the identified savings and the General Fund accounts affected. On or before August 1,  
34 2014, the State Controller shall lapse the identified savings to the unappropriated surplus  
35 of the General Fund from the accounts identified in the report.

36 This Part also requires the Department of Corrections to increase the term of work  
37 release from 12 months to 18 months prior to prisoner release, resulting in an increase in  
38 General Fund revenue.

1           This Part requires the Finance Authority of Maine to transfer the remaining balance  
2 in the Quality Child Care Education Scholarship Fund to the State as undedicated Fund  
3 for a Healthy Maine revenue no later than June 30, 2015.
