1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 2 MRSA §1, 3rd ¶**, as amended by PL 2019, c. 475, §6, is further
3 amended to read:

4 Until the first Wednesday of January 1987, the Governor receives an annual salary of
5 \$35,000. Beginning the first Wednesday of January 1987, the Governor is entitled to
6 receive an annual salary of \$70,000. Beginning the first Wednesday of January following
7 the election of a Governor who is not in office on December 2, 2020, the Governor is
8 entitled to receive an annual salary of \$135,000.

9 **Sec. 2. 2 MRSA §2**, as amended by PL 2019, c. 475, §9, is further amended to
10 read:

11 **§2. Expense account**

12 The "Governor's Expense Account" must be credited with those amounts that are
13 appropriated by the Legislature for that purpose. This appropriation must be available for
14 expenditure by the Governor at the Governor's discretion. This account is not subject to
15 audit, except as to total amount to be paid. Beginning the first Wednesday of January
16 following the election of a Governor who is not in office on December 2, 2020, the
17 Governor's Expense Account must be provided \$40,000 per year.

20 ~~Each~~ Until the first Wednesday of December 2020, each member of the Senate and

23 biennium, except that if a Legislator who is a recipient of retirement benefits from the

2 each legislative session ~~once each week~~ at the ~~same~~ rate of 58¢ per mile to and from that
3 Legislator's place of abode ~~as state employees receive~~, the mileage to be determined by
4 the most reasonable direct route, except that Legislators may be reimbursed for tolls paid
5 for travel on the Maine Turnpike as long as they have a receipt for payment of the tolls,
6 such tolls to be reimbursed when Legislators use the Maine Turnpike in traveling to and
7 from sessions of the Legislature or in performance of duly authorized committee
8 assignments. Each Legislator is entitled to mileage on the first day of the session, and
9 those amounts of salary and expenses at such times as the Legislature may determine
10 during the session, and the balance at the end of the session.

13 Except as provided in this section, each member of the Senate and House of
14 Representatives is entitled to a meal allowance in the amount of \$32 and a housing

16 Legislature and for each day the member occupies overnight accommodations away from
17 home either immediately preceding or immediately following attendance at daily sessions
18 of the Legislature. The presiding officers may establish reasonable policies regarding
19 allowances for meals and overnight accommodations for the day immediately preceding
20 the session, which may include policies regarding whether an allowance is paid, whether
21 the full amount or a portion of the statutory allowance is paid and whether receipts are
22 required. In lieu of the meal and housing allowance, each member is entitled to a daily
23 meal allowance in the amount of \$32 and actual daily mileage allowances in an amount
24 up to but not exceeding ~~\$38~~ \$50 per day. Each member of the Senate also receives an
25 annual allowance for constituent services in the amount of \$2,000, \$1,300 in January and
26 \$700 in the month following adjournment of the regular session. Each member of the
27 House of Representatives also receives an annual allowance for constituent services in the
28 amount of \$1,500, \$1,005 in January and \$495 in the month following adjournment of the
29 regular session. Notwithstanding this section, during the first regular session of each
30 legislative biennium, a member of the Senate or the House of Representatives may elect
31 to receive the first payment of the annual allowance for constituent services in December
32 following convening of the Legislature by notifying the Executive Director of the
33 Legislative Council in the manner prescribed by the executive director. The Executive
34 Director of the Legislative Council shall inform Legislators of the choice available for
35 payment of the allowance for constituent services in the first year of the legislative
36 biennium and of any tax implications associated with exercising that choice.

7 **SUMMARY**

8 This bill is reported out by the Joint Standing Committee on State and Local
9 Government pursuant to the Maine Revised Statutes, Title 3, section 2, subsection 2. The
10 committee has not taken a position on the substance of this bill. By reporting out this bill,
11 the committee is not suggesting and does not intend to suggest that it agrees or disagrees
12 with any aspect of this bill. The committee is reporting out the bill for the sole purpose of
13 having a bill printed that can be referred to the committee for an appropriate public
14 hearing and subsequent processing in the normal course. The committee is taking this
15 action to ensure clarity and transparency in the legislative review of the proposals
16 contained in the bill.

17 This bill includes all the recommendations of the State Compensation Commission's
18 January 2020 final report including increases in the:

19 1. Salary of the Governor from \$70,000 per year to \$135,000 per year to take effect
20 after the election of a Governor not in office on December 2, 2020;

21 2. The expense account of the Governor from \$30,000 per year to \$40,000 per year;

22 3. Salary of Maine Legislators, beginning with the 130th Maine Legislature, from
23 \$14,862 in the first year and \$10,582 in the 2nd year of a biennium, after adjustment for
24 inflation, to \$16,000 in each year of the biennium;

25 4. Mileage allowance for Maine Legislators from 44¢ per mile to 58¢ per mile;

26 5. Lodging rate for Maine Legislators from \$38 per day to \$50 per day;

27 6. Salary of the Chief Justice of the Supreme Judicial Court from \$116,000 per year
28 to \$184,000 per year;

29 7. Salary of the Associate Justices of the Supreme Judicial Court from \$96,000 to
30 \$169,000 per year;

31 8. Per diem compensation for Active Retired Justices from \$350 per day to \$500 per
32 day;

33 9. Salary of the Chief Justice of the Superior Court from \$94,000 per year to
34 \$160,000 per year;

1 10. Salary of the Justices of the Superior Court from \$90,000 per year to \$150,000
2 per year;

3 11. Salary of the Chief Judge of the District Court from \$94,000 per year to
4 \$160,000 per year;

5 12. Salary of the Deputy Chief Judge of the District Court from \$92,000 per year to
6 \$155,000 per year; and

7 13. Salary of the Associate Judges of the District Court from \$90,000 per year to
8 \$150,000 per year.

9 The bill gives the Chief Justice of the Supreme Judicial Court the authority to
10 develop criteria and rates for longevity pay for all justices and judges. It moves the initial
11 meeting of the State Compensation Commission from within 15 days after appointment
12 of the members to within 15 days after adjournment of a legislative session. It requires
13 the President of the Senate and the Speaker of the House to appoint the 5th member of the
14 commission in alternating odd-numbered years. It removes the following positions from
15 the commission's review: Secretary and Assistant Secretary of the Senate and Clerk and
16 Assistant Clerk of the House of Representatives.
