### An Act To Expand and Promote Telehealth Services

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 24-A MRSA §4316, sub-§8**, as enacted by PL 2019, c. 289, §2, is amended  
3 to read:

4 **8. Telehealth equipment.** A carrier may not require a provider to use specific  
5 telecommunications technology and equipment as a condition of coverage under this  
6 section as long as the provider uses telecommunications technology and equipment that  
7 comply with current industry interoperability standards and that comply with standards  
8 required under the federal Health Insurance Portability and Accountability Act of 1996,  
9 Public Law 104-191 and regulations promulgated under that Act. A provider may perform  
10 a medically necessary health care service delivered through telehealth using the patient's  
11 choice of telecommunications technology and equipment or, with the patient's consent, the  
12 telecommunications technology and equipment that is available to the provider and the  
13 patient.

14 **Sec. 2. 24-A MRSA §4316, sub-§10** is enacted to read:

15 **10. Providers outside of State.** A provider not licensed to practice medicine in the  
16 State may provide telehealth to a patient in the State from another jurisdiction pursuant to  
17 the provisions of Title 32, section 3300-D.

18 **Sec. 3. 32 MRSA §3300-D, sub-§1**, as enacted by PL 2015, c. 137, §1, is amended  
19 to read:

20 **1. Definition.** For the purposes of this section, "telemedicine" has the same meaning  
21 as "telehealth" in Title 24-A, section 4316, subsection 1, paragraph C.

22 **Sec. 4. 32 MRSA §3300-D, sub-§2**, as enacted by PL 2015, c. 137, §1, is amended  
23 to read:

24 **2. Requirements.** A physician not licensed to practice medicine in this State may  
25 provide ~~consultative~~ services through interstate telemedicine to a patient located in this  
26 State if the physician is registered in accordance with subsection 3. A physician intending  
27 to provide ~~consultative~~ services in this State through interstate telemedicine shall provide  
28 any information requested by the board and complete information on:

29 A. All states and jurisdictions in which the physician is currently licensed;

30 B. All states and jurisdictions in which the physician was previously licensed; and

31 C. All negative licensing actions taken previously against the physician in any state or  
32 jurisdiction.

33 **Sec. 5. 32 MRSA §3300-D, sub-§3**, as enacted by PL 2015, c. 137, §1, is amended  
34 to read:

35 **3. Registration.** The board ~~may~~ shall register a physician to practice medicine in this  
36 State through interstate telemedicine if the following conditions are met:

37 A. The physician is fully licensed without restriction to practice medicine in the state  
38 from which the physician provides telemedicine services;

39 B. The physician has not had a license to practice medicine revoked or restricted in  
40 any state or jurisdiction;
