1 **Emergency preamble.** Whereas, acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and 3 Whereas, the 90-day period will not terminate until after the beginning of the next 4 fiscal year; and 5 Whereas, this legislation affects obligations and expenses during the course of the current fiscal year and requires immediate attention; and 6 7 Whereas, current state reimbursement rates for services providing long-term supports 8 and services do not account for the current minimum wage requirements; and 9 Whereas, in the judgment of the Legislature, these facts create an emergency within 10 the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, 11 therefore, be it 12 13 Sec. 1. Reimbursement. Resolved: That the Department of Health and Human 14 Services shall amend its rules to increase MaineCare reimbursement rates for home and community-based services by no less than \$2 an hour for the following services: 15 1. 1 2 3	Sec. 2. Reimbursement. Resolved: That the Department of Health and Human Services shall amend its rules to increase reimbursement rates for state-funded home and community-based services by no less than \$2 an hour for the following services:
4 5	1. Personal assistance provided under the provisions of 14-197 C.M.R. Chapter 11, Consumer-directed Personal Assistance Services;
6 7	2. Day care services provided under the provisions of 10-149 C.M.R. Chapter 5, Office of Aging and Disability Services Policy Manual, Section 61, Adult Day Services;

Resolved: That the Department of Health and Human Services shall amend its rules to update per diem calculations to include an increase of no less than \$2 an hour for all direct care services for the following residential services provided under Chapter 101: MaineCare Benefits Manual, Chapter III:
22	1. Section 2, Adult Family Care Services;
23 24	2. Section 50, Principles of Reimbursement for Intermediate Care Facilities for the Developmentally Disabled;
25	3. Section 67, Principles of Reimbursement for Nursing Facilities; and
26	4. Section 97, Private Non-Medical Institution Services, Appendix C.
27 28	Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.
29	SUMMARY
30 31 32 33	This resolve increases reimbursement rates to direct care workers. The resolve requires the Department of Health and Human Services to increase reimbursement rates to all direct care worker services that are provided in home and community-based settings and in institutional settings by no less than \$2 an hour.
