3 4 5	10-A. Substance use disorder treatment program. The commissioner shall establish and maintain a substance use disorder treatment program in the correctional facilities, which must, at a minimum:	
6 7	A. Provide for a substance use disorder assessment on intake for all clients to assess the risk of overdose or withdrawal and to determine treatment options;	
8 9 10	B. Include comprehensive behavioral treatment options for clients that involve recovery groups, individual counseling and identification and treatment of associated mental health disorders;	
11 12 13	C. Provide a variety of medication-assisted treatment options and other substance use disorder treatment options for clients with substance use disorder for treatment of withdrawal and maintenance therapy; and	
14 15 16	D. Coordinate with representatives of local recovery communities and providers of local case management services to offer peer support and comprehensive treatment options to clients after release.
