1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 7 MRSA c. 15** is enacted to read:

3 **CHAPTER 15**

4 **FARMLAND RESTORATION PROGRAM**

5 **§361. Farmland Restoration Program**

6 **1. Definitions.** As used in this chapter, unless the context otherwise indicates, the
7 following terms have the following meanings.

8 A. "Fund" means the Farmland Restoration Fund established in section 362.

9 B. "Panel" means the review panel established in subsection 3.

10 C. "Program" means the Farmland Restoration Program established in subsection 2.

11 **2. Program established.** The Farmland Restoration Program is established within
12 and is administered by the department. The program provides approved applicants with
13 assistance in improving lands for increasing food and fiber production agriculture,
14 improving soil quality and strengthening soil conservation and watershed protection.

15 The program provides payments of up to 50% of the cost or \$20,000, whichever is less,
16 of an approved restoration project under subsection 5. For projects involving state-owned
17 or municipality-owned farmland under long-term agricultural leases of 5 years or more,
18 the total program payment may be up to 90% of the restoration costs, up to \$20,000.

19 **3. Participation; application; review panel.** Individuals must submit an
20 application to the department to be eligible for participation in the program, pursuant to
21 procedures developed by the department. Applications must include a detailed
22 conservation plan as described under subsection 4. An approved application is required
23 prior to funding approval.

24 The department shall establish a review panel to evaluate and approve applications for
25 participation in the program based on the 3 equal objectives of increasing food and fiber
26 production agriculture, improving soil quality and strengthening soil conservation and
27 strengthening watershed protection. The panel may further evaluate and approve
28 applications and proposed conservation plans based upon other lesser criteria developed
29 by the department. The panel must notify all applicants of their application status in a
30 timely manner.

31 **4. Conservation plan required.** An application for the program must include a
32 detailed conservation plan. An applicant that chooses not to prepare a plan in
33 consultation with the United States Department of Agriculture, Natural Resources
34 Conservation Service must provide a plan developed in consultation with the applicant's
35 local soil and water conservation district in order to be considered for funding under the
36 program. The conservation plan must at a minimum comply with the latest best
37 management practices. In scoring plans, the panel will award higher scoring to

1 conservation plans that incorporate stronger, evidence-based management practices
2 reflective of increasing trends for total rainfall and increased severity of rainfall events.

3 If a restoration project includes clearing or partial clearing of forested areas, the
4 conservation plan must also comply with any guidelines of the department regarding the
5 creation of new agricultural fields or the expansion of existing agricultural fields in
6 forested areas.

7 **5. Healthy soil practices required.** The project's conservation plan must be
8 consistent with, and the applicant's plans for operation and maintenance practices for the
9 restoration area farmland must constitute, an investment in good soil health, including a
10 healthy diversity of soil biota.

11 **6. Approved restoration projects.** The program may fund the following farmland
12 restoration projects:

13 A. Reclamation of grown-over pastures, meadows and cropland, including the
14 removal of invasive plants, and hedgerow management;

15 B. Clearing and removal of trees, stumps, stones and brush to create or restore a
16 land's agricultural use, which may include clearing plots or thinning to implement
17 forest farming practices, including interplanting and livestock foraging and grazing;

18 C. Installation of fencing to keep livestock in reclaimed pasture areas or out of
19 riparian areas;

20 D. Installation of wildlife management fencing to protect crop fields in designated
21 areas;

22 E. Restoration of water runoff and drainage of crop fields to improve cropland areas
23 and restore water runoff patterns and water conservation;

24 F. Renovation of farm ponds, including farm pond management, irrigation and
25 irrigation wells incidental to the restored areas;

26 G. Replanting of vegetation on erosion-prone land and along stream banks on
27 agricultural lands;

28 H. Restoration of shellfish beds or aquaculture ponds; and

29 I. Enhancement of farm roads that serve restoration areas.

30 **§362. Farmland Restoration Fund**

31 **1. Fund established.** The Farmland Restoration Fund is established as a nonlapsing
32 fund within the department. The commissioner may accept money for the fund from any
33 public or private source and may make expenditures from the fund to carry out the
34 purposes of the program.

35 **2. Administration.** The commissioner shall administer the fund.

§363. Rulemaking

The department shall adopt rules necessary to implement the program. Rules adopted pursuant to this section are major substantive rules pursuant to Title 5, chapter 375, subchapter 2-A.
