An Act To Amend Seasonal Licenses for the Operation of Beano or Bingo Games

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 17 MRSA §315**, as enacted by PL 1975, c. 307, §2, is repealed and the
3 following enacted in its place:

4 **§315. Seasonal licenses**

5 Notwithstanding sections 314 and 319, the Chief of the State Police may issue
6 seasonal licenses to operate beano or bingo games, including those designed to attract
7 players under 16 years of age, in bona fide resort hotels as long as the following
8 conditions are met.

9 **1. Operated on-site.** The games are operated and conducted in those resort hotels
10 by the management without profit and solely for the entertainment of registered guests or
11 patrons of that resort hotel.

12 **2. Maximum charge.** The charge, if any, to a guest or patron for participation in
13 those games is limited to a maximum of \$2 in any 24-hour period.

14 **3. Minors.** If the games are designed to attract players under 16 years of age, then
15 the award is limited to a nonmonetary prize valued at less than \$10, which may be
16 awarded to a single player no more than once every 24 hours. Notwithstanding section
17 319, a person under 16 years of age may be admitted to the playing area without an adult
18 and may participate in the game. For purposes of this subsection, "nonmonetary prize"
19 includes a credit for food served on the premises of the resort hotel.

20 The fee for a license issued pursuant to this section is \$10 and must be paid to the
21 Treasurer of State to be credited to the General Fund. A hotel or liquor license of a resort
22 hotel licensee may not be withheld because of the conducting by the resort hotel of the
23 game of beano or bingo.

24 Nothing in this section permits the operation or conduct of beano or bingo games
25 without a license.

26 **SUMMARY**

27 This bill amends the law regarding seasonal licenses to operate beano or bingo games
28 without profit, which currently may be issued to resort hotels for their registered guests
29 on the premises of the resort. Current law prohibits minors under 16 years of age from
30 playing beano or bingo games or being in a place where the games are being operated
31 without an adult.

32 The bill allows minors under 16 years of age, without being accompanied by an adult,
33 to participate in bingo or beano games operated at the resort hotel as long as the prize is a
34 nonmonetary prize, which may include a credit for food served on the premises of the
35 resort, valued at no more than \$10.
