Resolve, To Enhance the Administration of the Child and Adult Care Food Program by Creating Clear Guidelines for Organizations and Streamlining the Application Process

Cosponsored by Representative GATTINE of Westbrook and Senators: BURNS of Washington, HASKELL of Cumberland, Representatives: BLACK of Wilton, HAMANN of South Portland, HICKMAN of Winthrop, MAREAN of Hollis. 1 **Whereas,** the Child and Adult Care Food Program is a federally funded nutrition 2 program within the United States Department of Agriculture that is administered in the 3 State by the bureau of child and family services within the Department of Health and 4 Human Services; and

5 Whereas, the federal Child and Adult Care Food Program provides reimbursement 6 for nutritious meals and snacks served to eligible infants and children in qualifying child 7 care centers, family day care homes, emergency shelters and after-school care programs 8 for at-risk students and to eligible adults receiving care in qualifying nonresidential adult 9 day care centers; and

- 10 **Whereas,** in order to provide such services and receive reimbursement, qualifying 11 care facilities must complete lengthy applications and comply with numerous 12 requirements, prohibitions and guidelines; and
- 13 Whereas, certain facilities encounter difficulty navigating the application process 14 and meeting the requirements, thus reducing the number of facilities that qualify to 15 provide these critical services; now, therefore, be it:
- 16 **Sec. 1. Review and revise application; guidelines. Resolved:** That the 17 Department of Health and Human Services shall review the application and reapplication 18 procedures and forms required for an organization to apply to participate in the federal 19 Child and Adult Care Food Program and shall:
- 20 1. Streamline the application and reapplication forms;
- Provide access to the forms through the department's publicly accessible website;
 and
- 23 3. Enable online completion and submission of all forms required for an organization
 24 to participate in the program, including but not limited to the application and
 25 reapplication forms.
- 26 Rules adopted pursuant to this section are routine technical rules as defined in the 27 Maine Revised Statutes, Title 5, chapter 375, subchapter 2-A.

This resolve requires the Department of Health and Human Services to review the application and reapplication procedures and forms required for an organization to apply to participate in the federal Child and Adult Care Food Program, and it directs the department to streamline the application and reapplication forms; provide access to the forms through the department's publicly accessible website; and enable online completion and submission of all forms required for an organization to participate in the program, including but not limited to the application and reapplication forms.
