An Act to Require the Commissioners of the Public Utilities Commission to Be Popularly Elected

1	Be it enacted by the People of the State of Maine as follows:
2 3	<b>Sec. 1. 2 MRSA §6-A, sub-§5,</b> as amended by PL 1989, c. 502, Pt. A, §4 and PL 2007, c. 58, §3, is further amended to read:
4 5 6 7 8 9	<b>5. Retirement contribution.</b> The State shall pay the mandatory retirement contribution required by Title 5, section 17701, for commissioners who elect to become members of the Maine Public Employees Retirement System. Payment shall <u>must</u> be made as provided in Title 5, section 17702. A commissioner may elect at the time of appointment <u>election</u> to receive a 5% salary increase instead of state payment of the retirement contribution.
10	Membership in the Maine Public Employees Retirement System is optional.
11 12	<b>Sec. 2. 35-A MRSA §105,</b> as enacted by PL 1987, c. 141, Pt. A, §6, is amended to read:
13	§105. Appointment <u>Election</u> and term
14 15 16 17	<b>1. Appointment.</b> The Governor shall appoint 3 members to the Public Utilities Commission. The appointments shall be subject to review by the joint standing committee of the Legislature having jurisdiction over public utilities and to confirmation by the Legislature. Members of the commission shall devote full time to their duties.
18 19 20	<b>1-A. Election.</b> The 3 members of the Public Utilities Commission are elected by popular election on the general election date in November. Members of the commission shall devote full time to the duties of office.
21	2. Term. The commissioners shall serve for staggered terms of 6 years.
22 23 24	A. Each term shall end on March 31st of the 6th year of the term. The terms shall be staggered so that one ends in 1987 and every 6 years thereafter, one ends in 1989 and every 6 years thereafter, and one ends in 1991 and every 6 years thereafter.
25 26	B. A commissioner may continue to serve beyond the end of this term until a successor is appointed elected and qualified.
27 28	C. Any vacancy occurring in the commission shall $\underline{\text{must}}$ be filled by appointment $\underline{\text{of}}$ the Governor for the unexpired portion of the term.
29 30 31 32	<b>Sec. 3. Staggered terms.</b> Notwithstanding the Maine Revised Statutes, Title 35-A, section 105, subsection 2, the 3 members of the Public Utilities Commission elected in November 2023 shall draw lots to decide which member serves a 2-year term, which member serves a 4-year term and which member serves a 6-year term.
33	SUMMARY
34 35	This bill provides that the 3 members of the Public Utilities Commission are elected instead of appointed.
