1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 30-A MRSA §900-B**, as amended by PL 2019, c. 23, §1, is further amended
3 to read:

4 **§900-B. Advisory committee**

5 There is established the Washington County Budget Advisory Committee as provided
6 in this section.

7 **1. Municipal officers; election; term.** ~~The~~ Except as provided in subsections 2 and
8 2-A, the municipal officers from each county commissioner district shall choose the budget
9 advisory committee members by the following procedure.

10 A. No later than 100 days before the end of the county's fiscal year, the county
11 commissioners shall notify all municipal officers in the county to caucus by county
12 commissioner districts at a specified date, time and place for the purpose of electing at
13 least one municipal officer from each district as a member of the budget advisory
14 committee; except that, in 1992, at least 3 municipal officers must be selected from
15 each district unless the municipal officers of a district decide that another person from
16 that district would be better qualified. A municipality may not be represented by more
17 than one officer at a time. The county commissioner shall serve as nonvoting
18 moderator for that district caucus. Nominations must be received from the floor. The
19 nominee receiving the most votes is approved as a budget advisory committee member
20 except that, in 1992, each caucus shall elect 3 members. The names of those elected
21 by the caucus must be recorded and forwarded to the county commissioners.

22 B. Budget advisory committee members serve 3-year terms except that, in 1992, one
23 member from each district must be elected for a one-year term, one member for a 2-
24 year term and one member for a 3-year term. If a budget advisory committee member
25 ceases to be a municipal officer during the term of membership, that committee
26 member vacates membership and the next district caucus shall elect a qualified
27 municipal officer to serve for the remainder of the unexpired term.

28 A municipal officer elected as a member of the budget advisory committee may name a
29 designee to serve on the committee.

30 **2. Legislative member.** ~~The~~ Prior to October 15, 2025, the Washington County
31 legislative delegation shall annually select one member of the delegation who resides in
32 Washington County to serve as a nonvoting member on the budget advisory committee.
33 By October 15, 2025 and by October 15th of every odd-numbered year thereafter, the
34 Washington County legislative delegation shall select, by majority vote, one member of
35 the delegation who resides in Washington County to serve on the budget advisory
36 committee for a 2-year term as a voting member. If the selected member resigns from the
37 Legislature or from the budget advisory committee during the member's term of office, the
38 Washington County legislative delegation shall select, by majority vote, another member
39 of the delegation who resides in Washington County to serve the remainder of the term.
40 The Washington County legislative delegation may replace a member selected pursuant to
41 this subsection to serve on the budget advisory committee by a 2/3 vote of the delegation.

42 **2-A. Member from unorganized territory.** The county commissioners shall appoint
43 one member who is a resident of the unorganized territory in Washington County as a
44 voting member of the budget advisory committee to serve a 3-year term.

3. Chair. The budget advisory committee shall annually select one of its members to chair the committee.

SUMMARY

This bill requires the Washington County commissioners to appoint one member who is a resident of the unorganized territory in Washington County as a voting member of the Washington County Budget Advisory Committee to serve a 3-year term. It also requires the Washington County legislative delegation to select by majority vote, by October 15, 2025 and by October 15th of every odd-numbered year thereafter, one member of the delegation who resides in Washington County to serve on the budget advisory committee for a 2-year term as a voting member. Current law requires the Washington County legislative delegation to annually select one member of the delegation who resides in Washington County to serve as a nonvoting member on the budget advisory committee.
