31 32 33 34	This bill changes the terms "expressly or impliedly acquiesced" and "acquiesced" to "consented" in the elements of the criminal offenses of gross sexual assault, unlawful sexual contact and unlawful sexual touching and provides a definition of consent for these offenses as "a word or action by a person that indicates a freely given agreement."
