1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 17-A MRSA §253, sub-§2, ¶M**, as amended by PL 2021, c. 608, Pt. E, §1,  
3 is further amended to read:

4 M. The other person has not ~~expressly or impliedly acquiesced~~ consented to the sexual  
5 act and the actor is criminally negligent with regard to whether the other person has  
6 ~~acquiesced~~ consented. For purposes of this paragraph, "consent" means a word or  
7 action by a person that indicates a freely given agreement. Violation of this paragraph  
8 is a Class C crime; or

9 **Sec. 2. 17-A MRSA §255-A, sub-§1, ¶A**, as amended by PL 2021, c. 608, Pt. E,  
10 §2, is further amended to read:

11 A. The other person has not ~~expressly or impliedly acquiesced in~~ consented to the  
12 sexual contact and the actor is criminally negligent with regard to whether the other  
13 person has ~~acquiesced~~ consented. For purposes of this paragraph, "consent" means a  
14 word or action by a person that indicates a freely given agreement. Violation of this  
15 paragraph is a Class D crime;

16 **Sec. 3. 17-A MRSA §255-A, sub-§1, ¶B**, as amended by PL 2021, c. 608, Pt. E,  
17 §3, is further amended to read:

18 B. The other person has not ~~expressly or impliedly acquiesced in~~ consented to the  
19 sexual contact, the actor is criminally negligent with regard to whether the other person  
20 has ~~acquiesced~~ consented and the sexual contact includes penetration. For purposes of  
21 this paragraph, "consent" means a word or action by a person that indicates a freely  
22 given agreement. Violation of this paragraph is a Class C crime;

23 **Sec. 4. 17-A MRSA §260, sub-§1, ¶A**, as amended by PL 2021, c. 608, Pt. E, §4,  
24 is further amended to read:

25 A. The other person has not ~~expressly or impliedly acquiesced in~~ consented to the  
26 sexual touching and the actor is criminally negligent with regard to whether the other  
27 person has ~~acquiesced~~ consented. For purposes of this paragraph, "consent" means a  
28 word or action by a person that indicates a freely given agreement. Violation of this  
29 paragraph is a Class D crime;

30 **SUMMARY**

31 This bill changes the terms "expressly or impliedly acquiesced" and "acquiesced" to  
32 "consented" in the elements of the criminal offenses of gross sexual assault, unlawful  
33 sexual contact and unlawful sexual touching and provides a definition of consent for these  
34 offenses as "a word or action by a person that indicates a freely given agreement."
