	<b>c. 1. 12 MRSA §407,</b> as amended by PL 2011, c. 655, Pt. EE, §17 and affected and amended by c. 657, Pt. W, §5, is repealed and the following enacted in its place:
<u>§407. (</u>	Comprehensive river resource management plans
assistan Resource other sta plan for or to be	<b>Plan required.</b> The Department of Agriculture, Conservation and Forestry, with ce from the Department of Inland Fisheries and Wildlife, the Department of Marine ces, the Department of Environmental Protection, the Governor's Energy Office and ate agencies as needed, shall develop a comprehensive river resource management each watershed with a hydropower project licensed under the Federal Power Act that provides a basis for state agency nts, recommendations and permitting decisions.
	<b>Plan components.</b> A comprehensive river resource management plan developed t to subsection 1:
<u>A.</u>	Must, at a minimum, include as applicable:
	(1) Minimum flows;
	(2) Impoundment level regimes;
	(3) Upstream and downstream fish passage survival rates;
	(4) Maintenance plans for aquatic habitat and habitat productivity; and
	(5) Plans for public access and recreational opportunities; and
<u>B.</u>	Must give consideration to existing uses.
develop commer	State management plan. A comprehensive river resource management plan red pursuant to subsection 1 must update, complement and, after public notice, nt and hearings in the watershed, be adopted as components of the State's hensive rivers management plan.
compre	<b>Rules.</b> A comprehensive river resource management plan and any amendment to a hensive river resource management plan adopted under this section are major tive rules as defined in Title 5, chapter 375, subchapter 2-A.
	<b>c. 2. 38</b> MRSA §464, sub-§4, ¶F, as amended by PL 1991, c. 66, Pt. B, §1, is amended by enacting a new subparagraph (7) to read:
	(7) Notwithstanding any provision of law to the contrary, a person that meets a condition relating to any effect or potential effect on a species that is listed under the United States Endangered Species Act of 1973, Public Law 93-205, as amended, that is imposed or proposed to be imposed by the Federal Energy Regulatory Commission in granting a new license pursuant to 18 Code of Federal Regulations, Part 16, as amended, is considered to have met the State's water quality standards in the event that no equivalent state standard has been set.
