SENATE AMENDMENT " " to COMMITTEE AMENDMENT "A" to H.P. 1060, L.D. 1539, Bill, "An Act To Amend Maine's Medical Marijuana Law"

Amend the amendment in section 15 in §2425-A in subsection 3 in the first blocked paragraph in the 2nd line (page 27, line 14 in amendment) by striking out the following: "The" and inserting the following: 'Except as provided in subsection 3-A, the'

Amend the amendment in section 15 in §2425-A by inserting after subsection 3 the following:

'3-A. Criminal history record check for caregivers administering medical marijuana on school grounds. The department shall request a criminal history record check for a caregiver designated under section 2423-A, subsection 1, paragraph F-1, subparagraph (4). The department may not issue a registry identification card to an applicant who is not permitted to have a disqualifying drug offense or who would be denied an approval, credential, certification, authorization or renewal under Title 20-A, section 6103 or 13011 based on that criminal history record check.

The criminal history record check requested under this subsection must include criminal history record information obtained from the Maine Criminal Justice Information System established in Title 16, section 631 and the Federal Bureau of Investigation. The following provisions apply.

A. The criminal history record information obtained from the Maine Criminal Justice Information System must include a record of public criminal history record information as defined in Title 16, section 703, subsection 8.

B. The criminal history record information obtained from the Federal Bureau of Investigation must include other state and national criminal history record information.

C. A person subject to a criminal history record check under this section shall submit to having fingerprints taken. The State Police, upon payment of the fee, shall take or cause to be taken the person's fingerprints and shall forward the fingerprints to the State Bureau of Identification so that the bureau can conduct state and national criminal history record checks. Except for the portion of the payment, if any, that constitutes the processing fee charged by the Federal Bureau of Investigation, all money received by the State Police for purposes of this paragraph must be paid over

1 to the Treasurer of State. The money must be applied to the expenses of  
2 administration incurred by the Department of Public Safety.

3 D. The subject of a Federal Bureau of Investigation criminal history record check  
4 may obtain a copy of the criminal history record check by following the procedures  
5 outlined in 28 Code of Federal Regulations, Sections 16.32 and 16.33. The subject of  
6 a state criminal history record check may inspect and review the criminal history  
7 record information pursuant to Title 16, section 709.

8 E. State and federal criminal history record information may be used by the  
9 department for the purpose of screening a child care provider or child care staff  
10 member in accordance with this chapter.

11 F. Information obtained pursuant to this subsection is confidential. The results of  
12 criminal history record checks received by the department are for official use only  
13 and may not be disseminated to any other person or entity.

14 G. If a person is no longer subject to this chapter that person may request in writing  
15 that the State Bureau of Identification remove the person's fingerprints from the  
16 bureau's fingerprint file. In response to a written request, the bureau shall remove the  
17 person's fingerprints from the fingerprint file and provide written confirmation of that  
18 removal.

19 The department, with the Department of Public Safety, Bureau of State Police, State  
20 Bureau of Identification, shall adopt rules to implement this subsection. Rules adopted  
21 pursuant to this subsection are routine technical rules as defined in Title 5, chapter 375,  
22 subchapter 2-A.'

23 Amend the amendment by inserting after section 27 the following:

24 '**Sec. 28. 25 MRSA §1542-A, sub-§1, ¶P** is enacted to read:

25 P. Who is required to have a criminal history record check under Title 22, section  
26 2425-A, subsection 3-A.

27 **Sec. 29. 25 MRSA §1542-A, sub-§3, ¶O** is enacted to read:

28 O. The State Police shall take or cause to be taken the fingerprints of the person  
29 named in subsection 1, paragraph P at the request of that person or the Department of  
30 Administrative and Financial Services under Title 22, section 2425-A, subsection  
31 3-A.

32 **Sec. 30. 25 MRSA §1542-A, sub-§4**, as repealed and replaced by PL 2017, c.  
33 409, Pt. B, §13, is amended to read:

34 **4. Duty to submit to State Bureau of Identification.** It is the duty of the law  
35 enforcement agency taking the fingerprints as required by subsection 3, paragraphs A, B  
36 and G to transmit immediately to the State Bureau of Identification the criminal  
37 fingerprint record. Fingerprints taken pursuant to subsection 1, paragraph C, D, E or F or  
38 pursuant to subsection 5 may not be submitted to the State Bureau of Identification unless  
39 an express request is made by the commanding officer of the State Bureau of  
40 Identification. Fingerprints taken pursuant to subsection 1, paragraph G must be  
41 transmitted immediately to the State Bureau of Identification to enable the bureau to  
42 conduct state and national criminal history record checks for the Department of

1 Education. The bureau may not use the fingerprints for any purpose other than that  
2 provided for under Title 20-A, section 6103. The bureau shall retain the fingerprints,  
3 except as provided under Title 20-A, section 6103, subsection 9. Fingerprints taken  
4 pursuant to subsection 1, paragraph I and subsection 3, paragraph I must be transmitted  
5 immediately to the State Bureau of Identification to enable the bureau to conduct state  
6 and national criminal history record checks for the court and the Department of Public  
7 Safety, Gambling Control Board, respectively. Fingerprints taken pursuant to subsection  
8 1, paragraph J, K, L or P must be transmitted immediately to the State Bureau of  
9 Identification to enable the bureau to conduct state and national criminal history record  
10 checks for the Department of Administrative and Financial Services, ~~Bureau of Revenue~~  
11 ~~Services~~. Fingerprints taken pursuant to subsection 1, paragraph M must be transmitted  
12 immediately to the State Bureau of Identification to enable the bureau to conduct state  
13 and national criminal history record checks for the Board of Osteopathic Licensure,  
14 established in Title 32, chapter 36. Fingerprints taken pursuant to subsection 1, paragraph  
15 N must be transmitted immediately to the State Bureau of Identification to enable the  
16 bureau to conduct state and national criminal history record checks for the Board of  
17 Licensure in Medicine, established in Title 32, chapter 48. Fingerprints taken pursuant to  
18 subsection 1, paragraph M must be transmitted immediately to the State Bureau of  
19 Identification to enable the bureau to conduct state and national criminal history record  
20 checks for the State Board of Nursing. Fingerprints taken pursuant to subsection 1,  
21 paragraph O must be transmitted immediately to the State Bureau of Identification to  
22 enable the bureau to conduct state and national criminal history record checks under Title  
23 28-B, section 204.'

24 Amend the amendment by relettering or renumbering any nonconsecutive Part letter  
25 or section number to read consecutively.

## 26 SUMMARY

27 This amendment requires a caregiver designated to possess and administer medical  
28 marijuana for use by a qualifying patient who is enrolled in primary or secondary school  
29 to submit to the same background check applicable to education personnel. The  
30 background check required includes fingerprinting.
