COMMITTEE AMENDMENT “ ” to H.P. 21, L.D. 20, Bill, “An Act To Reimburse Nursing Homes for the Loss of Coinsurance and Deductibles for Skilled Nursing Beds under Rules Adopted by the Department of Health and Human Services”

Amend the bill by striking out all of section 1 and inserting the following:

Sec. 1. Appropriations and allocations. The following appropriations and allocations are made.

Nursing Facilities 0148

Initiative: Appropriates and allocates funding to reimburse nursing homes for the losses of coinsurance and deductibles for nondual Qualified Medicare Beneficiary program members in skilled nursing beds. This funding was removed under rules adopted by the Department of Health and Human Services as required in Public Law 2013, chapter 368.
