Also allocates funds for one Director position, 2 Office Specialist I positions and one Office Associate II position and associated All Other effective July 1, 2012. Two Inspector positions, one Senior Inspector position and one Paralegal position and related All Other will be required effective January 1, 2014. Also allocates funds for the general operating costs necessary to support both the board and its staff.
