24 This amendment is the majority report of the committee, and it strikes and replaces
 25 Parts A and B.

26 This amendment adds to the bill the following:

- 27 1. A Highway Fund allocation of \$2,000,000 to the Highway and Bridge Capital
 28 program for capital projects;
- 29 2. A Highway Fund allocation of \$213,160 to the Urban-Rural Initiative Program;
- 30 3. The recognition of \$155,809 in Highway Fund Personal Services savings from
 31 vacancies within the Department of Public Safety, Bureau of State Police; and
- 32 4. An Island Ferry Services Fund allocation of \$450,000 to the Multimodal - Island
 33 Ferry Service program for increased repairs and fuel costs.
