- **4. Licensed veterinary technician.** "Licensed veterinary technician" has the same meaning as in Title 32, section 4853, subsection 11.'

Amend the bill in section 6 in §3920 in subsection 1 in the 8th line (page 3, line 8 in L.D.) by inserting after the following: "section 3932-A." the following: 'A certified rabies vaccinator must be under the direct supervision or indirect supervision of a licensed veterinarian to administer rabies vaccines to animals.'

Amend the bill by striking out all of section 8 and inserting the following:

- 'Sec. 8. 7 MRSA §3923-B, sub-§2-A, as enacted by PL 1999, c. 254, §5, is amended to read:
- **2-A. Rabies tags.** An owner <u>or keeper</u> shall ensure that a rabies tag obtained from a veterinarian, a licensed veterinary technician under the direct supervision or indirect supervision of a licensed veterinarian or a certified rabies vaccinator for immunization against rabies is securely attached to a collar of leather, metal or material of comparable strength and that the collar is worn at all times by the dog for which the rabies tag was issued, except as provided in subsection 3. <u>For purposes of this section, "direct supervision" has the same meaning as in Title 32, section 4853, subsection 4-A, "indirect supervision" has the same meaning as in Title 32, section 4853, subsection 5; and "licensed veterinarian" has the same meaning as in Title 32, section 4853, subsection 5; and "licensed veterinary technician" has the same meaning as in Title 32, section 4853, subsection 11.'</u>
