1	SUMMARY
2	This amendment, which is the majority report of the committee, modifies the
3	requirements in the bill for age-appropriate traffic safety education in school
4	administrative units. The amendment provides that the traffic safety education must be
5	provided annually to at least 4 different grade levels from kindergarten to grade 8 instead
6	of annually in grades 2 to 12. The amendment also strikes the requirement that the
7	education be at least one hour in length.
8	This amendment also provides funding for 90% of the cost to school administrative
9	units to implement the traffic safety education curriculum. The amendment also specifies
10	that outside funding may be accepted by the Department of Education and expended for
11	the purpose of traffic safety education annually.
