Safety. The committee may submit legislation based on the report to the Second Regular Session of the 132nd Legislature.'

5 SUMMARY

This amendment replaces the bill with a resolve. The amendment directs the County Corrections Professional Standards Council to examine county and regional jail compliance with financial reporting requirements and examine state funding for county and regional jails, including reviewing the status of county and regional jail compliance with financial auditing requirements, reviewing the status of county and regional jail reporting of operating expenses to the Department of Corrections, reviewing any unfunded mandates related to county and regional jails, examining improvements to the operations of the County Corrections Professional Standards Council and examining future needs for state support for county and regional jail operations.

This amendment requires that the County Corrections Professional Standards Council submit a report by January 15, 2026 to the Joint Standing Committee on Criminal Justice and Public Safety, which may submit legislation to the Second Regular Session of the 132nd Legislature.
