COMMITTEE AMENDMENT “ ” to H.P. 460, L.D. 721, “Resolve, to Support the Full Implementation of Certified Community Behavioral Health Clinics in the State”

Amend the resolve in the emergency preamble in the 4th paragraph in the last line (page 1, line 10 in L.D.) by inserting after the following: "State" the following: 'by the implementation deadline'

Amend the resolve by striking out everything after the emergency preamble and before the emergency clause and inserting the following:

'Sec. 1. Appropriations and allocations. Resolved: That the following appropriations and allocations are made.

**HEALTH AND HUMAN SERVICES, DEPARTMENT OF
Medical Care - Payments to Providers 0147**

Initiative: Provides one-time funding to support the full implementation of the 5 certified community behavioral health clinics certified by the State as part of the federal Certified Community Behavioral Health Clinic Medicaid Demonstration Program under the United States Department of Health and Human Services, Centers for Medicare and Medicaid Services, including hiring clinical and administrative staff critical to the success of the program. The funding must support enhancement of the department's certified community behavioral health clinics in a manner that enables the department to access the designated enhanced federal match for the program. The department must continue to engage with certified community behavioral health clinic providers regarding how available funding is best leveraged for the program to achieve full implementation.

14 Health and Human Services to use the funding provided by the resolve to support certified
15 community behavioral health centers by increasing wages with language requiring the
16 department to use the funding provided by the resolve to support certified community
17 behavioral health centers by enhancement of the department's special certified community
18 behavioral health clinic funding in a manner that enables the department to access the
19 designated enhanced federal match for the program.
