The amendment directs the 3 Department of Inland Fisheries and Wildlife to study lengthening the 6-day muzzle-loading season on deer in wildlife management districts in additional wildlife management districts 4 in the State where winter conditions are less severe. The amendment directs the department 5 6 to report back to the Joint Standing Committee on Inland Fisheries and Wildlife by January 7 1, 2026 with findings and recommendations and gives the joint standing committee the 8 authority to report out a bill based on the report to the Second Regular Session of the 132nd 9 Legislature.
