32 33	This amendment revises definitions to accommodate practices in Maine with regard to certain guardians and with regard to small estates.
34 35 36 37	The definition of "conservator" is amended to include a guardian when the guardian is exercising the powers of a conservator because no conservator has been appointed. To be consistent, the definition of "protected person" is amended to include a person for whom a guardian has been appointed when no conservator has been appointed.

- 1 The definition of "personal representative" is amended to cover a person claiming to 2 be a successor of the decedent user who presents an affidavit governing access to assets 3 in a small estate.
- 4 This amendment amends the definition of "property" that applies to the entire Probate 5 Code to include a digital asset as defined in the bill.
- 6 This amendment adds an emergency preamble and emergency clause and changes the 7 effective date to July 1, 2018.
