The public access officer is responsible for ensuring that each public record request is acknowledged 2 3 within a reasonable period of time 5 working days of the receipt of the request by the office responsible for maintaining the public record requested and that a good faith 4 estimate of when the response to the request will be complete is provided according to 5 6 section 408-A. The public access officer shall serve as a resource within the agency, county, municipality, school administrative unit and regional or other political 7 subdivision concerning freedom of access questions and compliance.' 8

SUMMARY

10 This amendment requires the agency or official that forwards a public record request 11 to the office that has custody of the records that are the subject of the request to notify the 12 requester that the request has been forwarded to the appropriate office and that the 5-day 13 period within which the receipt of the request must be acknowledged begins to run when 14 that receiving office receives the request.

15 This amendment also amends the laws governing public access officers by 16 specifically requiring that a request for public records be acknowledged within 5 working 17 days of the receipt of the request by the office responsible for maintaining the public 18 record requested. This is consistent with the acknowledgment deadline.

This amendment clarifies that the responsibility to forward a request for public records to the office that maintains the records is limited to circumstances in which the request is made to an agency that consists of more than one office in different locations, and the request is made to an office that does not maintain the records. The bill requires that the request be forwarded to the office that does maintain the records. It does not require a municipality to forward the request to another municipality.
