1 State in the same manner as votes for members of the Legislature. The Governor shall 2 review the returns. If a majority of the legal votes are cast in favor of this Act, the 3 Governor shall proclaim the result without delay and this Act becomes effective 30 days 4 after the date of the proclamation.

5 The Secretary of State shall prepare and furnish to each city, town and plantation all 6 ballots, returns and copies of this Act necessary to carry out the purposes of this 7 referendum.'

## SUMMARY

9 This amendment is the minority report of the committee. This amendment strikes the bill and replaces it with a requirement, contingent upon approval of the voters at 10 11 referendum, that the Department of Administrative and Financial Services, Bureau of Alcoholic Beverages and Lottery Operations develop a plan that includes proposed rules 12 and any legislation needed to implement the use and taxation of marijuana. The bureau is 13 14 required to report its plan to the Joint Standing Committee on Criminal Justice and Public Safety by January 31, 2014. The Joint Standing Committee on Criminal Justice and 15 Public Safety may report out legislation to the Second Regular Session of the 126th 16 17 Legislature related to that report.
