6 SUMMARY

This amendment increases the membership of the Department of Professional and Financial Regulation, Board of Real Estate Appraisers from 7 to 9 members and amends the qualifications for certain members of the board. It also amends the scope of license provisions for residential real property appraisers by providing that a license holder may appraise certain residential property as specified in criteria adopted by the appraiser qualifications board.
